1. Wood fence, built on easement. (City Code 7106)
2. Trash, debris and dry vegetation adjacent to the structure. (City Code 8-3A-5)

Please cause the property to be cleaned and the dry vegetation removed. If a front yard fence is to be maintained, City Codes require that it be located within your property lines. The re-located fence allowed may be no higher than 4 feet above grade with the top 2 feet at least 50% open.

Your cooperation in correcting the above conditions within 21 days of your receipt of this letter will be greatly appreciated and will preclude further action by this Department.
