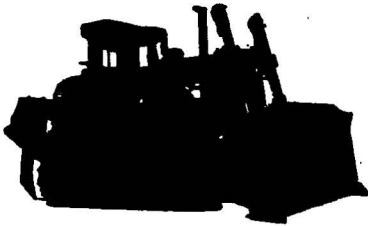
1. Section 41 - FUGITIVE DUST - of the APCD Regulations.

Unit price shall prevail.

Additional work that may be required by soils engineer - overexcavate of existing fill,
loose or unsuitable material.

NOTE: Quantities are based on the following paving depths:

Onsite - 2" AC/4" Type II/6" Type I

Offsite - 3" AC/4" Type II/6" Type I

Payments shall be made as the work progresses in an amount equal to the value of the work done, less the sum of any previous payments. The entire amount of the contract to be paid within 30 days after completion.

Any alteration or deviation from the above specifications, pursuant to the oral or written request of the buyer, involving additional labor or materials, will become an extra charge over the aforementioned sum and payable as said work progresses.

It is understood and agreed that in the event the buyer defaults in payments, as aforesaid, that buyer will be obligated to pay interest at the rate of 18% per annum on the unpaid balance, and all costs incurred in collecting said amount due, including, without limitation, Court costs and attorney fees.
