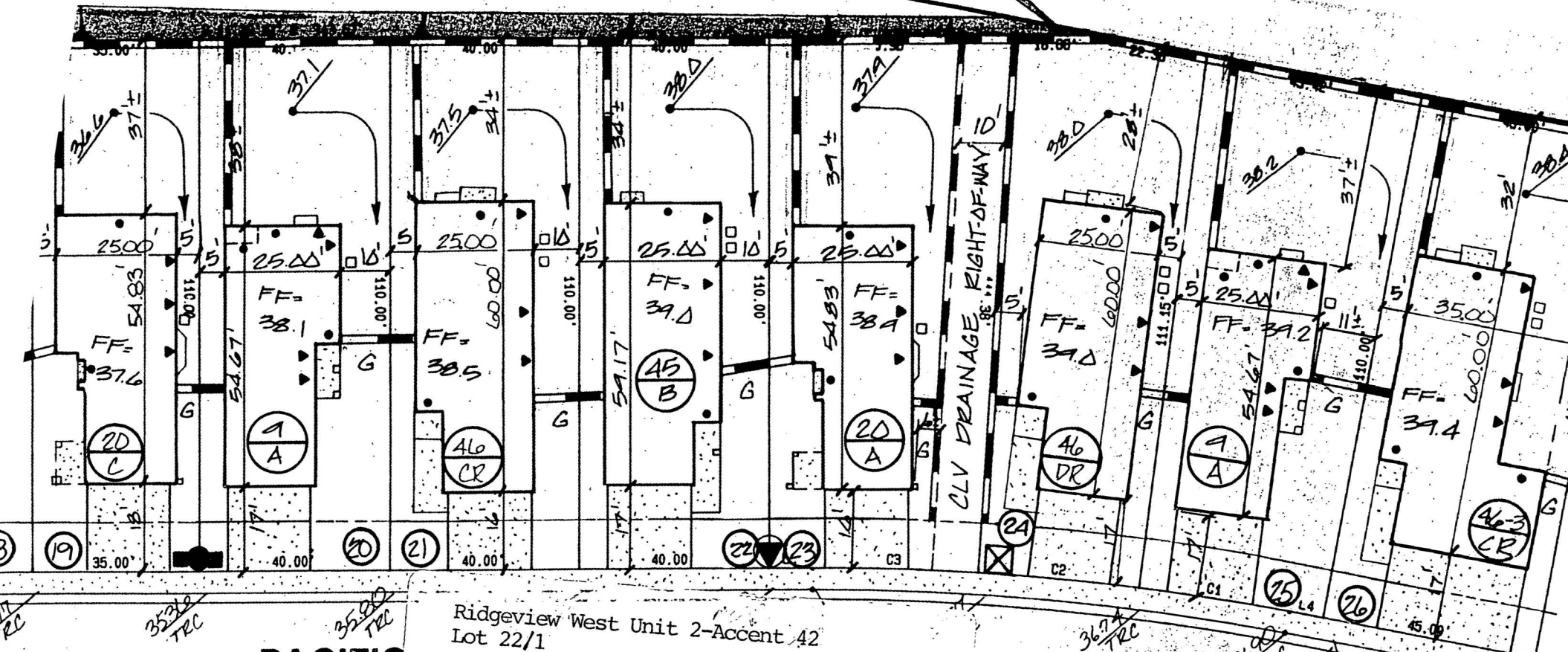

TEMPORARY DRAINAGE CHANNEL

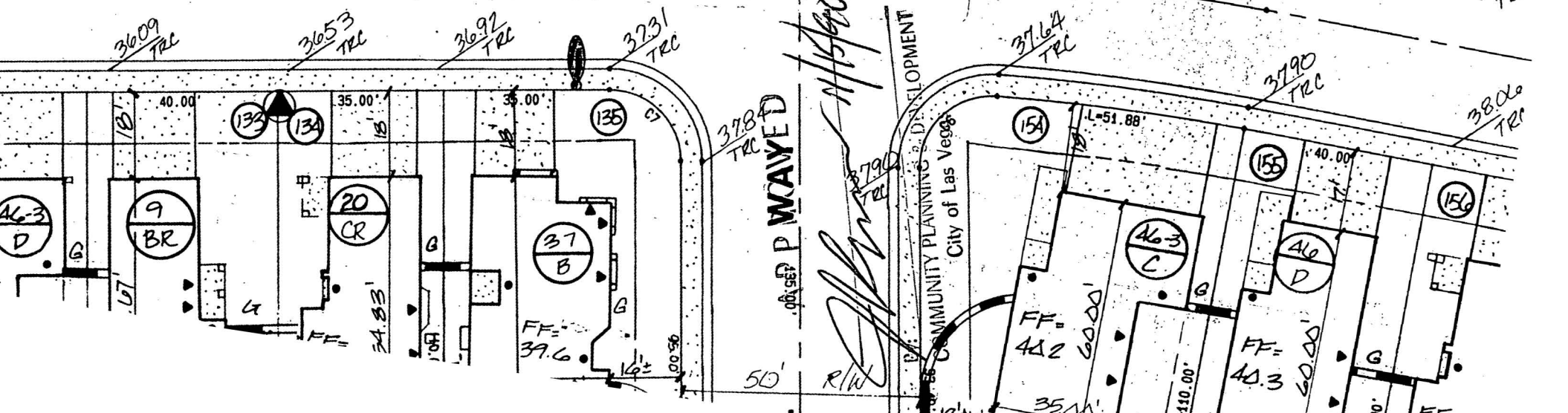

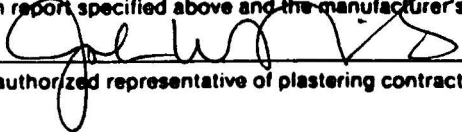
