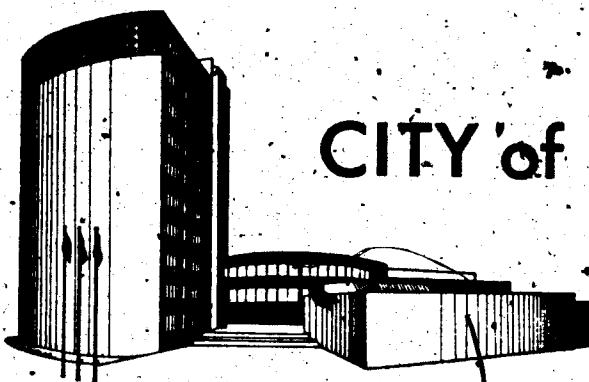

Please accept this letter as thirty (30) day written notice, from date of receipt, to comply.

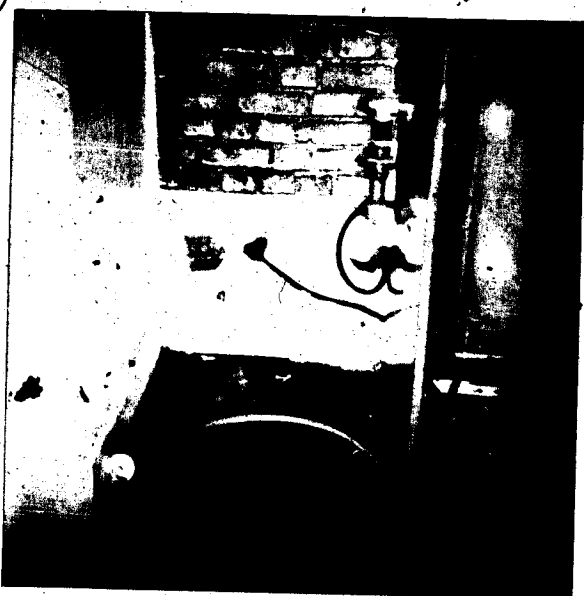
