Mr. A. W. Ham, Jr., owner of the two buildings above as well as the old telephone building on second street, has requested his time of requirement to meet the "dangerous building" ordinance be extended to 1 November 1964 at which time he contemplates full demolition.

It would be my suggestion, if the attorney agrees we may extend the time, we require all windows, doors and other accesses to be completely blocked allowing only locked, solid doors for entry as may be required as well as a notarized statement from the owner stating they will demolish 1 November 1964.
