LEGAL DESCRIPTION

The West Half (W1/2) of the Northwest Quarter (NW1/4) of the Southeast Quarter (SE1/4) of the Southeast Quarter (SE1/4) of Section 2, Township 21 South, Range 60 East, M. D. M., in the County of Clark, State of Nevada, being more particularly described as follows:

COMMENCING at the Northeast corner of the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of said Section 2; thence South 88° 53' 16" West along the North line of the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of said Section 2, a distance of 959.99 feet to the Northeast corner of the West Half (W1/2) of the Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of said Section 2, THE TRUE POINT OF BEGINNING; thence continuing South 88° 53' 16" West along said North line a distance of 320.00 feet to the West line of the Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of said Section 2; thence South 2° 24' 24" East along said West line a distance of 693.62 feet to the South line of the Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of said Section 2; thence North 88° 40' 34" East along said South line a distance of 318.52 feet to the East line of the West Half (W1/2) of the Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of said Section 2; thence North 2° 17' 13" West along said East line a distance of 692.41 feet to the TRUE POINT OF BEGINNING.
