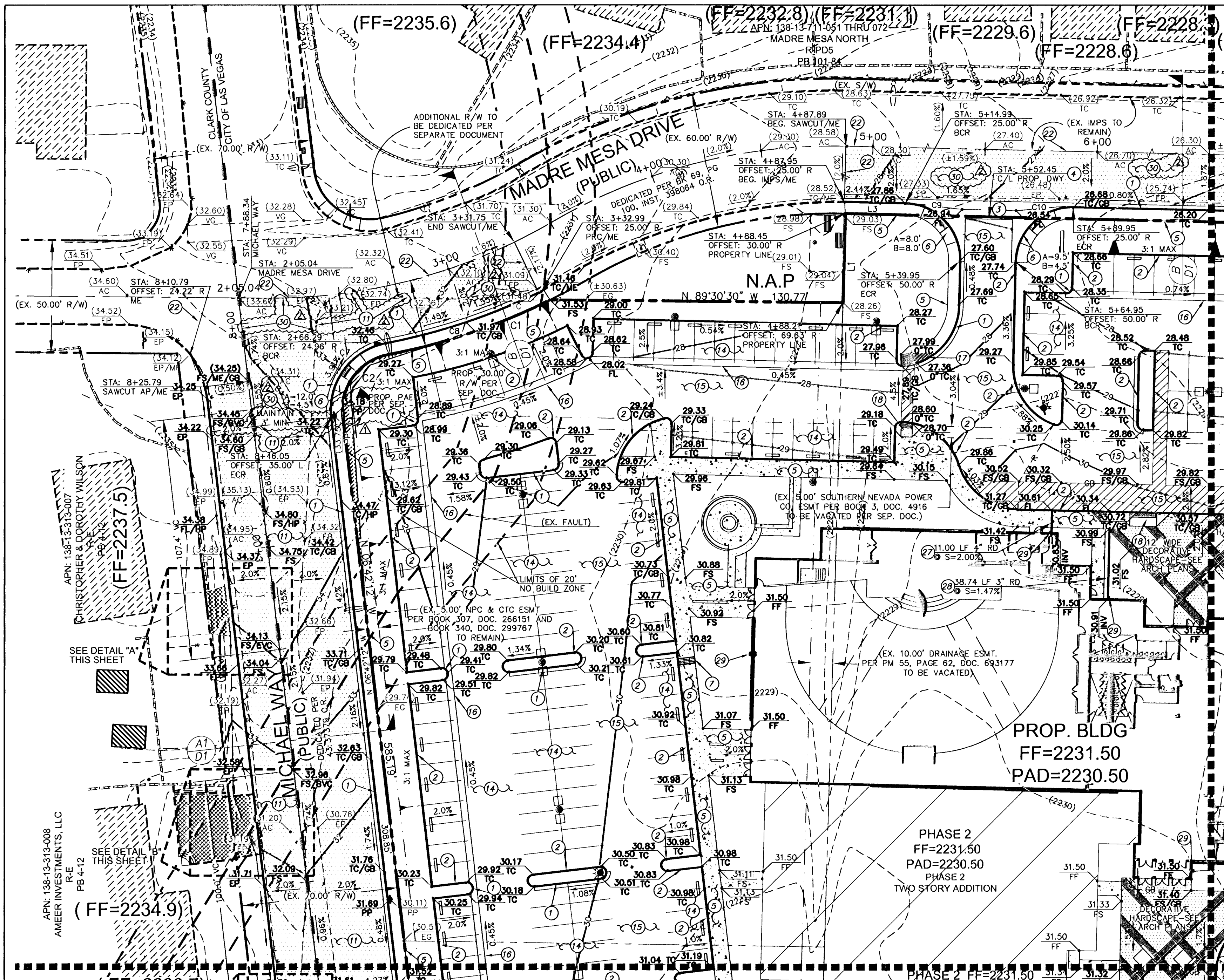

### SIGHT VISIBILITY ZONES NOTE

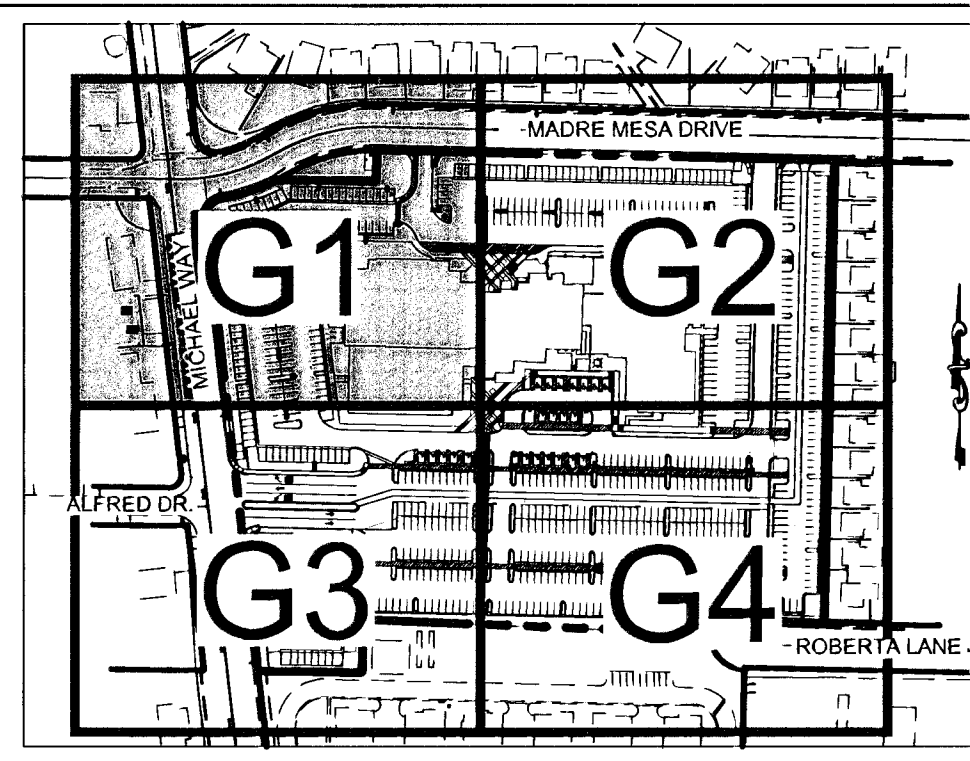

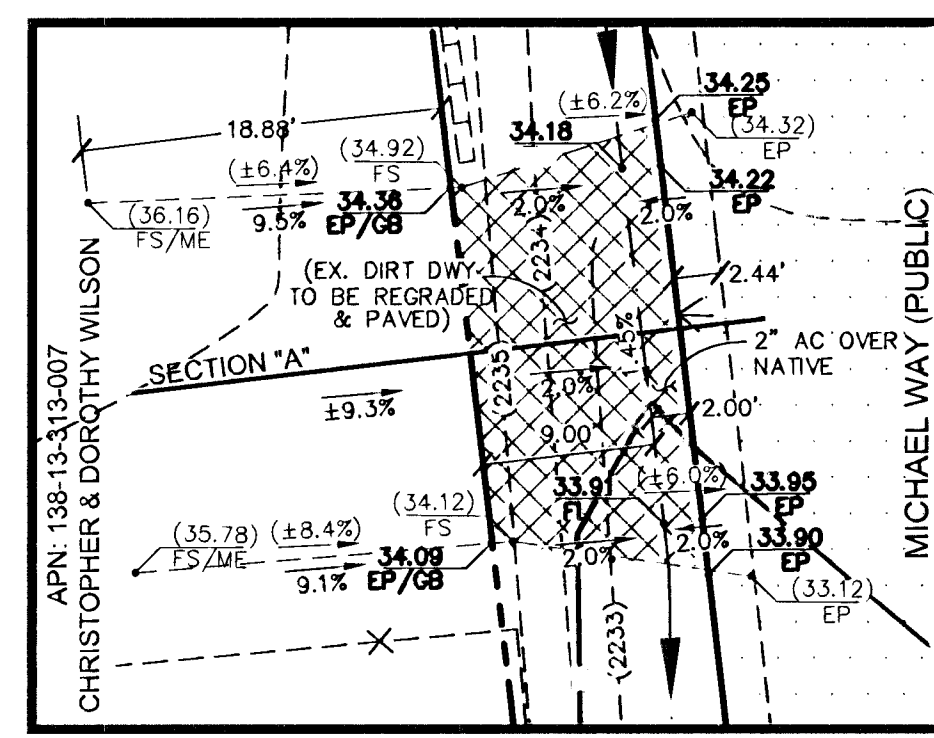

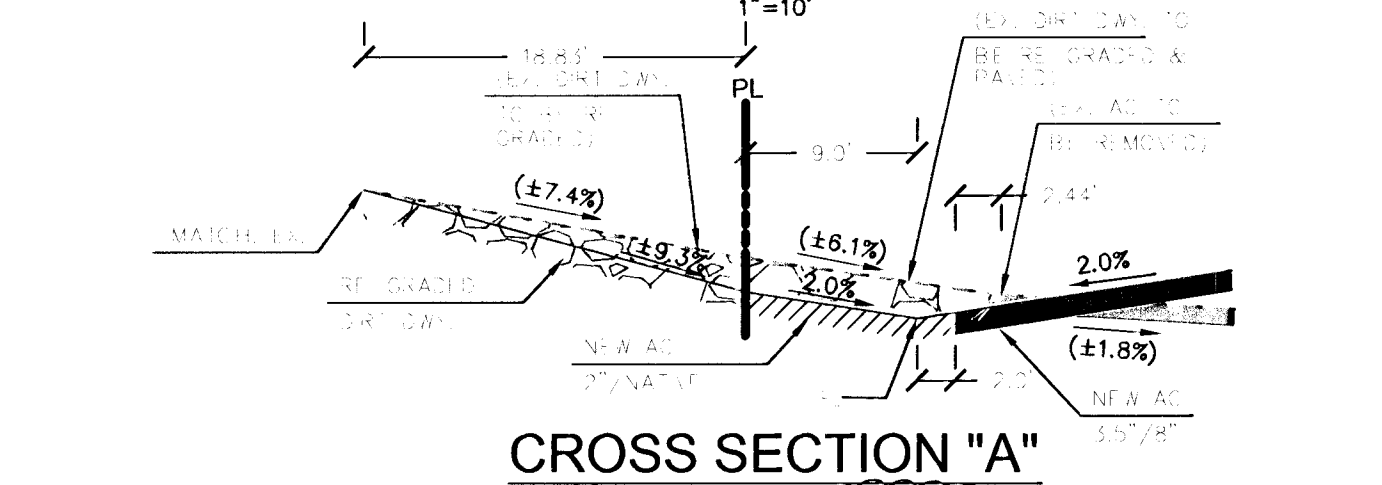
KEY MAP  
N.T.S.



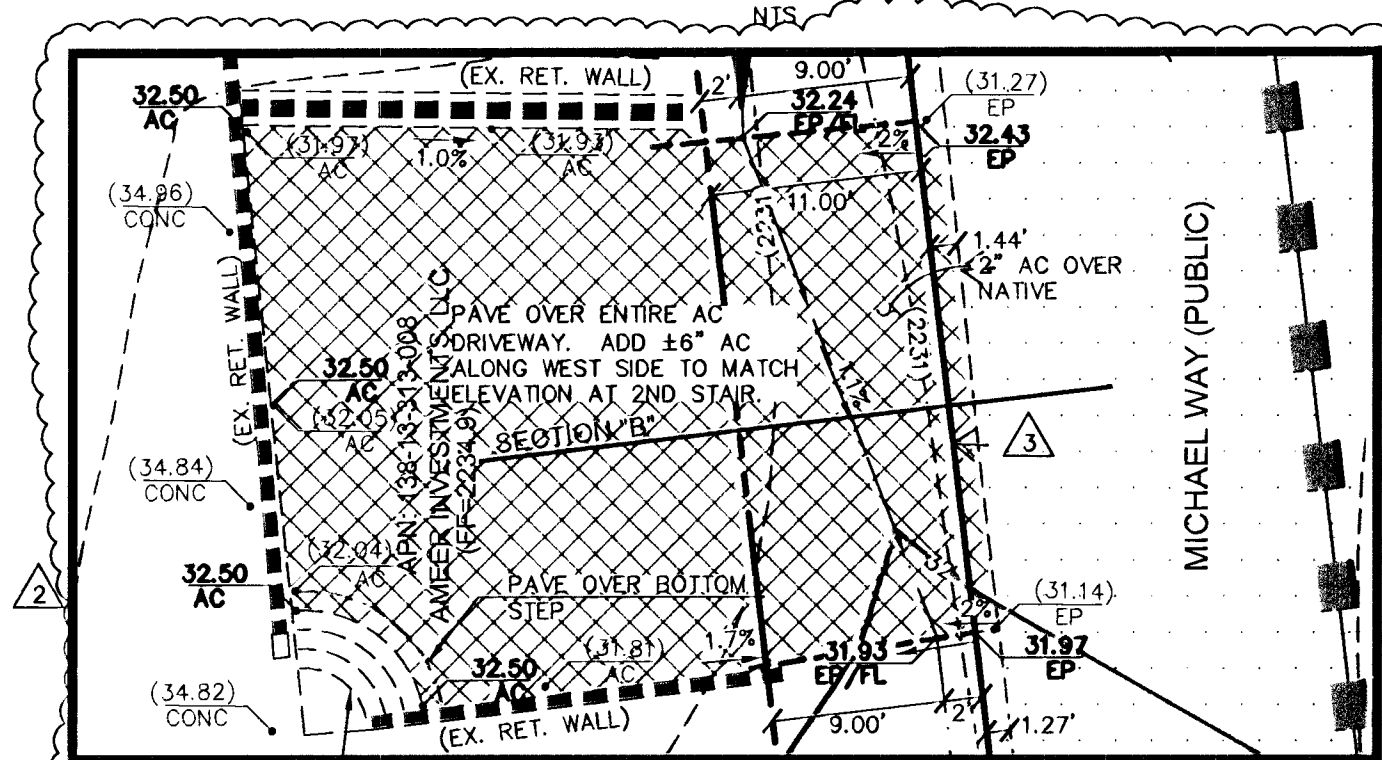
VICINITY MAP  
N.T.S.



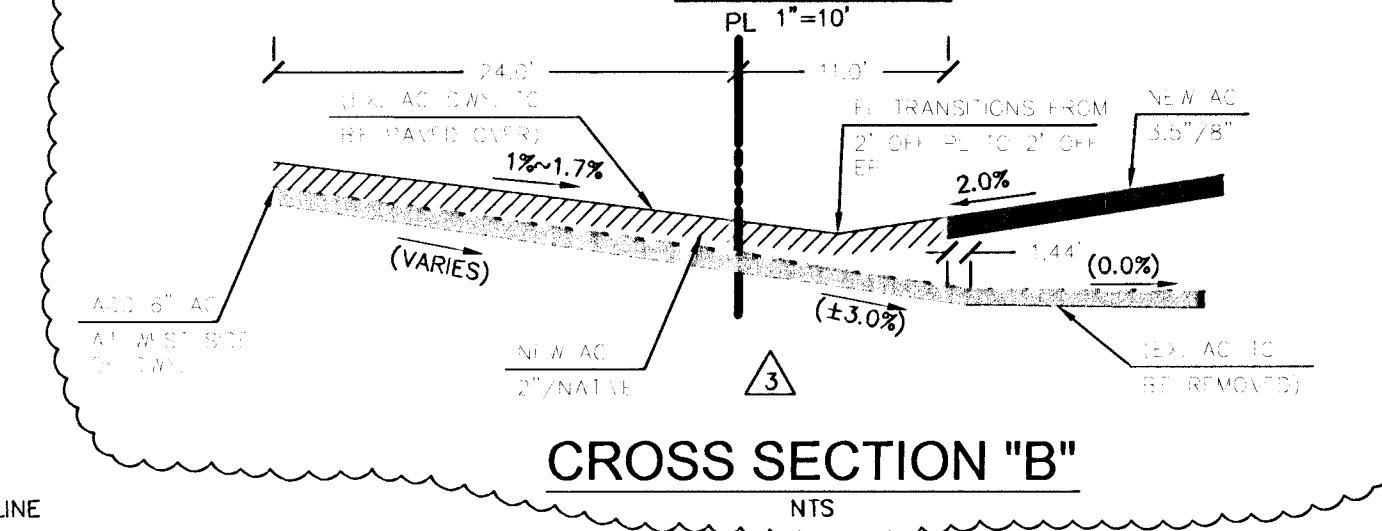
DETAIL "A"

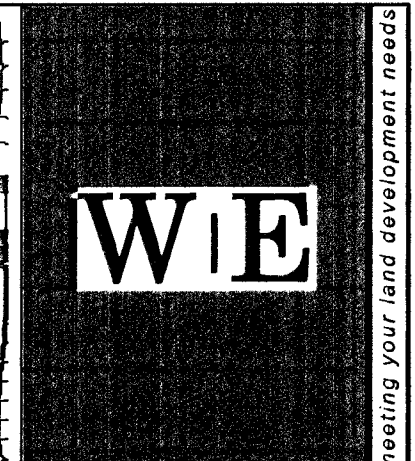

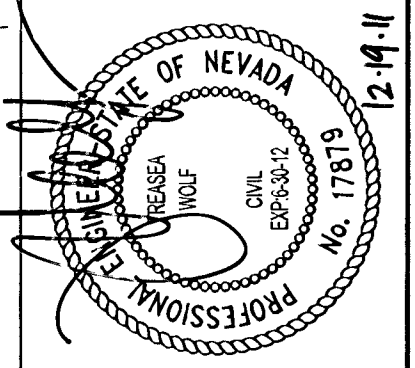
