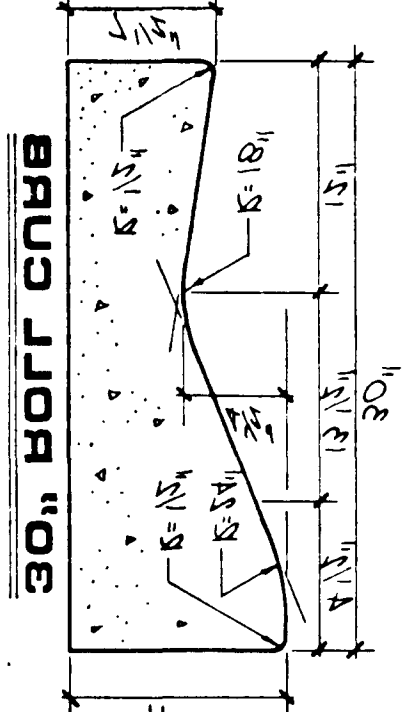
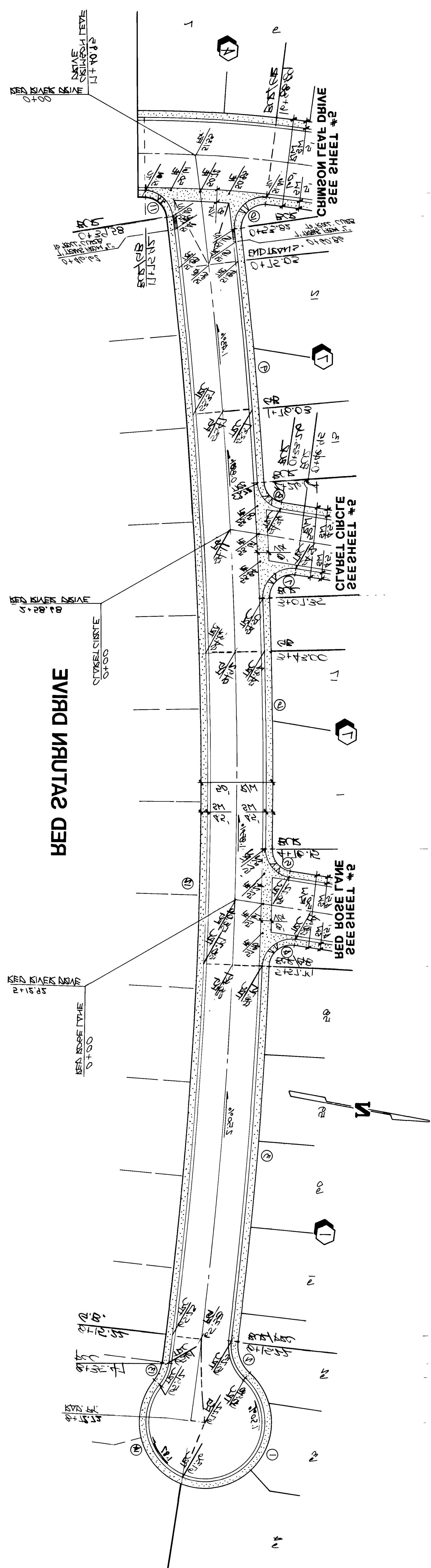

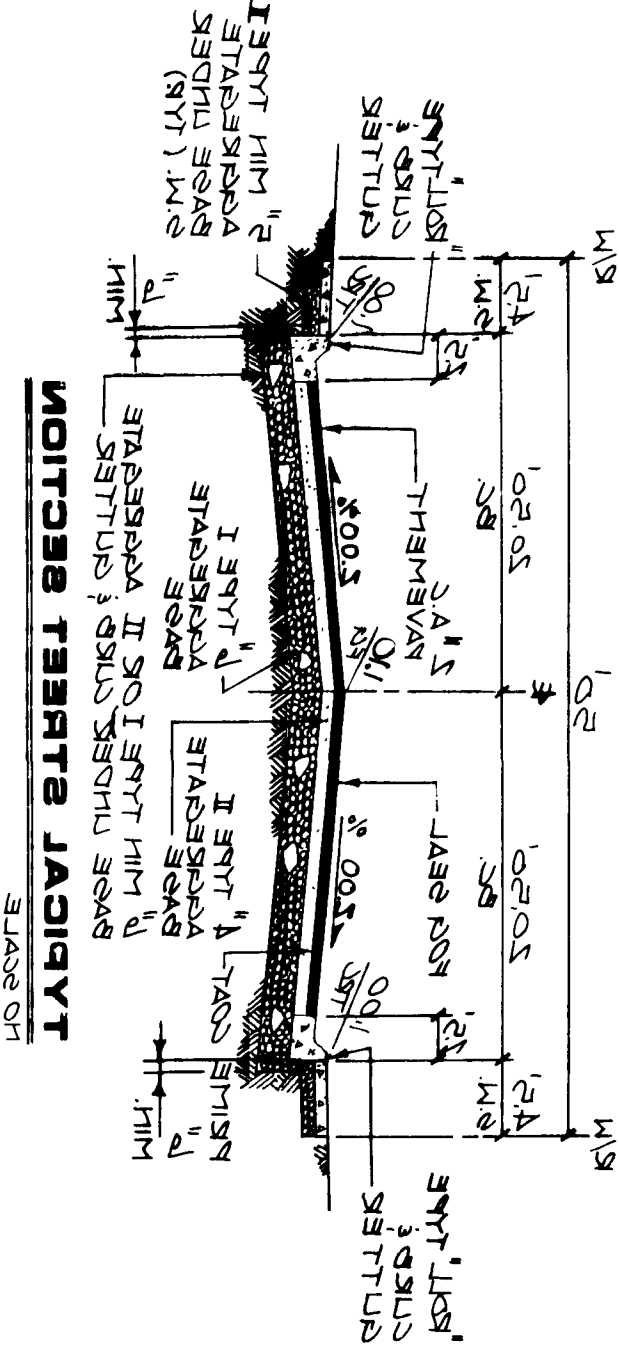

STREET PLAN & PROFILE

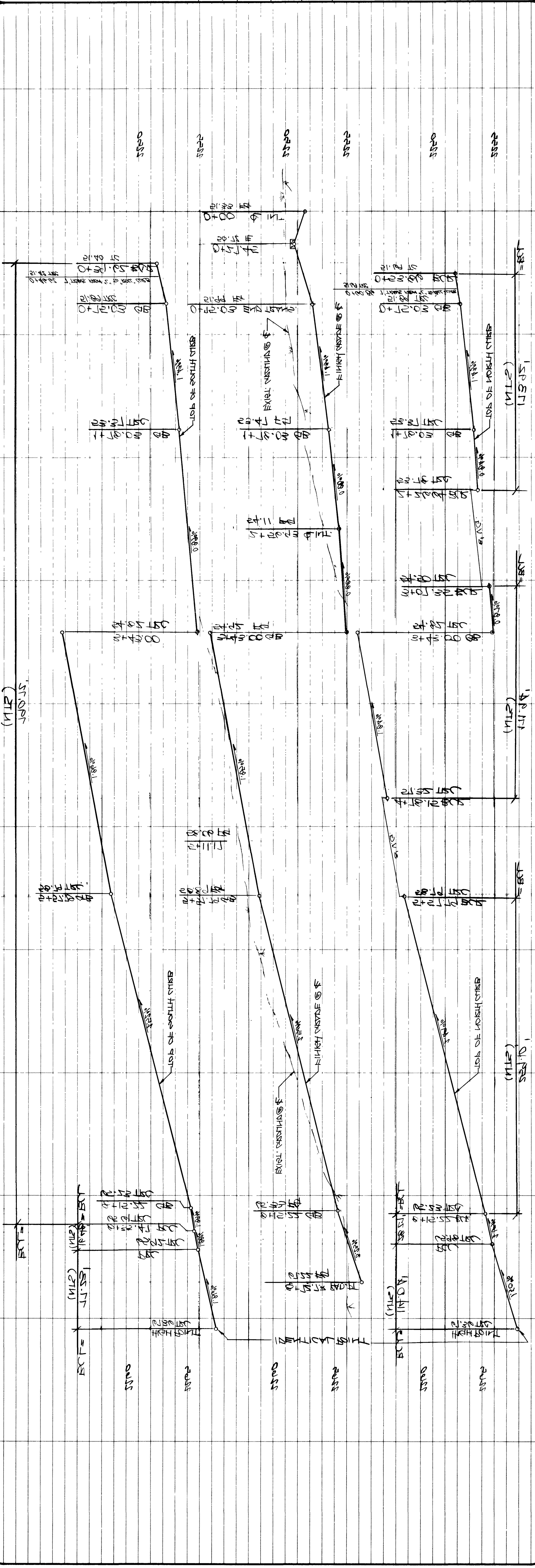

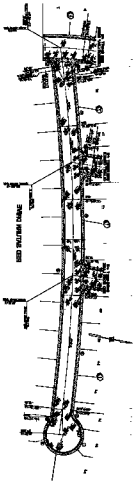
