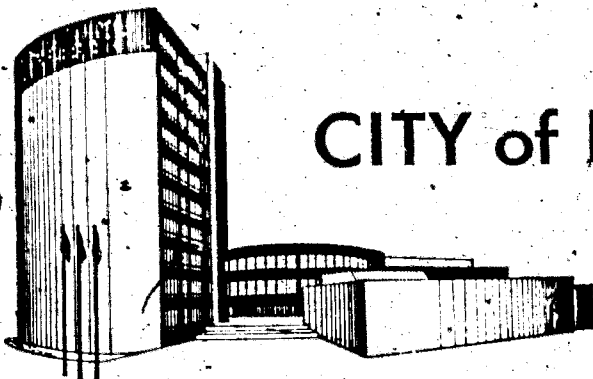

Dear Craig:

This letter will confirm what was discussed in my office October 12, 1982 concerning the City's acceptance of Omega Products, and the deviations from I.C.B.O. Research Report No. 4004. The telephone conversation we had with Vernon Malley of the International Conference of Building Officials at the meeting shed new light on this type of stucco systems. Mr. Malley indicated that I.C.B.O. was in the process of re-evaluating this type of stucco system and writing a new research report which would give broad coverage to all similar products using Chapter 47 and 47-4 of the U.B.C. Standards as the governing factor. In our dry climatic zone we do not see the need of covering the joints of the foam board with weather resistant building paper as long as all joints are made over the stud and all other openings around pipes, electrical panels, etc., are sealed with caulk to prevent moisture penetration. We agree to the elimination of metal trim on all corners since this is a maintenance problem rather than structural. Since mixing of sand at the job site is approved for other similar products, as well as regular stucco, then we must assume the applicator is one of integrity and conscience enough to use only the prescribed required mix not exceeding 160 lbs. of clean approved sand for each 80 lbs. bag of stucco mix,

Mr. Malley also indicated that to apply your system over regular polystyrene foam on dimple board polystyrene would not cause a problem. Therefore, we will accept the Omega stucco system, minus metal corner trim, minus weather resistant paper on joints with sand mixed at the job site and applied over regular or dimple polystyrene sheathing. Expansion joints and bracing of the walls will be reviewed by this Department on each structure submitted through plans check.
