We are in receipt of your letter dated September 9, 1983 and would like to inform you of the following condition.

Section 303 of the Uniform Building Code requires that all permits expire automatically after 180 days of construction inactivity at the jobsite. Since the code allows us to extend the expiration date for good cause, we will accept your letter as a petition for a permit extension. The expiration date for your building permit is now March 9, 1983. The new expiration date is conditional upon the provision that there is no construction activity during that period of time.
