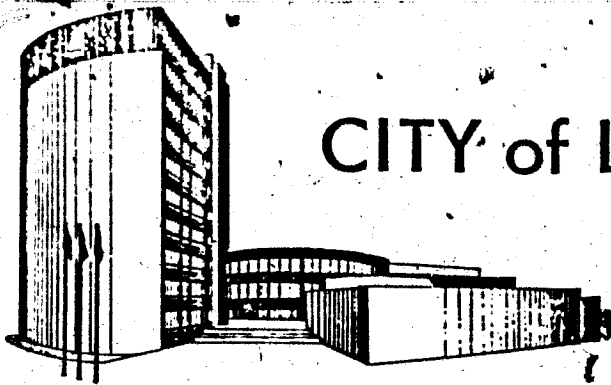

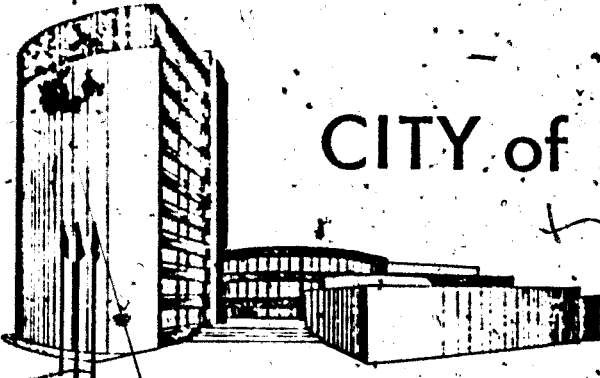

DEAR MR. HYMER:

C & E CONSTRUCTION CO. HEREBY REQUESTS THE CITY OF LAS VEGAS TO EMPLOY A SPECIAL INSPECTOR DURING THE CONSTRUCTION OF THE ABOVE PROJECT PURSUANT TO THE PROVISIONS OF SECTION 306 OF THE UNIFORM BUILDING CODE, 1979 EDITION, TO BE REIMBURSED MONTHLY.

WHEN THE CITY APPOINTS SUCH SPECIAL INSPECTOR OF THE CITY'S CHOICE, C & E CONSTRUCTION CO. WILL REIMBURSE THE CITY AT A RATE OF \$ 2,921.08 MONTHLY FOR REGULAR FORTY (40) HOUR WEEKS. ALL NECESSARY OVERTIME WILL BE REIMBURSED AT THE RATE OF \$ 23.28 PER HOUR. CITY RECOGNIZED HOLIDAY WORK WILL BE REIMBURSED AT THE RATE OF \$ 38.93 PER HOUR. ANY PERCENTAGE ANNUAL SALARY INCREASES ALLOWED FOR REGULAR CITY EMPLOYEES IN SIMILAR CLASSIFICATION WILL ALSO BE APPLIED TO SUCH SPECIAL INSPECTOR.

IN ADDITION TO THE ABOVE, C & E CONSTRUCTION CO. AGREES TO THE FOLLOWING:

1. TO PROVIDE SEPARATE OFFICE, MINIMUM 8' X 8' IN SIZE, FOR SPECIAL INSPECTOR, HAVING A TEMPORARY 6' X 3' DRAFTING TABLE WITH CHAIR AND SEPARATE TELEPHONE, AND SHALL BE EQUIPPED WITH HEATING & COOLING SYSTEM AND DOOR WITH LOCKING DEVICE.
2. PROVIDE TWO PARKING SPACES, ONE FOR SPECIAL INSPECTOR AND ONE FOR REGULAR INSPECTORS.
