

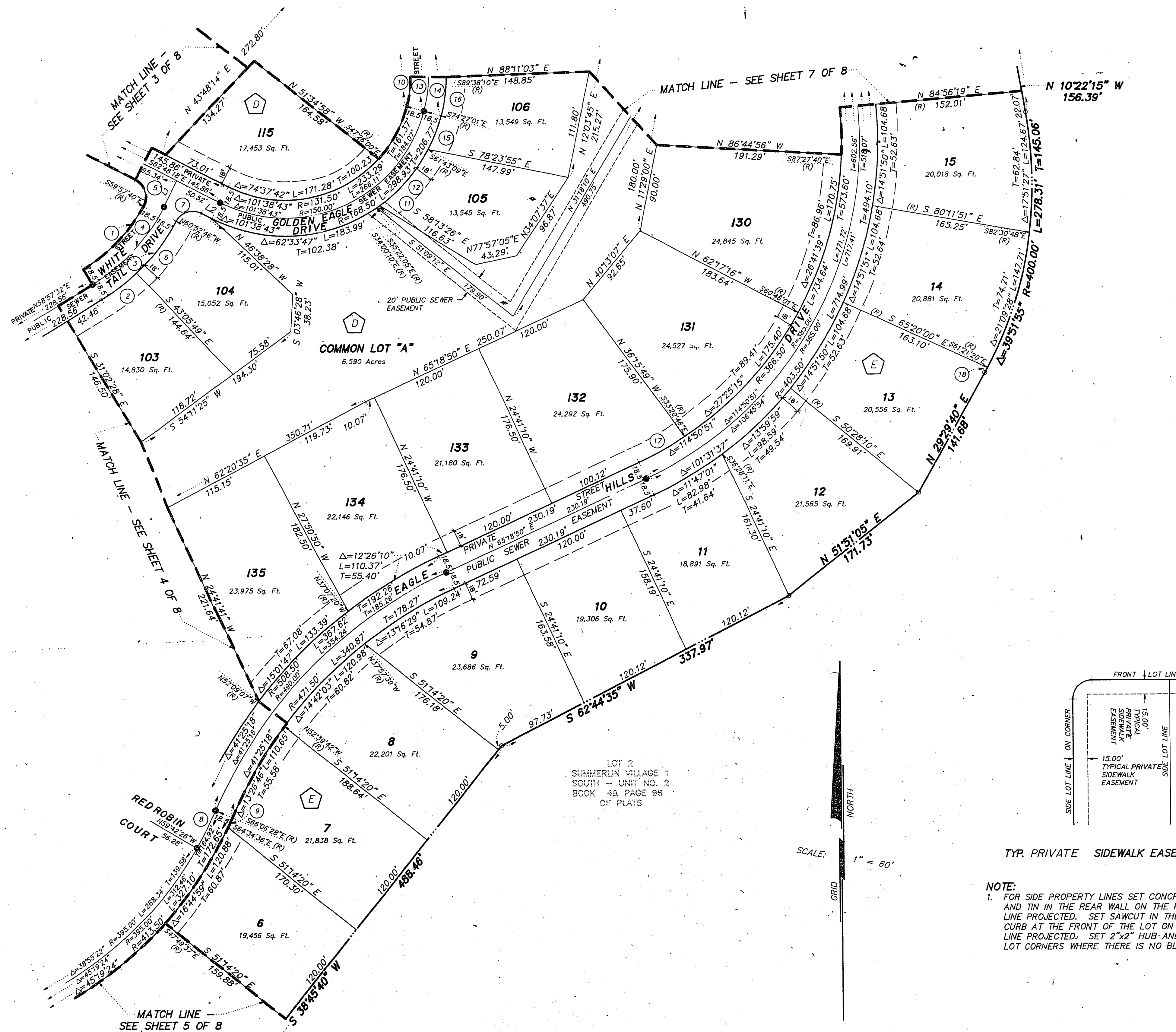

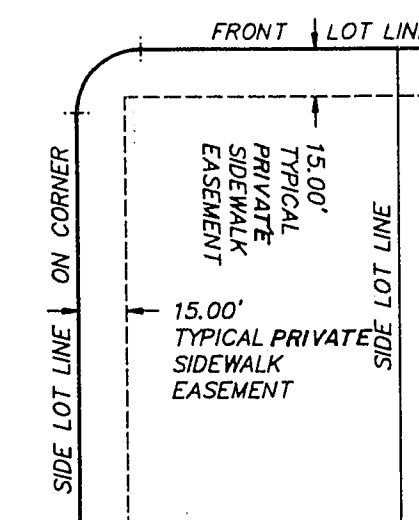

THE MINIMUM FRONT AND CORNER (CORNER LOTS) BUILDING SETBACKS PER THE CITY OF LAS VEGAS REQUIREMENTS ARE AS FOLLOWS: FRONT - 18', CORNER - 15'. THE MINIMUM FRONT AND CORNER (CORNER LOTS) BUILDING SETBACKS PER THE EAGLE HILLS DESIGN CRITERIA VARY IN SOME INSTANCES FROM THE CITY'S REQUIREMENTS. THE EAGLE HILLS DESIGN CRITERIA SHALL TAKE PRECEDENCE OVER THE CITY OF LAS VEGAS REQUIREMENTS.

NOTE:

- FOR SIDE PROPERTY LINES SET CONCRETE NAIL AND TIN IN THE REAR WALL ON THE PROPERTY LINE PROJECTED. SET SAWCUT IN THE BACK OF CURB AT THE FRONT OF THE LOT ON THE PROPERTY LINE PROJECTED. SET 2"x2" HUB AND TACK AT LOT CORNERS WHERE THERE IS NO BLOCK WALL.
