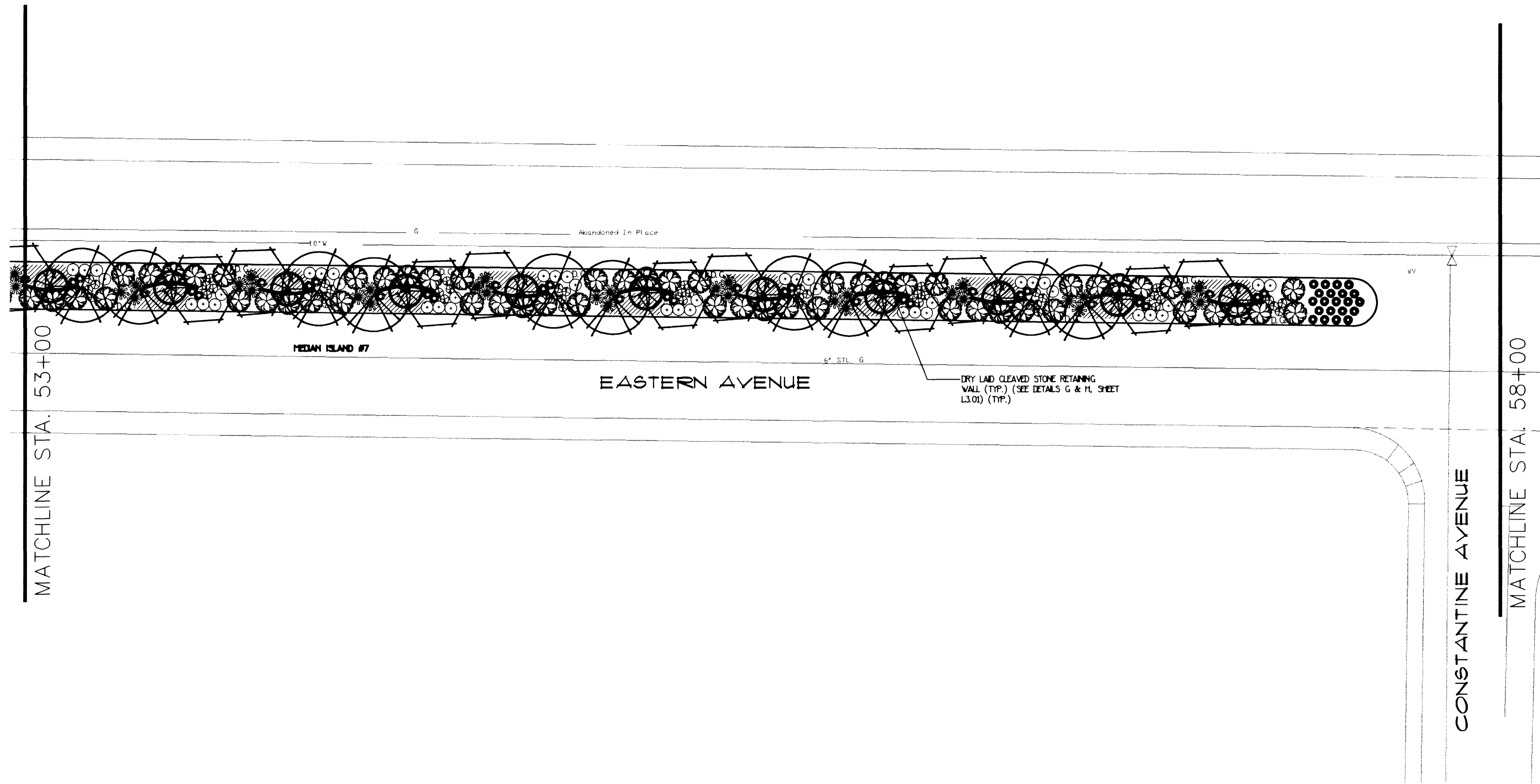

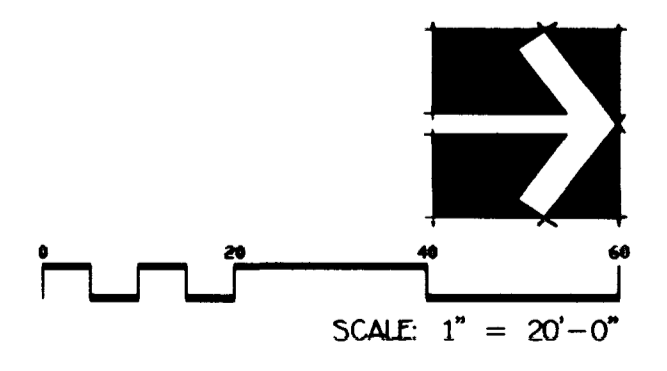

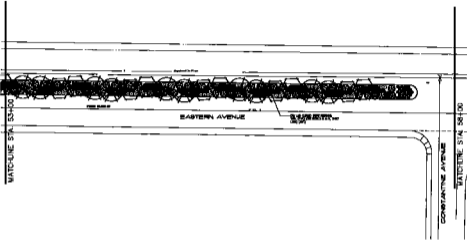
- 1) INSTALL A 2" LAYER OF 1/2" MINUS 'REBEL RED' DECOMPOSED GRANITE CONTINUOUS IN ALL PLANTERS UNDER ALL TREES AND SHRUBS. SUBMIT SAMPLE FOR APPROVAL PRIOR TO INSTALLATION. BEFORE PLACING GRANITE, COMPACT SUB-GRADE TO 85% AND APPLY A PRE-EMERGENT HERBICIDE TO SOIL. AFTER PLACING GRANITE, RAKE SMOOTH, WET TO ENTIRE DEPTH, ALLOW TO DRY, THEN LIGHTLY SCARIFY SURFACE WITH A LEAF RAKE. APPLY A SECONDARY APPLICATION OF PRE-EMERGENT HERBICIDE TO TOP OF GRANITE. KEEP TOP OF GRANITE 2" BELOW ADJACENT WALKS AND CURBS. DO NOT ALLOW GRANITE TO TOUCH THE TRUNK OF ANY PLANT. INSTALL AFTER INSTALLATION OF PLANT MATERIAL. (SEE DETAIL F, SHEET L3.01)
- 2) ALL UTILITY INFORMATION HAS BEEN OBTAINED FROM NDOT CONSTRUCTION PLANS - CONTRACT #2834.
- 3) FOR REMOVAL OF ASPHALT AND SUB-BASE TO A DEPTH OF 2'-0" IN EACH MEDIAN, SEE DETAIL I, SHEET L3.01.

EXISTING CONCRETE TO BE STAINED, BOMIANTE COLOR TOPFEE, AVAILABLE THROUGH ARCON CONSULTING (702) 368-4776. (PRIOR TO COMMENCEMENT, PROVIDE AN ON SITE TEST AREA 4' X 4' IN THE MIDDLE AREA OF MEDIAN ISLAND #10 WHERE CONCRETE IS TO BE REMOVED, FOR APPROVAL.)
