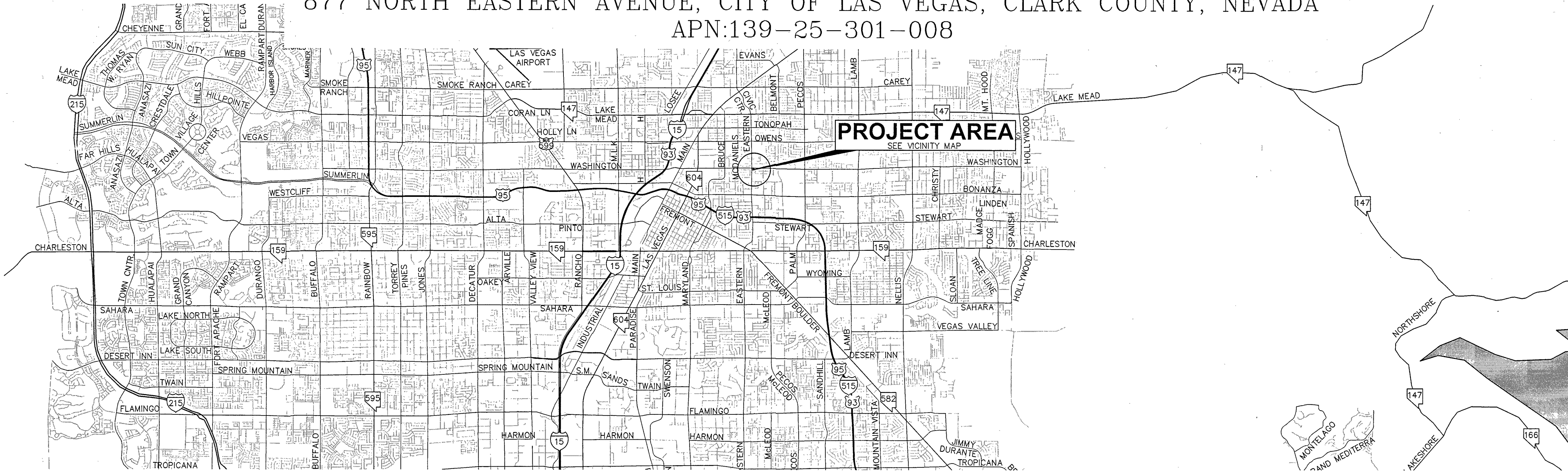
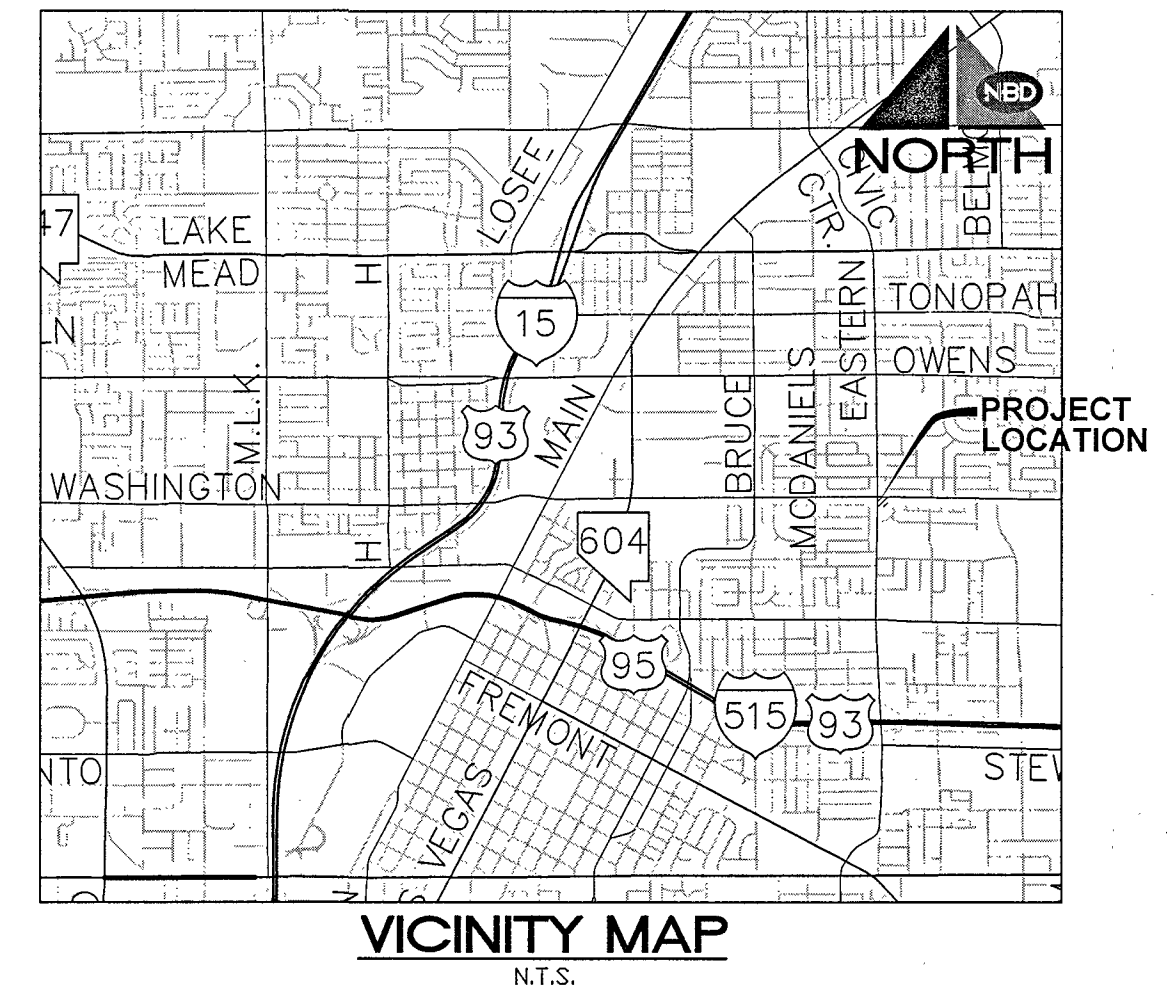

3. ALL EXISTING STREET LIGHTING SHALL REMAIN OPERATIONAL DURING CONSTRUCTION.
4. ALL STREET LIGHTING CONDUITS STUB SHALL HAVE AT LEAST ONE GROUND #9 THW WIRE INSTALLED, AS TRACER WIRE, WHEN "EMPTY" CONDUIT IS COMPLETELY INSTALLED FROM PB TO PB. IT SHALL HAVE MINIMUM OF 2 #4 AND 1 #9 THW WIRE WITH THE ENDS TAPED OR "SAFE-OFF" PRIOR TO FINAL INSPECTION.
5. ANY STRUCTURE SUCH AS BLOCK WALLS, CHAIN LINK FENCES, RETAINING WALLS, ETC., SHALL LEAVE A MINIMUM CLEARANCE IN ACCORDANCE WITH THE USD NO. 320A.
6. AS-BUILT DRAWINGS SHALL BE SUPPLIED TO THE TEFO PRIOR TO ANY PRE-FINAL INSPECTION. THE AS-BUILT DRAWINGS NEEDS TO BE STAMPED AS-BUILT AND SIGNED BY THE PREPARER.
