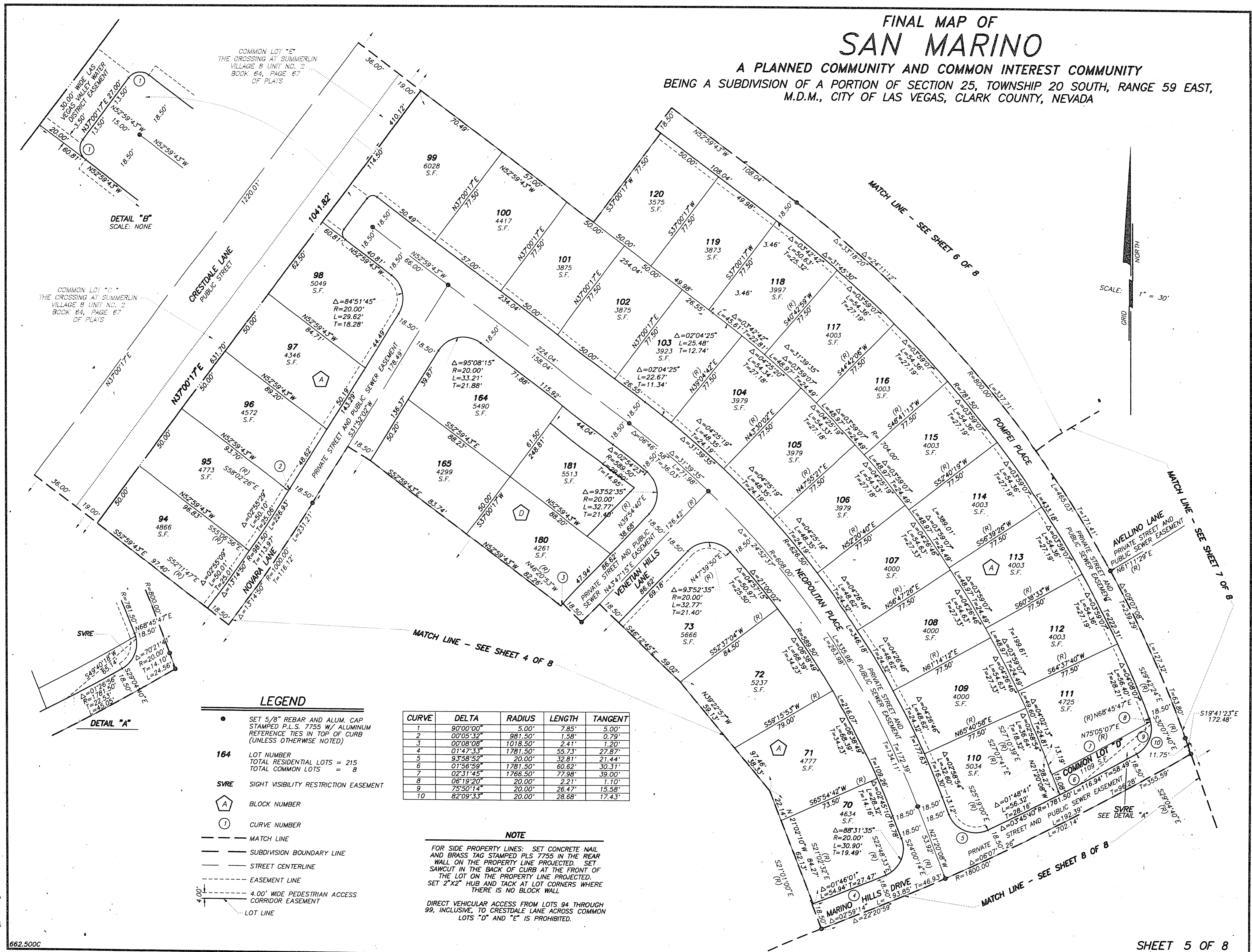

NOTE

FOR SIDE PROPERTY LINES: SET CONCRETE NAIL AND BRASS TAG STAMPED PLS 7755 IN THE REAR WALL ON THE PROPERTY LINE PROJECTED. SET SAWCUT IN THE BACK OF CURB AT THE FRONT OF THE LOT ON THE PROPERTY LINE PROJECTED. SET 2"x2" HUB AND TACK AT LOT CORNERS WHERE THERE IS NO BLOCK WALL.

DIRECT VEHICULAR ACCESS FROM LOTS 94 THROUGH 99, INCLUSIVE, TO CRESTDALE LANE ACROSS COMMON LOTS "D" AND "E" IS PROHIBITED.
