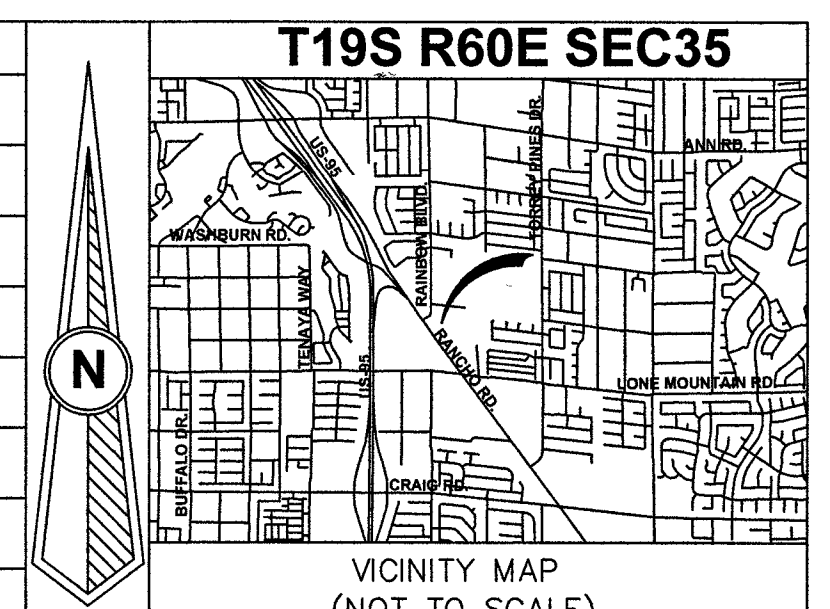

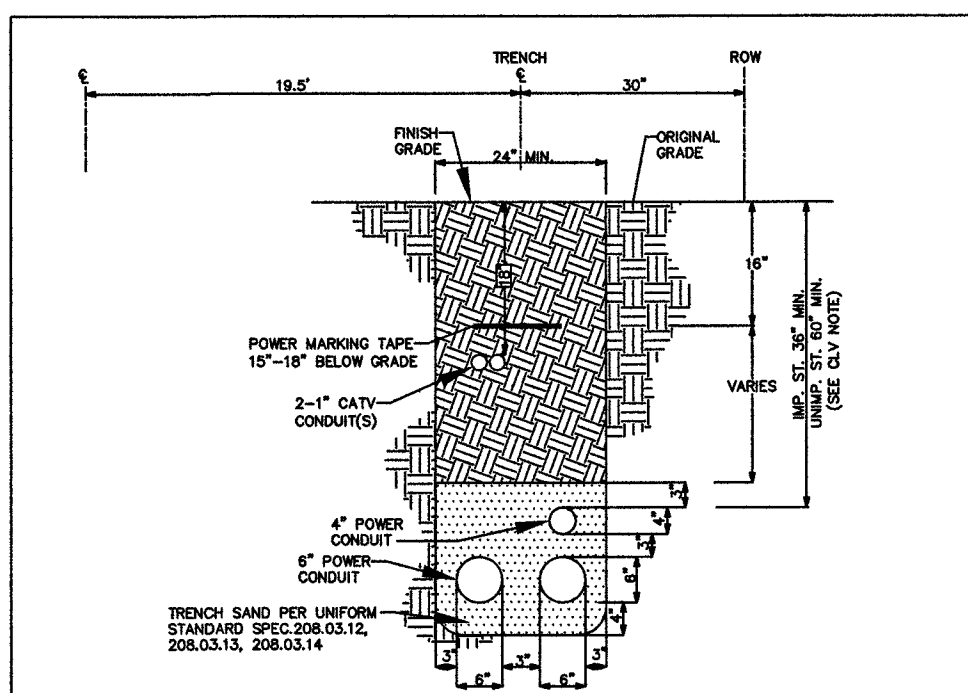

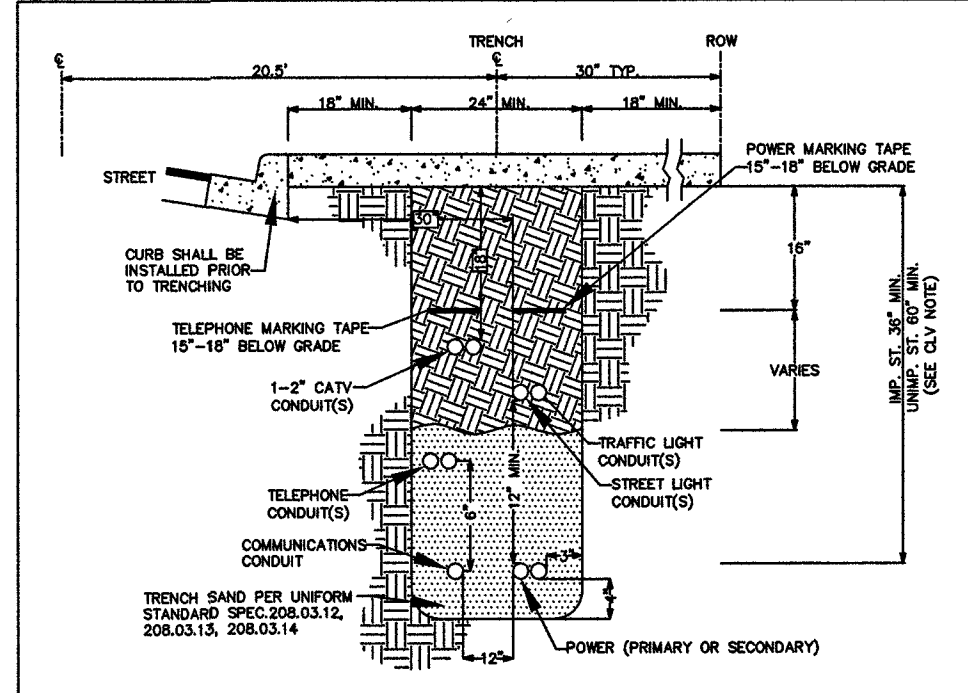

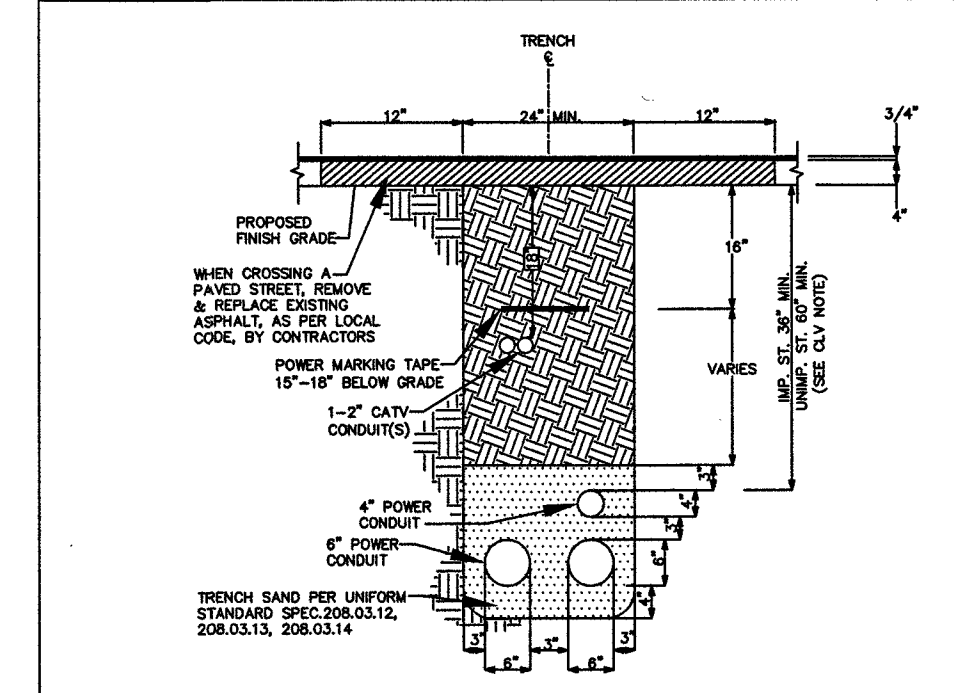
A DIRT TRENCH DETAIL

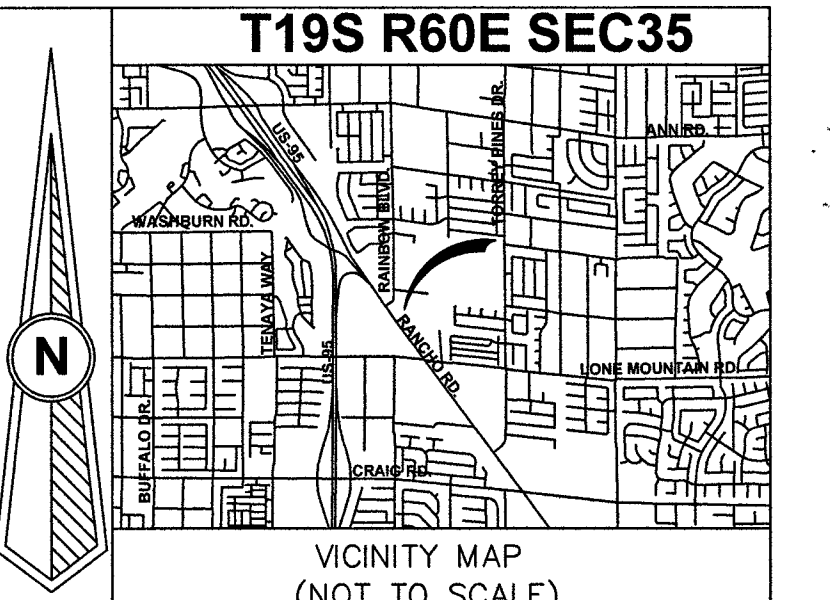


C TRENCH DETAIL
