ENLARGED SITE PLAN

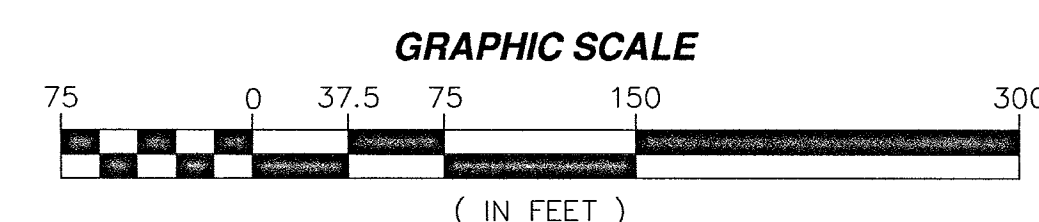

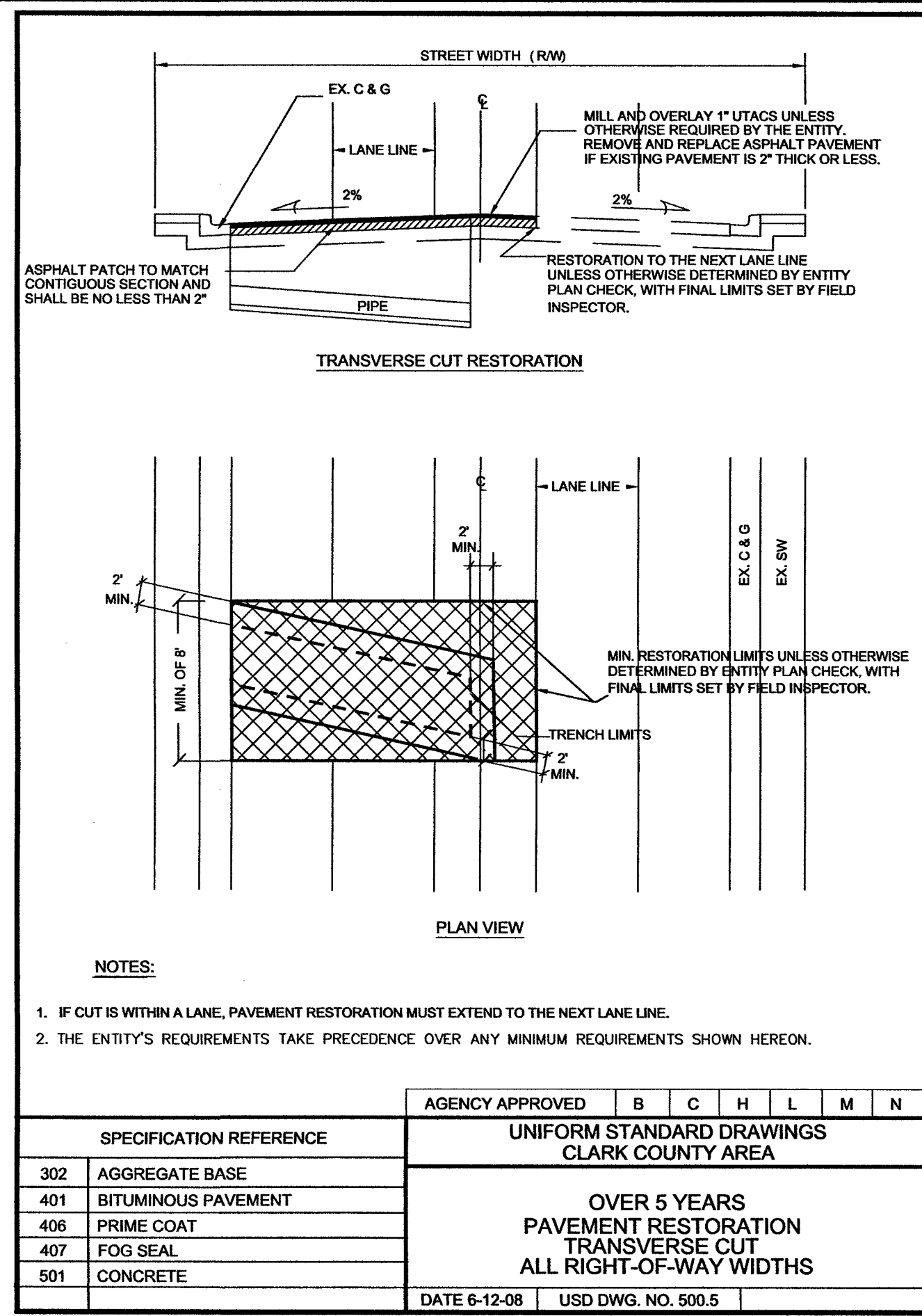
