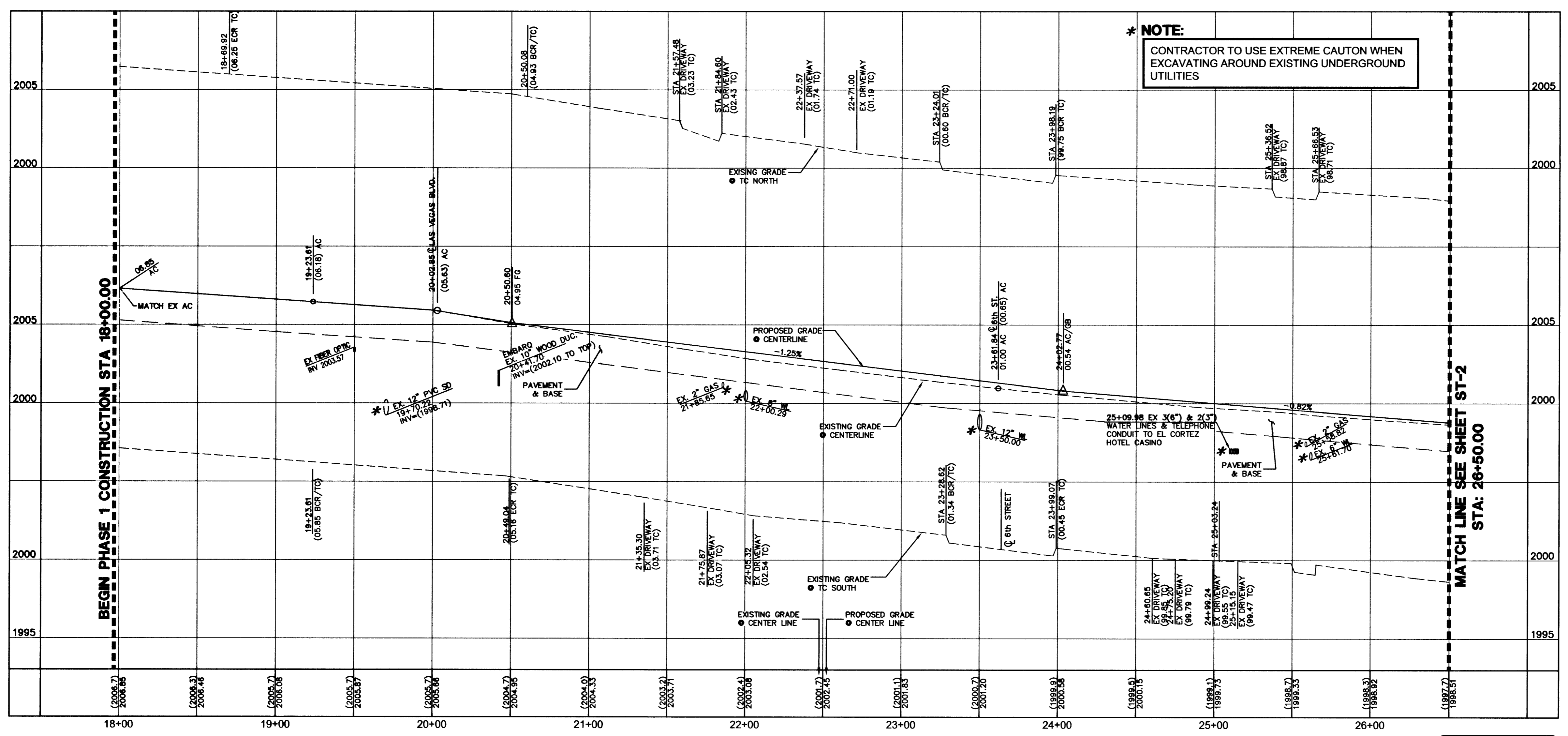

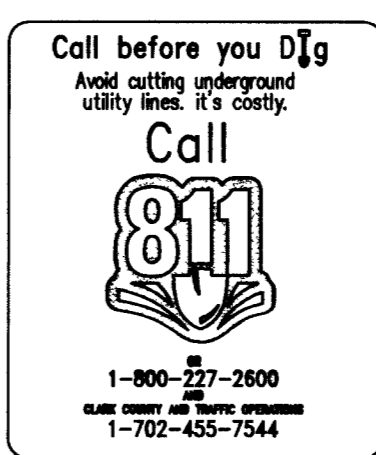
- 1 CONSTRUCT AC PAVEMENT PER TYPICAL STREET SECTION ON SHEET DT-1
- 2 REMOVE EXISTING PAVEMENT AND REPLACE PER CONSTRUCTION NOTE NO. 1
- 3 SAWCUT AND MATCH EXISTING AC
- 4 INSTALL TYPE III MONUMENT PER USDOCA DWG. NO. 241
- 5 (NOT USED)
- 6 ADJUST WATER VALVE BOX TO FINISHED GRADE PER LUDAS PLATE NO. & VALVE SHALL BE ACCESSIBLE AT ALL TIMES.
- 7 ADJUST STORM DRAIN MANHOLE TO FINISHED GRADE
- 8 CONTRACTOR TO PROTECT IN PLACE AND MATCH NEW PAVEMENT TO TOP OF ELECTRIC BOX.
- 9 PROTECT EXISTING DROP INLET IN PLACE
