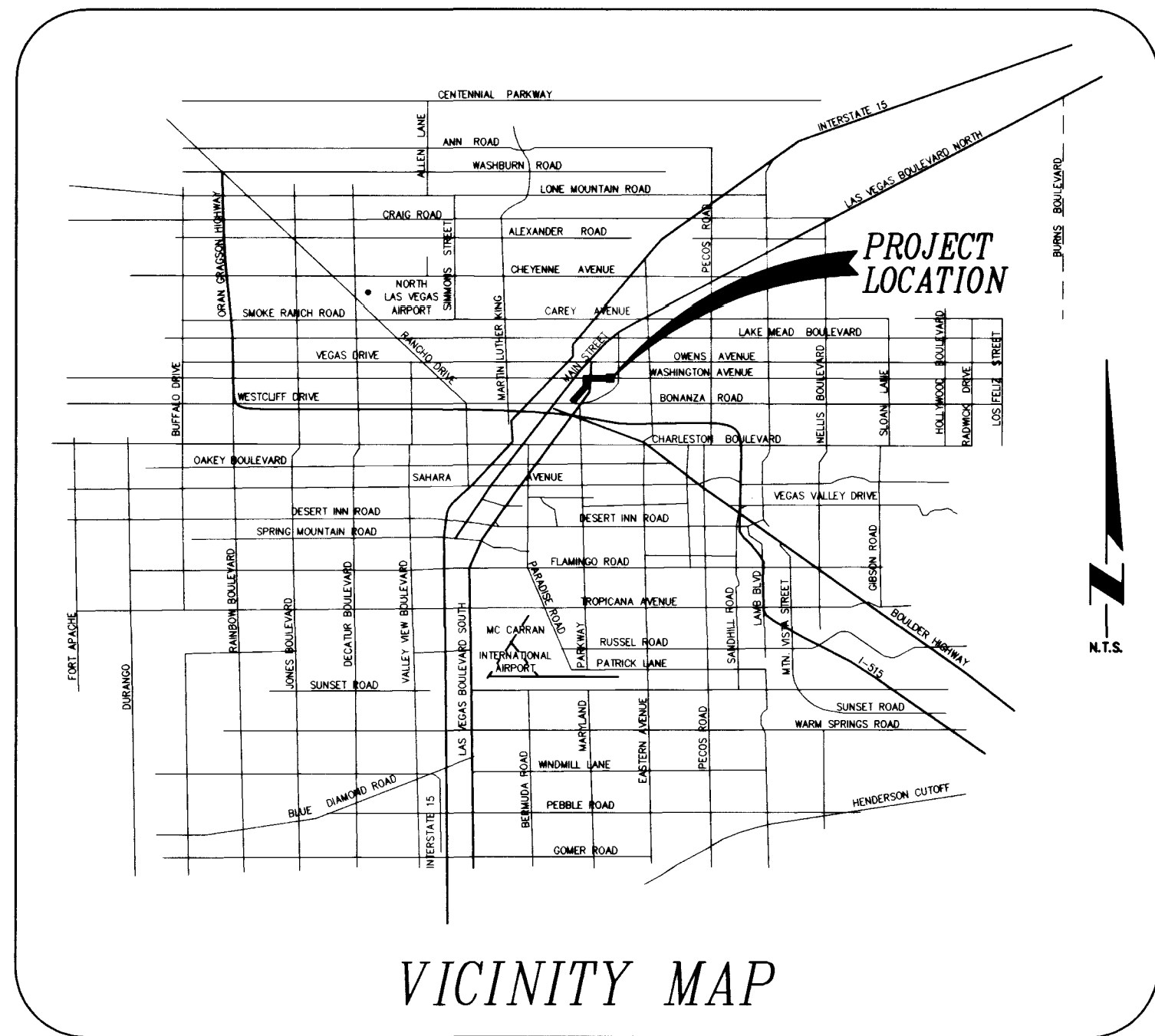

VICINITY MAP

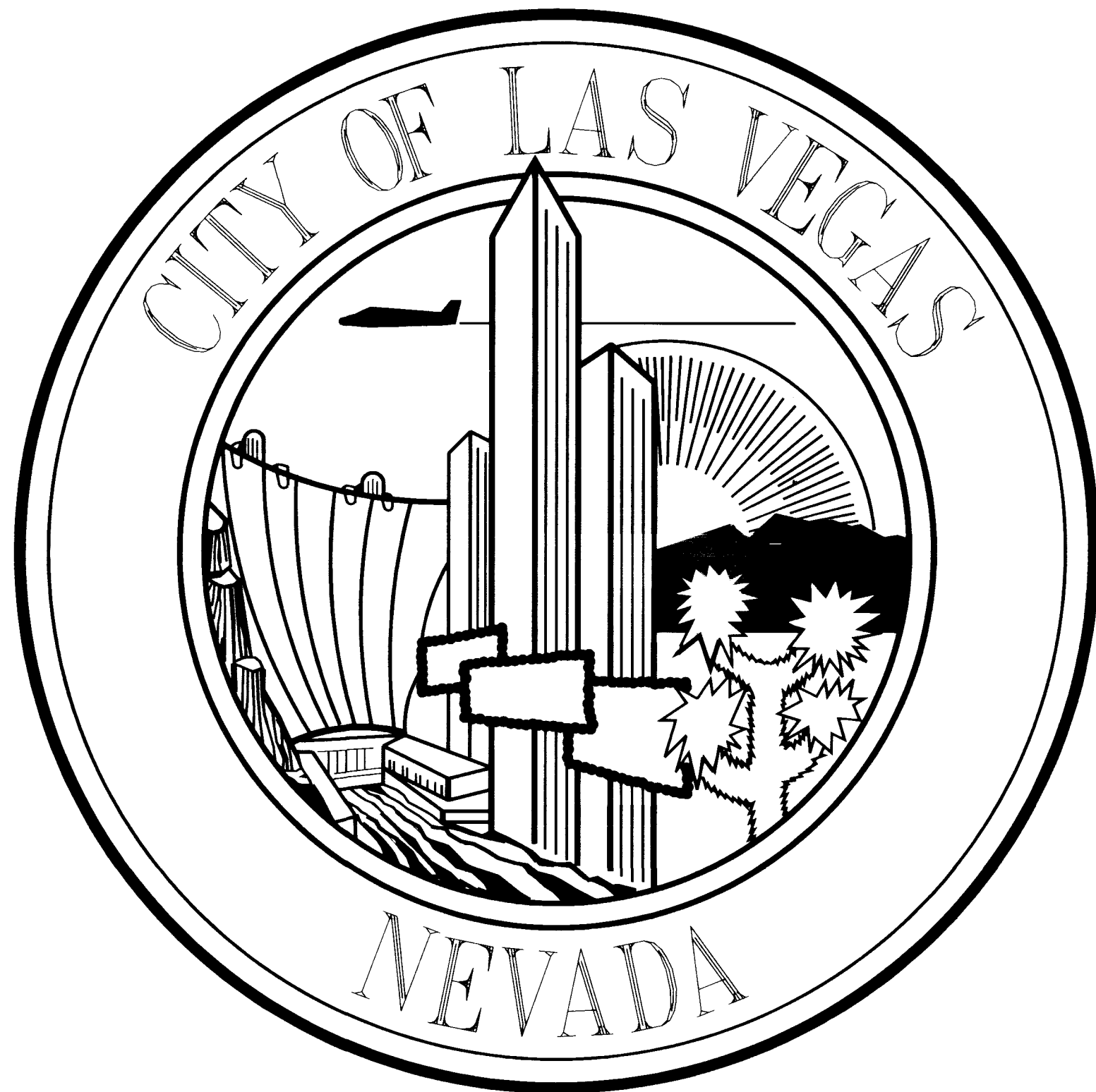

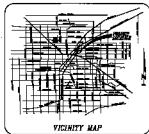
