PUBLIC STREET WITH CLV SEWER EASEMENTS

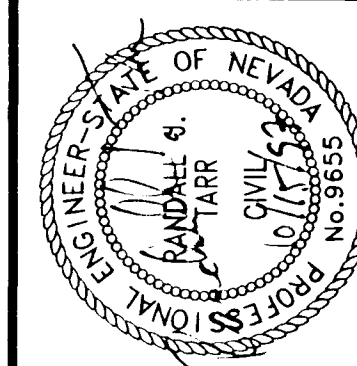

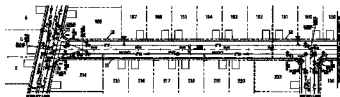

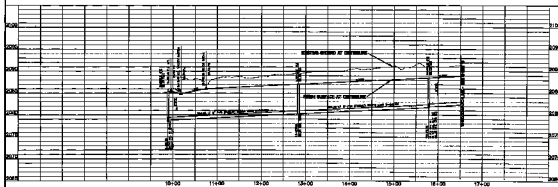
