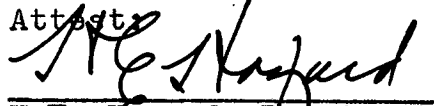
We desire to improve this parcel just as soon as sewer facilities are available. It is on the Eastland Heights water system.

For this reason we pray that you will give full consideration to annexing this property to the City of Las Vegas.

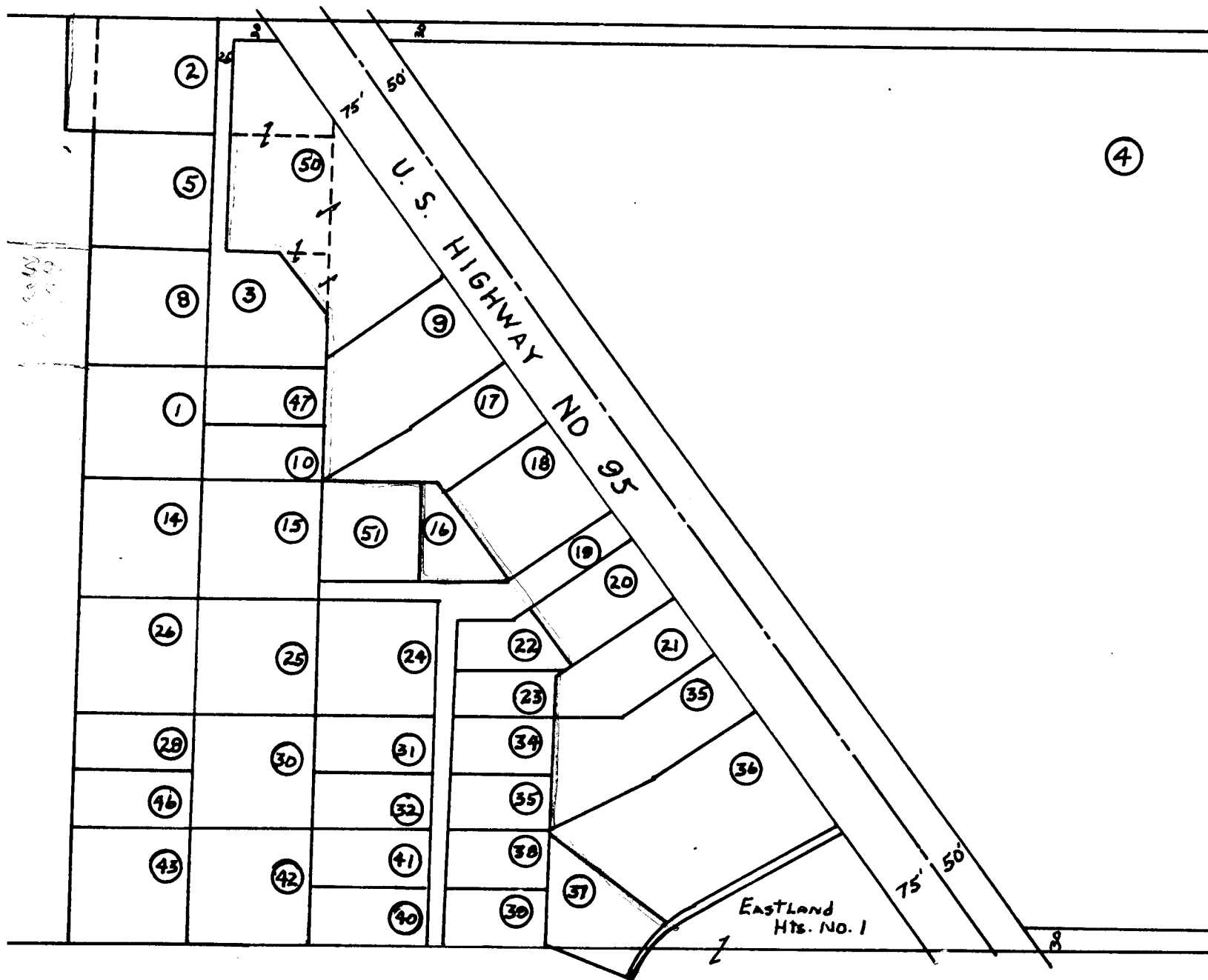
