ORDINANCE NO. 1061

AN ORDINANCE ANNEXING TO, AND MAKING A PART OF THE CITY OF LAS VEGAS CERTAIN SPECIFICALLY DESCRIBED TERRITORY ADJOINING AND CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF LAS VEGAS; DECLARING SAID TERRITORY AND INHABITANTS TO BE ANNEXED THERETO AND SUBJECT TO ALL LAWS AND ORDINANCES; ORDERING A PLAT SHOWING SAID TERRITORY TO BE RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF THE COUNTY OF CLARK, STATE OF NEVADA, AND PROVIDING OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Pursuant to a Petition duly presented to the Board of Commissioners of the City of Las Vegas, signed by a majority of the freeholders in the area containing the hereinafter described parcel of real property requesting the Board of Commissioners of the City of Las Vegas to annex to and make a part of the City of Las Vegas, the hereinafter described parcel of real property, the exterior boundaries of the City of Las Vegas are hereby extended to annex to, and include therein, the following described parcel of said property, to-wit:

That portion of the North Half ($N\frac{1}{2}$) of the North Half ($N\frac{1}{2}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section 2, Township 20 South, Range 60 East, M.D.B. & M., lying east of the centerline of U. S. Highway No. 95 (Tonopah Highway).

Together with the tenements, property and inhabitants within said parcel of real property is hereby declared to be a part of the City of Las Vegas.

SECTION 2. Said parcel of real property, together with the tenements and inhabitants thereof, shall be subject to all of the laws applicable to the City of Las Vegas.

SECTION 3. The City Engineer of the City of Las Vegas is hereby instructed to prepare plats of said territory described in Section 1 of this ordinance and to file the same for record in the office of the County Recorder of Clark County, Nevada.

Discussion

The Director of Planning, Mr. Donald J. Saylor: This is a rather large and important annexation. This is the Tonopah Highway and this is Craig Road. Most of it is under large holdings, and all of the property owners involved have petitioned for annexation. I think we have 100% petition for this. The Planning Commission has reviewed the matter and recommended approval of the annexation. This area is under one ownership and a portion of this is in North Las Vegas -- their annexation #19. We do not intent to include that in the Ordinance on this over-all annexation until this is settled one way or another.

Mr. Hal Atwood: I am the owner of this property here, and co-partner of this portion through here. In this section, we have gone through quite a bit of planning and working on this in order to work with the State Highway Department and your Planning Department, and if this thing goes through, it is going to have to be with the North Las Vegas Department. Now, I think I can get along pretty well with one or two of these outfits, but I'm going to have a hard time getting along with all three of them. I think that in order to settle the thing in the proper way, I see no reason nor no right in this set up where North Las Vegas can extend a limb out here and come right through our property. They want to gain access to Craig Road or Tonopah Highway, but let them come up here -- why break into this.

Commissioner Fountain returned to the meeting at the hour of 5:05 p.m.

The City Attorney, Mr. Sidney R. Whitmore: I discussed this in the office the other day with this gentleman and Mr. Saylor and I thought we had arrived at a conclusion, that we would proceed for annexation; but that we would take the two pieces separately -- the big piece that is outlined in green would be taken on one Ordinance, and the small area that you are discussing would be taken on another Ordinance. In that way, we won't have the whole thing in question. We will have to fight out the dispute on the small area with the City of North Las Vegas. I thought you were in agreement with that?

Mr. Atwood stated that he was in agreement and that he had signed the papers to allow this to be done the way the Attorney wished.

Mayor Whipple: I agree with our Attorney. If you get the two intermixed, you might throw the whole thing into a legal battle.

Mr. Atwood: At the present time, there is an office building under construction at this point here. I have stopped construction on this and since the first of the year I have been waiting to see if we are going to be in the County, the City or North Las Vegas. Also, through the County, we have permission for a hotel and shopping center here; and this area at the present time here -- this total of 80 acres -- it is the feeling at the present time that the Holiday outfit will go in here. I hope that the City Commissioners will go along with this type of development.

Commissioner Levy: If this was zoned by the County for these purposes, it will be taken in this way.

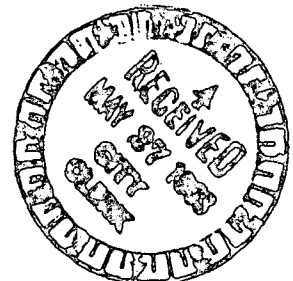

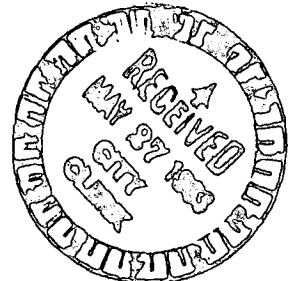

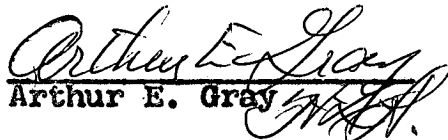
