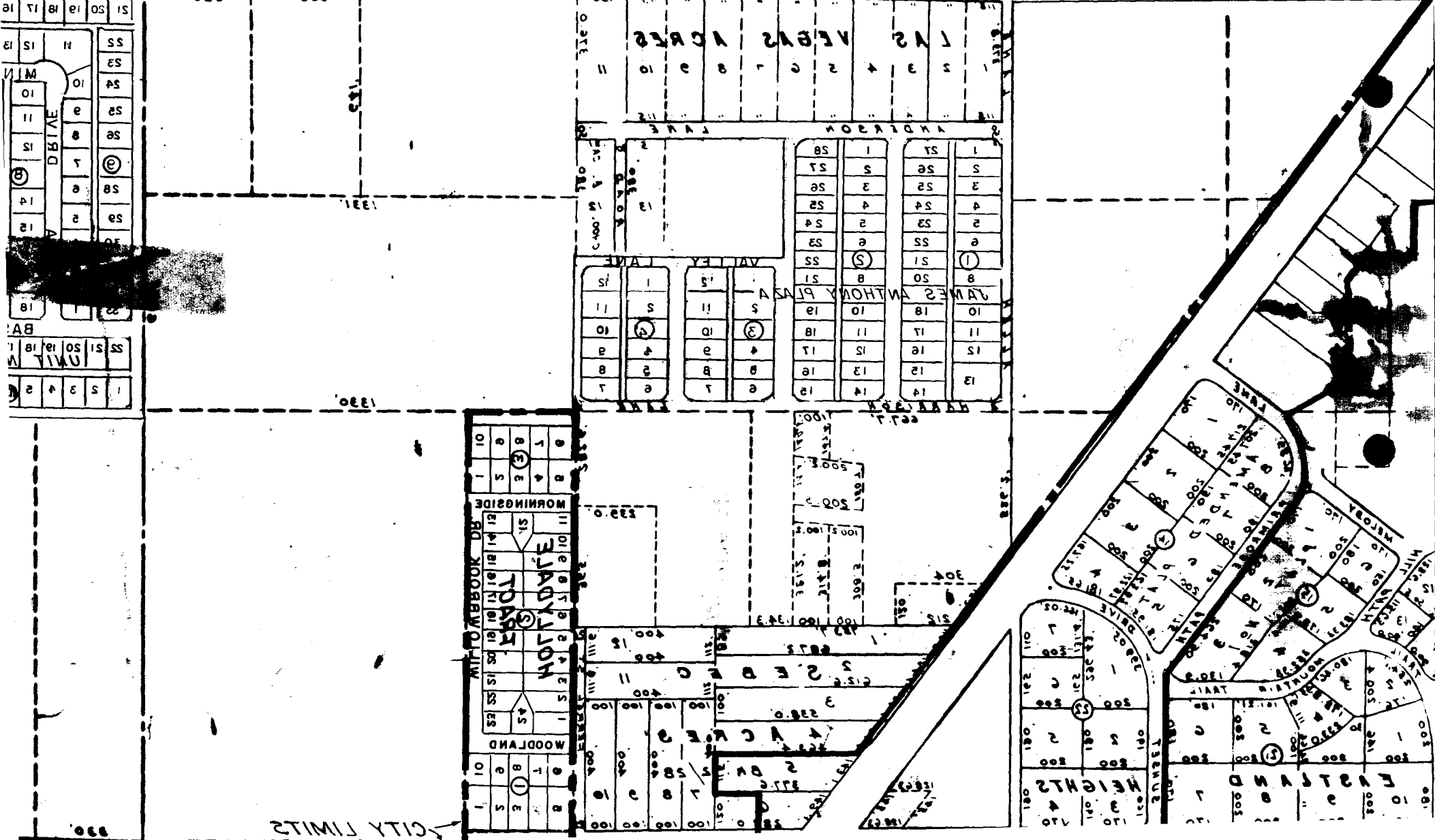

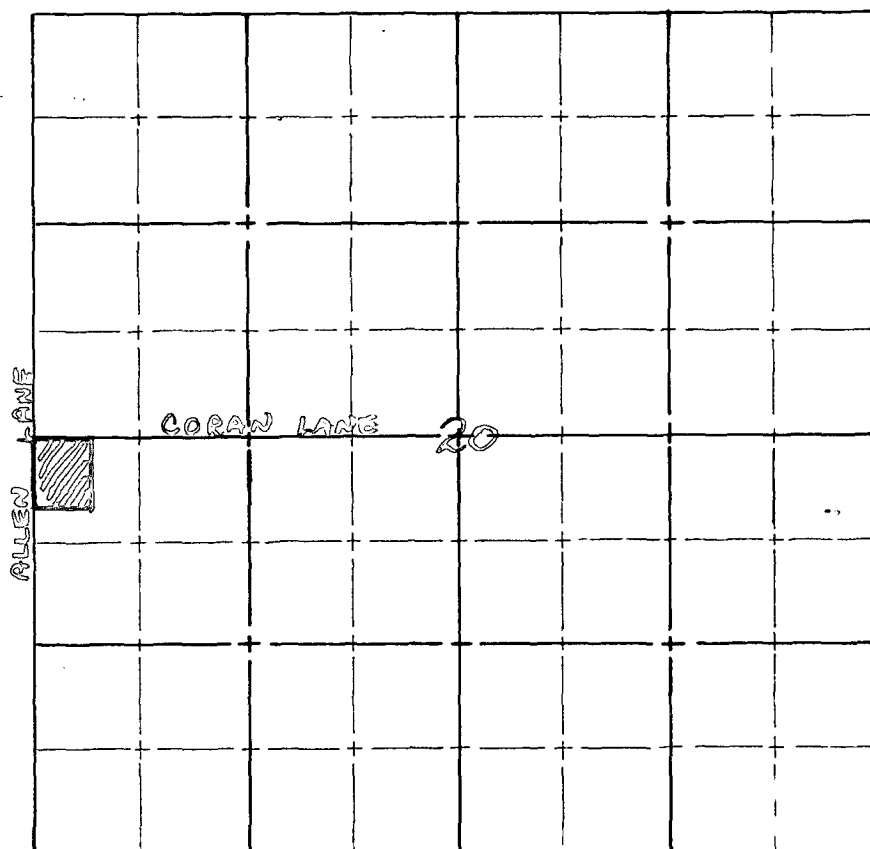

ORDINANCE No. 1095

AN ORDINANCE ANNEXING TO AND MAKING A PART OF THE CITY OF LAS VEGAS, CERTAIN SPECIFICALLY DESCRIBED TERRITORY ADJOINING AND CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF LAS VEGAS; DECLARING SAID TERRITORY AND INHABITANTS TO BE ANNEXED THERETO AND SUBJECT TO ALL LAWS AND ORDINANCES, ORDERING A PLAT SHOWING SAID TERRITORY TO BE RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF THE COUNTY OF CLARK, STATE OF NEVADA, AND PROVIDING OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Pursuant to a Petition duly presented to the Board of Commissioners of the City of Las Vegas, signed by a majority of the freeholders in the area containing the hereinafter described parcel of real property requesting the Board of Commissioners of the City of Las Vegas to annex to and make a part of the City of Las Vegas, the hereinafter described parcel of real property, the exterior boundaries of the City of Las Vegas are hereby extended to annex to, and include therein, the following described parcel of real property, to wit:

Lots 1, 2 and the West 60.00 feet of Lot 3,
Las Vegas Acres Tract No. 1

Together with the tenements, property and inhabitants within said parcel of real property is hereby declared to be a part of the City of Las Vegas.

SECTION 2. Said parcel of real property, together with the tenements and inhabitants thereof, shall be subject to the laws applicable to the City of Las Vegas.

SECTION 3. The City Engineer of the City of Las Vegas is hereby instructed to prepare plats of said territory described in Section 1 of this ordinance and to file the same for record in the office of the County Recorder of Clark County, Nevada.

A regular meeting of the City Planning Commission was called to order by Vice-Chairman Tiberti at 7:30 PM in the Council Chambers of the City Hall, Las Vegas, Nevada.

PRESENT: Vice-Chairman Tiberti, Messrs. Gilday, Johnston, Matteucci, and Longley, Sr.

ABSENT: Chairman Cahlan, Messrs. Fountain and Uehling, and City Manager Fletcher.

STAFF PRESENT: Director of Planning Don J. Saylor and Recording Secretary Esther Borden.

MINUTES: Upon motion by Mr. Johnston and seconded by Mr. Gilday and carried by a unanimous vote, the Minutes of the regular meeting of August 8, 1963 were approved as mailed.

NEW BUSINESS:

1. PARADISE PALMS NO.15 (Revised)
County Referred Tentative Map
Approved
Mr. Saylor presented the County referred tentative map of PARADISE PALMS NO. 15 (Revised), pointing out the general location. He stated that the only City major street involved was Desert Inn Road, and it was shown as a 50 foot half-street, which is in accord with our Master Plan of Streets and Highways. Staff recommended approval.
After discussion, Mr. Gilday moved that the County referred tentative map of PARADISE PALMS NO. 15 (Revised), be approved.
Mr. Johnston seconded the motion and it was carried by a unanimous vote.
2. CHARLESTON ESTATES NO. 5
AMENDED PLAT OF BLOCK 6
Final Map
Approved
Mr. Saylor presented the AMENDED PLAT OF BLOCK 6, CHARLESTON ESTATES NO. 5, pointing out the general location. He stated that there had been one lot added to this block, but the lots are still substantially larger than the minimum required. Staff has no objection to the addition.
After discussion, Mr. Johnston moved that the AMENDED PLAT OF BLOCK 6, CHARLESTON ESTATES NO. 5, be approved and the Secretary authorized to certify this approval on said map.
Mr. Gilday seconded the motion and it was carried by a unanimous vote.

COPIES TO:

This annexation is a very small area, about 2 acres. Time and cost involved in each annexation is about the same regardless of the size. Since the Engineering Division is and has been understaffed for many years the annexations of small areas greatly increase the backlog of urgent work to be done by the Division.

The average annexation requires about two days survey work for a crew of four and about three days office work for one person to make closure computations, make linen map and record. The estimated cost in salary to make an annexation is about \$300. Therefore, it is highly desirable that a minimum size of annexation be determined so as to reduce the time spent on annexations.

If annexations of a reasonable size were made it would be feasible and possible to investigate the engineering problems of each one.

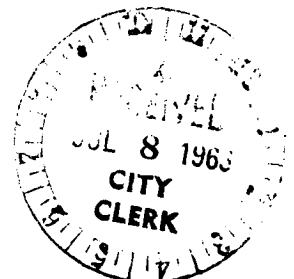

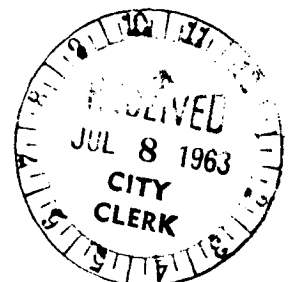
