Your memorandum of October 21, 1977 requested comments from the Public Services Department on the submittal of a Parcel Map # 22-77 by Leo and Harriet Pahor and Gabryella Hrast.

The heavy border of the plat should be extended an additional 10' to the south (20' width) to provide for additional 10' right-of-way dedication on E. Charleston Blvd. In conjunction with this, future right-of-way width should be shown as a dashed line to designate right-of-way requirements that are ultimately to be met.

Inasmuch as Fremont St. is referred to in the text of the Owner's Certificate, the right-of-way should be shown in dashed lines with its location and distance to some point on the platted area.

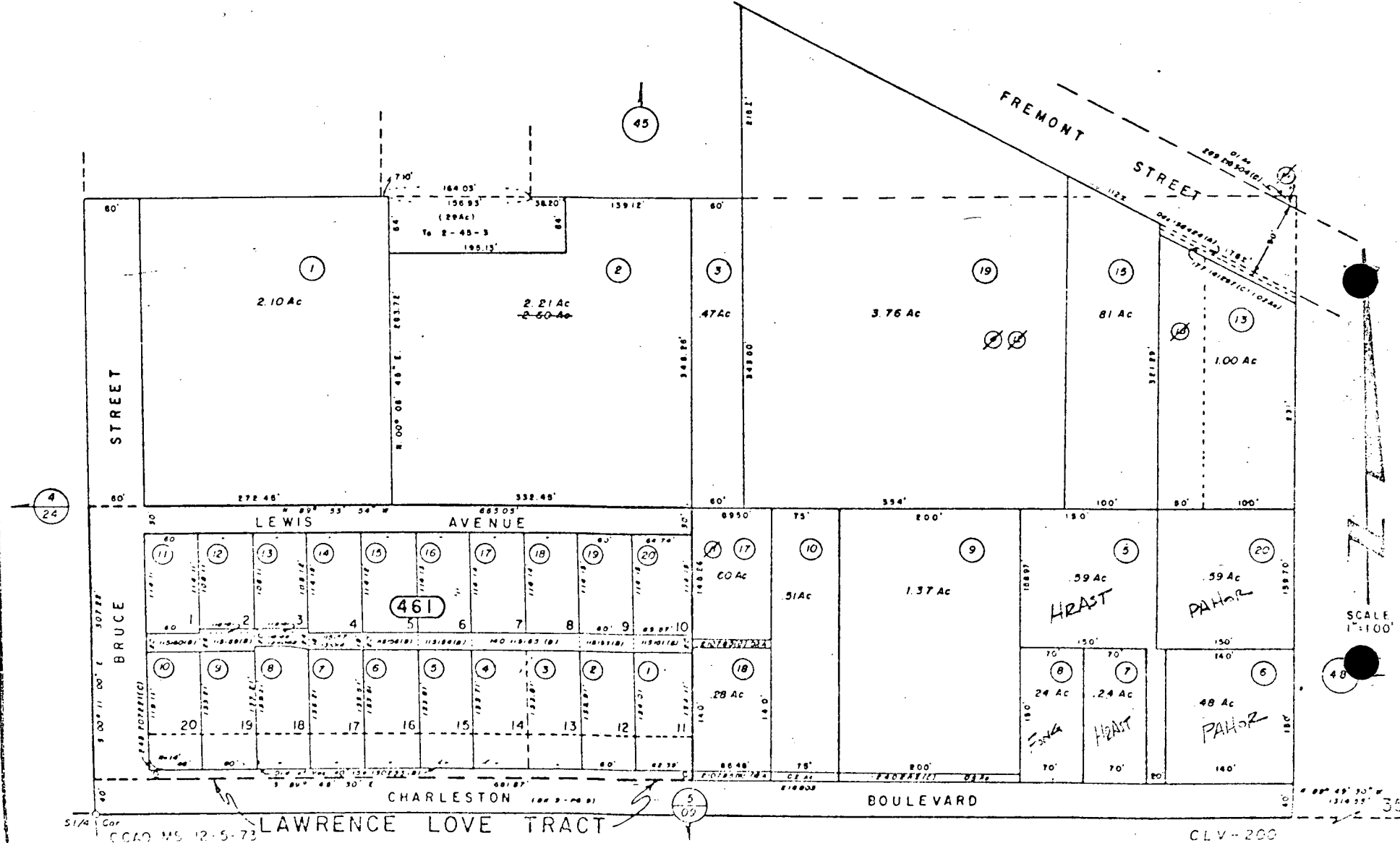
