- 1 1. No objections
2. Fire hydrants to be installed within 500/600 feet of the building or existing hydrant.
3. Fire hydrants to be installed in accordance with current fire code adopting ordinance.
4. Fire flow requirements to be determined when construction plans are submitted.
5. Hydrants are to be installed and charged with water before construction begins.
6. Must meet requirements of Uniform Fire Code.
7. Dead end fire lanes not to exceed 150'.
8. Minimum turning radius of 45' 6".
9. Crash gate(s) shall be approved by the Fire Department prior to installation. Said gates shall be a minimum of 15 feet in width. Gates shall be over an all weather road surface. Any chain or locks used to secure such gates shall no be no larger than 3/8 of an inch in diameter.
10. If private streets are to be named, names are to be checked by Alarm Office to eliminate duplication.

OTHER:

1. Provide this department with information on the available water in the immediate area of building project (water analysis).
2. Provide information on: Height of buildings; type of construction; type of roof covering; and ground floor square footage so that we may determine your exact fire flow needs.
3. The required fire flow shall be available at the most remote hydrant(s)
4. Peak demands of domestic and irrigation water must be considered in the water analysis.

The Department of Public Works has recently established a general policy to be used to determine the extent of required off-site public-street improvements when a development abutts and/or fronts State Highway rights-of-way.

In general, the policy will be that no off-site improvements will be required upon any streets/roads that abutt NDOT rights-of-way, except where access to the development is needed from or across such NDOT rights-of-way. Each development and its needs will still be reviewed on a case-by-case basis.

In the review of conditions for the Plot Plan Review of Z-133-77 we believe that Condition #4 should be eliminated as a requirement of this development.

As per Condition #3 we will still require half-street improvements on Dalecrest and will still require approximately 81 LF of half-street improvements on Gowan.

The Gowan improvements will require the typical transition paving between the improved street section and the existing ribbon asphalt street. The Gowan/Dalecrest intersection may require a special design to route stormwaters to the existing box culverts under the Gragson Highway.

Comply with the remaining Conditions of Approval for the Plot Plan Review of Z-133-77.
