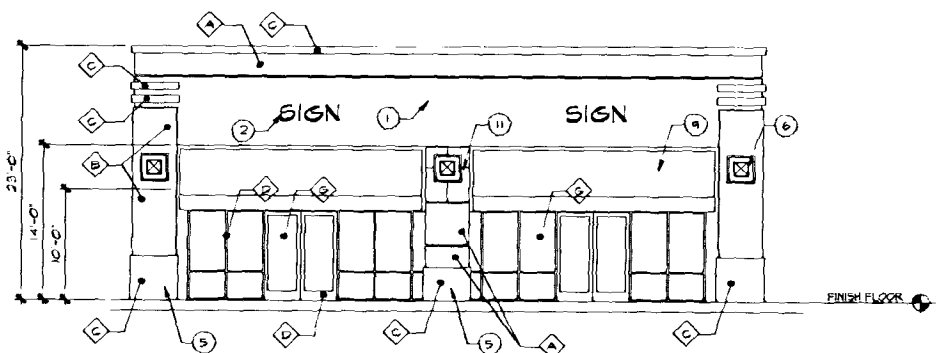

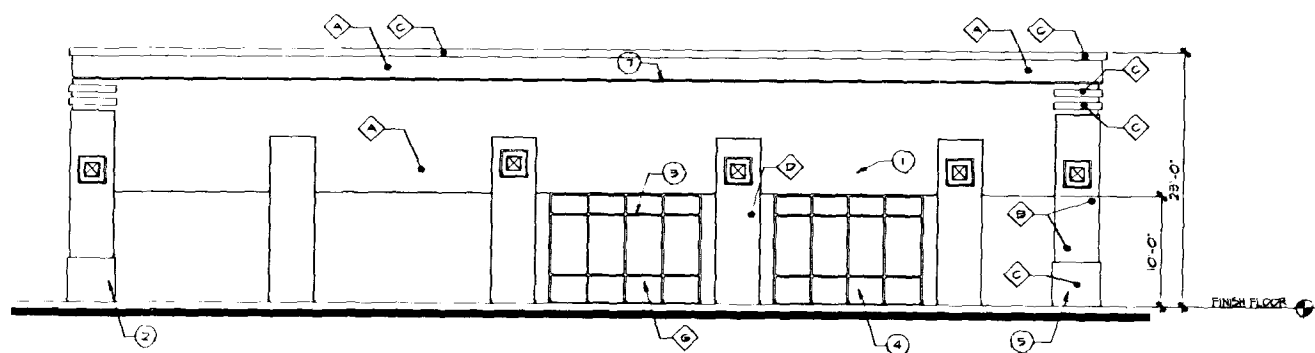

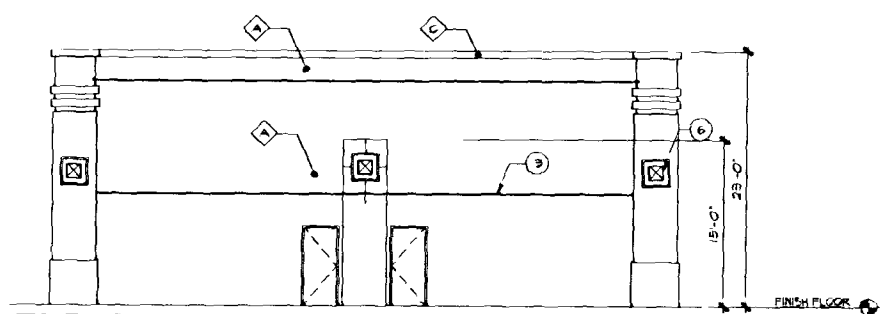

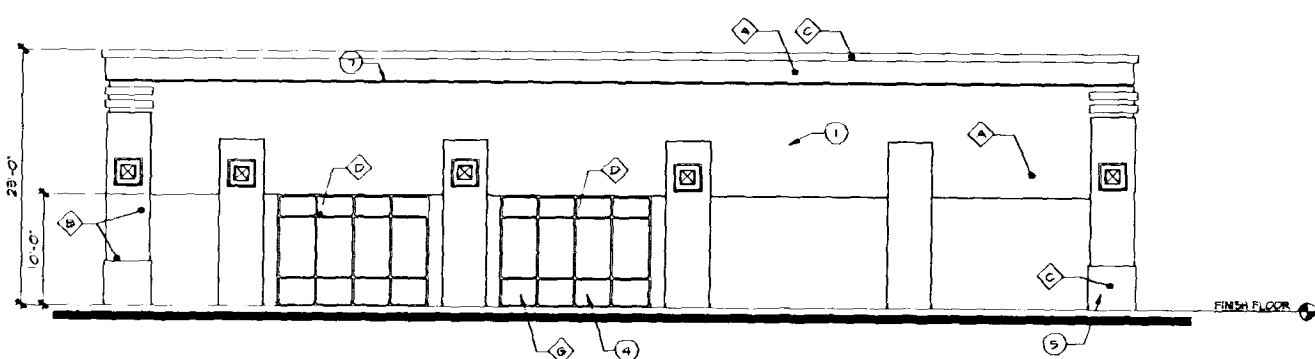
A EAST ELEVATION

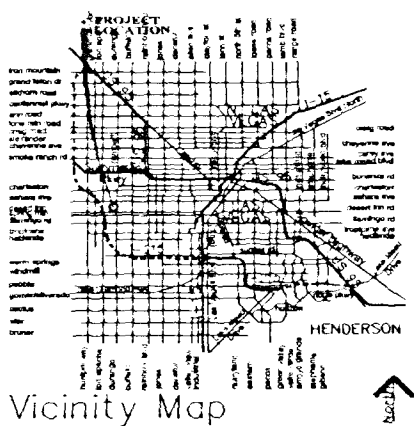
C NORTH ELEVATION

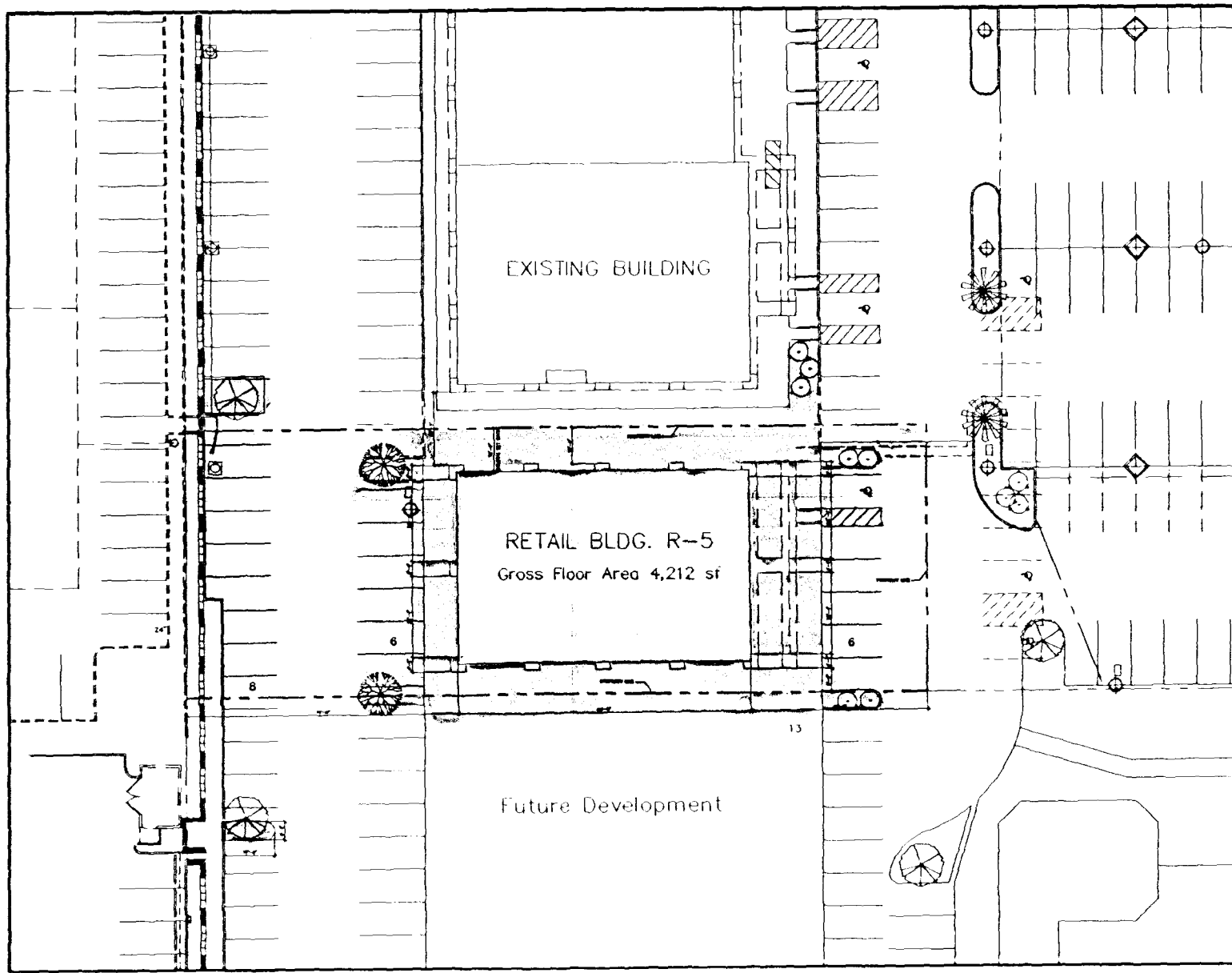
