FLOORPLAN



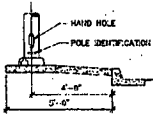

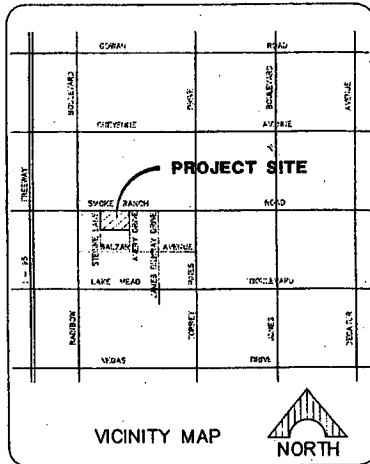

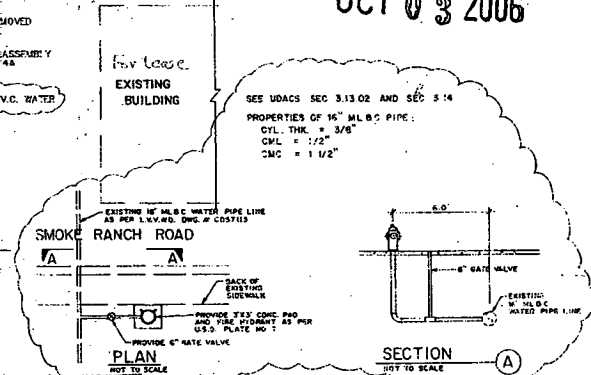


PROJECTED SEWER FLOWS

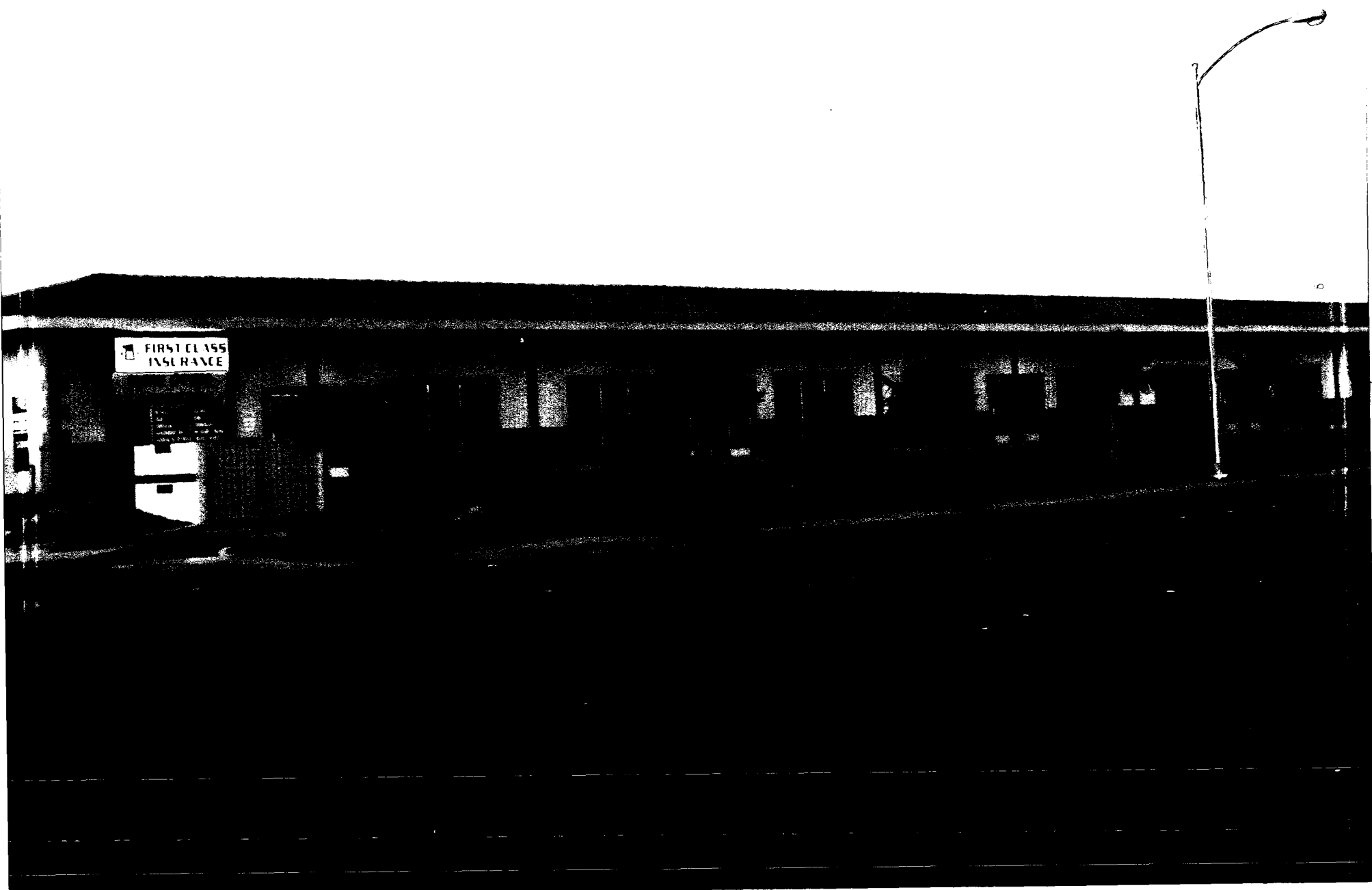

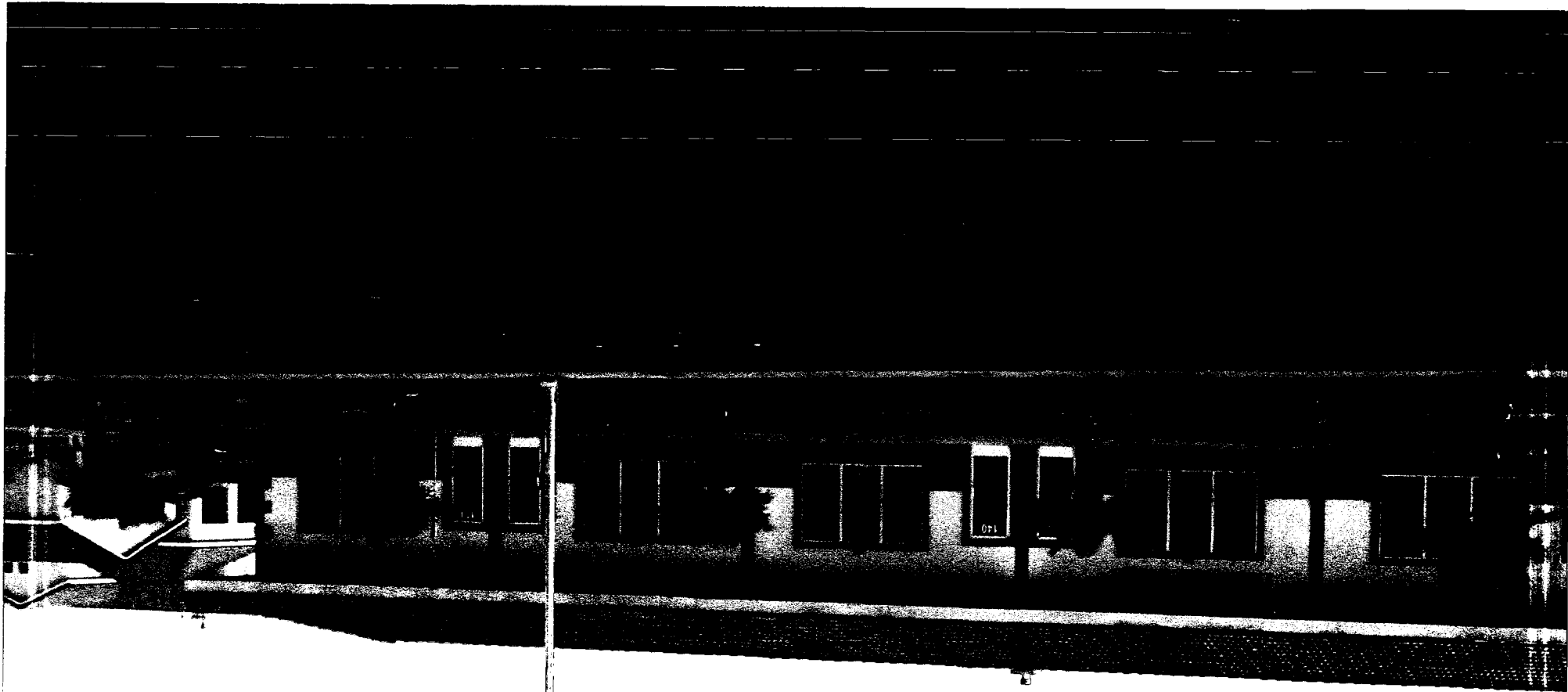
