

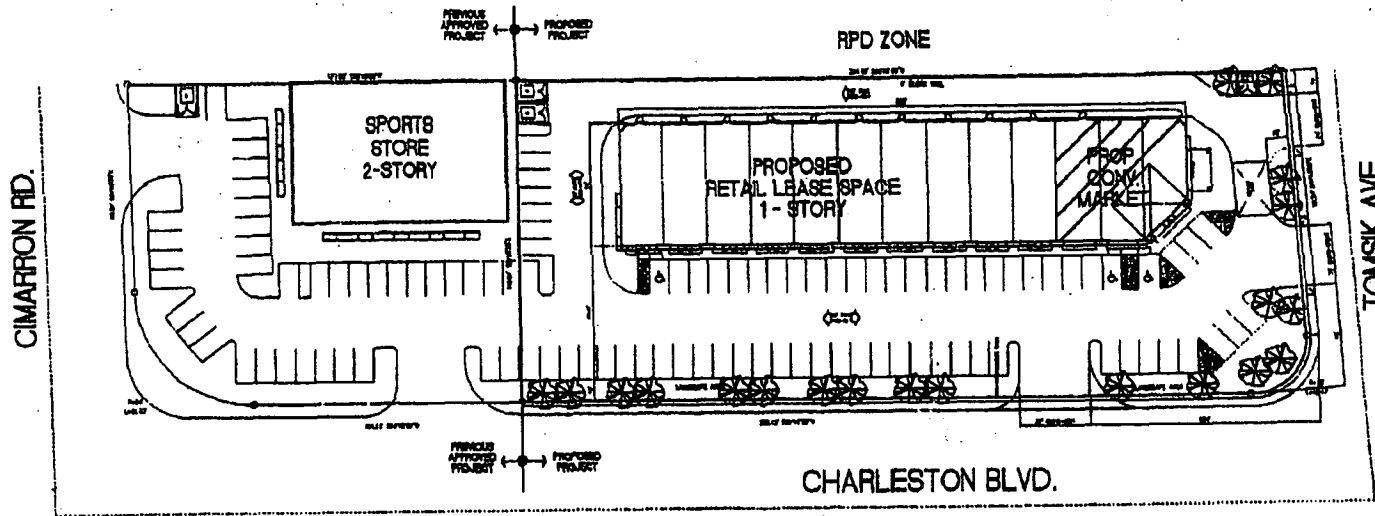

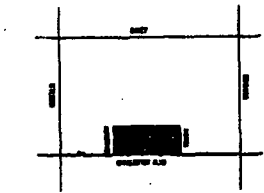

SITE PLAN

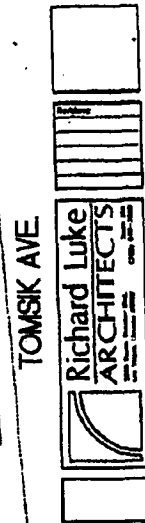


1 proposed site development plan

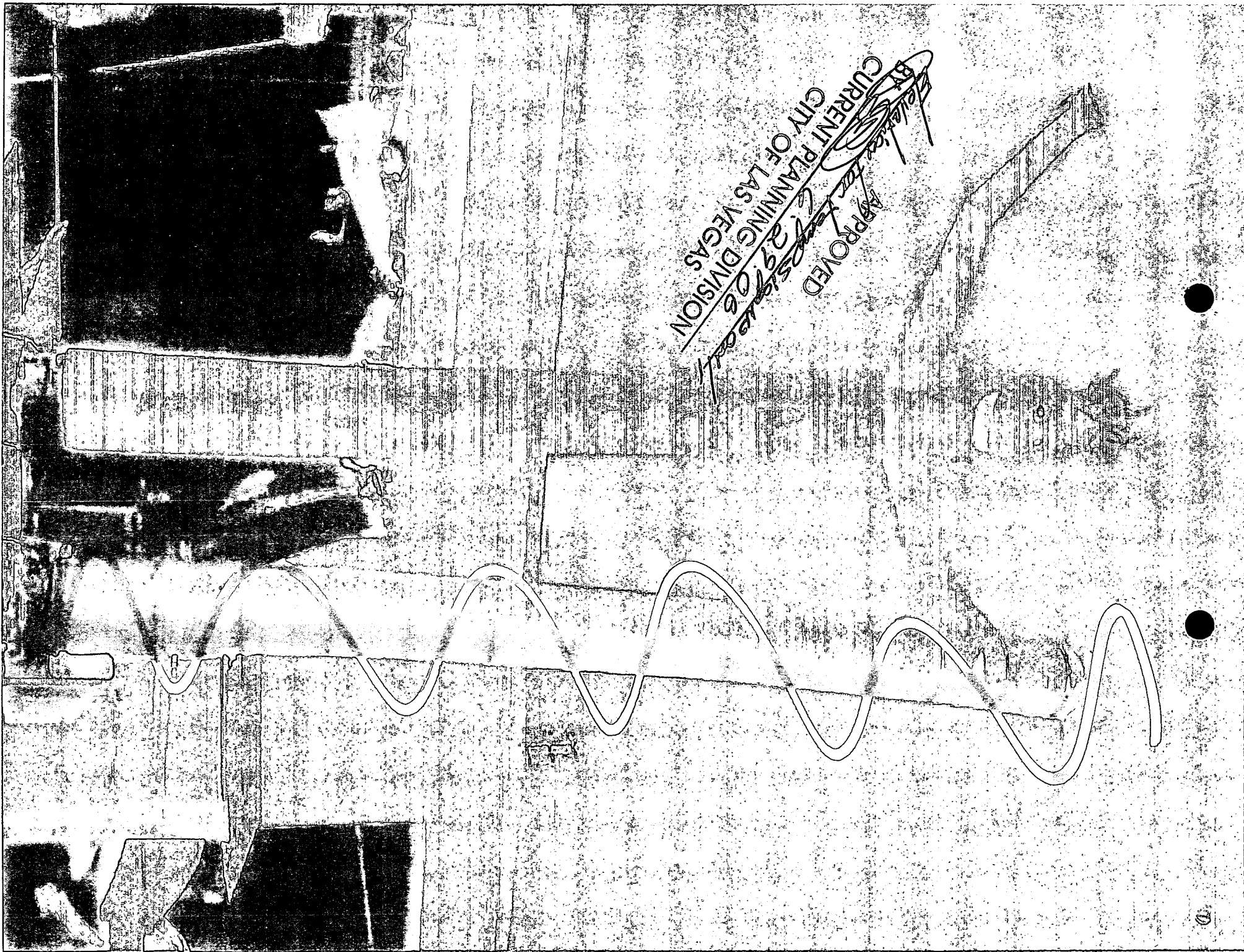

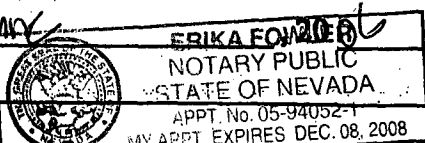

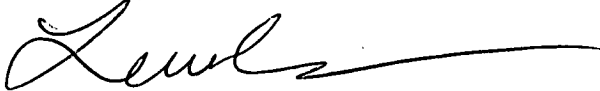

As per our conversation, I can proceed with the review and approval of temporary signage for the water store with the grand opening of the addition of the smoothies if the application meets the requirements of Title 19.

Up-date of items reviewed;

1. The corrections to the plans L-3233-06 showing a preparation bar, freezer, and sink for the addition of smoothie store to the water store were not reviewed by planning. The application was signed 4-22-06. The plans were received 4-25-06 and were not stamped approved by planning.
2. Business licensing does not require planning to review licenses that are adding a use to ~~there~~ ^{their} existing business if it is not the primary part of the business.
3. As we discussed, this location will be considered the same as a 7-11 with the sale of smoothies. This condition will be good as long as the business does not provide a means for a seating area.

I will up-date the LMEM screen in business licensing to reflect the "seating condition." I will also bring you a copy of the documentation that we reviewed.
