Dear Planner;

I am requesting permission to hold a carnival at the Fremont Plaza located at 232 N. Jones in Las Vegas. The carnival will be set up at the South end of the parking lot along the interstate. The dates of carnival operation will be September 28 through October 1, 2006. The hours of operation will be Thursday, 5:00 – 11:00, Friday 5:00 – 12:00, Saturday 1:00 – 12:00 and Sunday 1:00 – 10:00. At times the carnival closes early, depending on how late the people stay. We would not extend the hours to a later time. The set up would commence on September 26, 2006. The equipment would be moved off on Monday and Tuesday, October 2nd and 3rd.

The carnival will consist of 13 rides including rides such as the Carousel, Gondola Ferris Wheel, Sizzler, Ring of Fire, Bumper Cars, Jalopy Junction, Squadron, Raiders, Mardi Gras Fun House, Super Slide, Typhoon and the Dragon Wagon Coaster. There will be about 6 – 8 games such as The Balloon Dart, The Dozer, a Ball Throw, a Roll Down, etc. All games are licensed through the Washington Gambling Commission and follow the strict guidelines they set for our industry. We will have 2 – 3 food trailers. One is a cotton candy trailer which sells Cotton Candy, Carmel Apples, Popcorn, soda pop, water, and Slushy's. The second is a Corn Dog Trailer selling corn dogs, sausage dogs, hot dogs, curly fries, nachos, and drinks. The third trailer is a funnel cake stand selling funnel cakes and drinks. The health permits have been applied for and paid in advance. We will not have any tents other than the game booths. We do not sell alcohol of any kind and do not allow patrons to carry alcohol into the premises.

I have received permission to use the property from the property management of General Growth. My contact at General Growth is Susan Holland, Phone 702.369.0704. Although this is my first time to use the Fremont Plaza property, it is my understanding that they typically have 2 carnivals every year, one in the spring and one in the fall. I have sent an application to the City of Las Vegas with a check in the amount of \$430.00 which includes \$100 per day for operation and a \$30.00 processing fee. I have also enclosed a certificate of insurance to the city naming the City of Las Vegas.

I have enclosed a check in the amount of \$100 for the Planning Department fees.

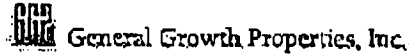
