- 1) THE TEMPORARY SIGN PERMIT SHALL BE VALID FOR 45 DAYS FROM FEBRUARY 6, 2008 TO MARCH 21, 2008.
- 2) ALL TEMPORARY SIGNS SHALL BE SET BACK FROM ANY STREET INTERSECTION OR DRIVEWAY OR OTHERWISE LOCATED IN ORDER TO NOT CREATE A SIGHT RESTRICTION.
- 3) ALL TEMPORARY SIGNAGE SHALL BE SO LOCATED AS TO NOT CREATE A NUISANCE TO NEARBY PROPERTIES AS A RESULT OF FACTORS SUCH AS EXCESSIVE ILLUMINATION, GLARE, OR NOISE.
- 4) ALL TEMPORARY SIGNAGE SHALL CONFORM TO THE SUBMITTED SITE PLAN.
- 5) THE APPLICANT SHALL DISPLAY A COPY OF THIS TEMPORARY SIGN PERMIT DURING NORMAL BUSINESS HOURS.
- 6) ALL TEMPORARY IMPROVEMENTS MADE TO THIS SITE AND THE ABUTTING STREETS SHALL BE REMOVED UPON EXPIRATION OF THE PERMIT.
- 7) ALL APPLICABLE CITY CODE REQUIREMENTS SHALL BE SATISFIED.
- 8) THE APPLICANT SHALL BE RESPONSIBLE FOR LEAVING THE SITE FREE OF DEBRIS, LITTER, OR ANY OTHER EVIDENCE OF THE SIGNAGE UPON EXPIRATION OF THE PERMIT.
- 9) NO SIGNS SHALL BE LOCATED IN THE PUBLIC RIGHT-OF-WAY.

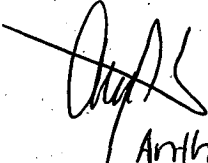

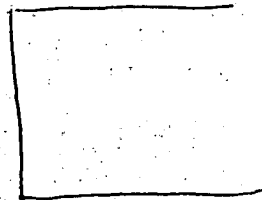

Attention: Property and/or Business Owners, Corporate Officers, and General Managers:

City of Las Vegas Municipal Code, Chapter 19.14 (SIGN STANDARDS)

1. All signs not expressly permitted or exempted under CLVMC 19.14 are prohibited.
2. CLVMC 19.14.100 prohibits the construction, placement, or erection of off-premise signs without obtaining a Special Use Permit. Apply at City Planning, 731 S. 4th Street.
3. CLVMC 19.14.090 prohibits posting any on-premise temporary sign without obtaining a temporary sign certificate from the Director of Planning, 731 S. 4th Street, 229-6301.
4. Including but not limited to; banners, balloons, inflated devices, pennants, streamers, portable signs, similar attention gaining devices, and human beings displaying signage.
5. CLVMC 19.14.120 Sec (A) Sub-Sec 3. Signs requiring a certificate shall have it displayed where visible or be subject to removal.
6. CLVMC 19.14.020 Sec (G) Sub-Sec.(1) All signs shall be maintained in good structural condition, in compliance with all building and electrical codes, and in conformance with this chapter at all times. (2) All materials used in sign construction shall be maintained in such a manner as to be free from fading, peeling, chipping and other states of general deterioration.
7. CLVMC 19.14.170 Sec. (A) Sub-Sec. (6) each sign installed, created, erected, maintained, failing to display a permit tag, or abandoned in violation of 19.14 shall be considered a separate offense when applying penalties.
8. CLVMC 19.14.140 Sec (B) Sub-Sec. (2 & 3) each sign shall be subject to removal and impound after 10-day Notice has been issued.

The City of Las Vegas shall have the right to recover any costs incurred for removal and disposal of each illegal sign, from the property or business owner or installer of each sign, or the property on which it is located, or any other responsible person.

The City of Las Vegas may issue a misdemeanor citation and upon conviction, seek imposition of fines with accordance with the following schedule per CLVMC 19.14.170 Sec. (B) Sub-Sec 6.

- Upon the first conviction, a minimum of \$200 dollars;
- Upon the second conviction within a period of one year, a minimum of \$500 dollars;
- Upon each subsequent conviction within a period of one year, a minimum of \$1000 dollars

Failure to comply may result in the denial of future business license/permits required to perform business activity in the City of Las Vegas.
