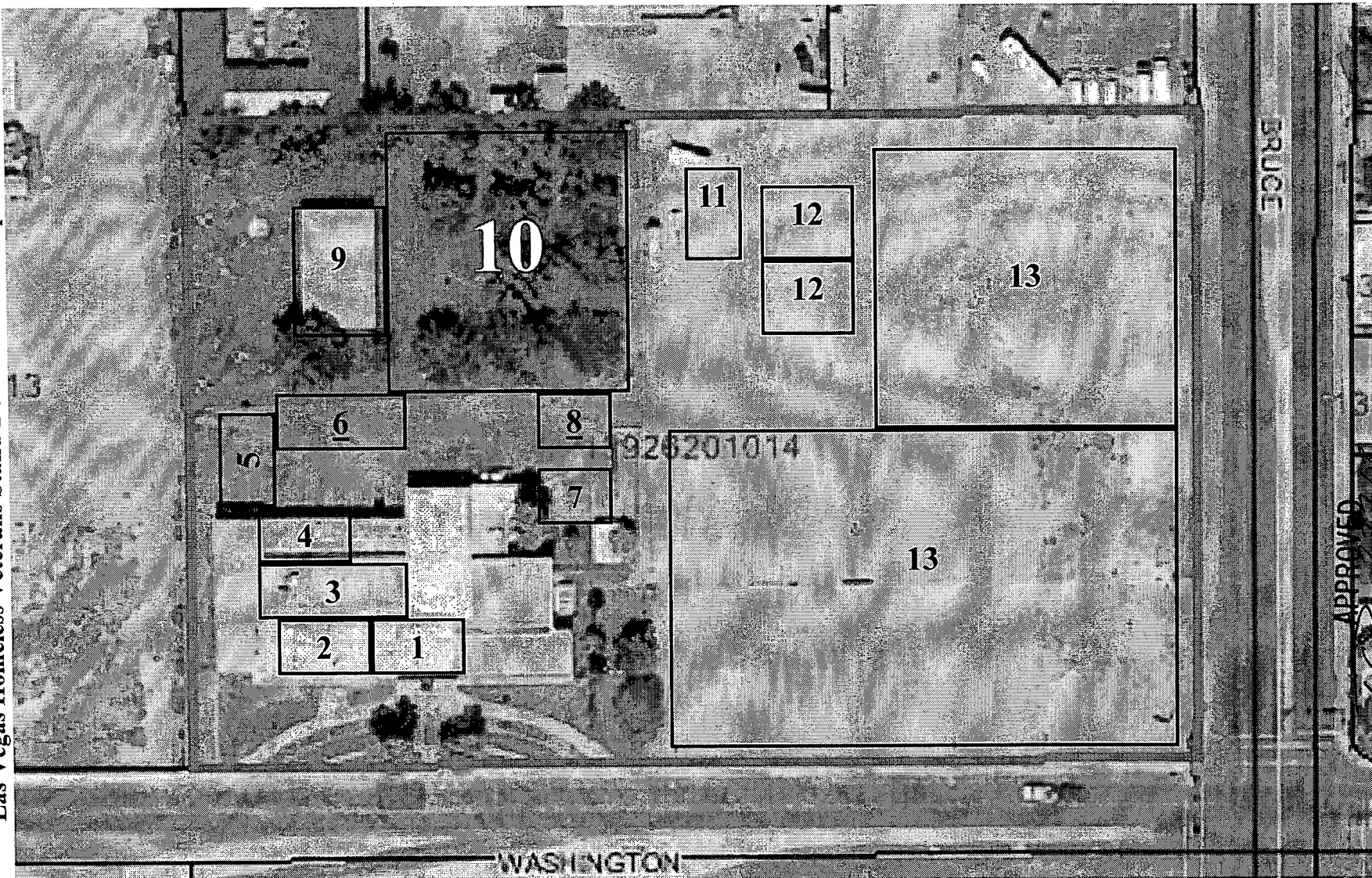

2. THIS PERMIT IS NOT A BUSINESS LICENSE.
3. THIS PERMIT IS NOT A SUBSTITUTE FOR ANY REQUIRED STATE OR LOCAL BUSINESS LICENSE OR FOR ANY REQUIRED CHARITABLE SOLICITATION PERMIT.
4. This use shall not create a nuisance to nearby properties as a result of factors such as excessive illumination, glare, noise, vibration, smoke, dust, dirt, odors, gases or heat.
5. The use shall conform to the submitted plot plan date stamped 4/9/08.
6. No combustible materials shall be located within 50 feet of any structure on, or adjacent to this site.
7. No building or structure of any type shall be erected closer than 25 feet from any property line.
8. The applicant shall display a copy of this Temporary Commercial Permit during the hours of operation.
9. Sanitation facilities must be provided in accordance with the Clark County Health District and Republic Services of Southern Nevada.
10. The applicant shall provide private security officers as required by the Las Vegas Metropolitan Police Department.
11. Any signage for this temporary commercial use must be approved and permitted by the Planning and Development Department.
12. All applicable City code requirements shall be satisfied.
13. The applicant shall be responsible for leaving the site free of debris, litter or any other evidence of occupancy upon completion or removal of the use.

Justification letter for Temporary Commercial Permit application

April 2, 2008

United States Veterans Initiative ("U.S. VETS"), a 501c3 community-based organization, is hosting the 5th annual Las Vegas Veterans Stand Down on May 14-16, 2007. U.S. VETS is the non-profit sponsor of the Stand Down, and the event is also supported by other local non-profits and community-based agencies, veteran service organizations, the County, Sen. John Ensign and Sen. Harry Reid's offices, Congressional offices of Jon C. Porter and Shelley Berkley, and the VA Medical Center of Southern Nevada. The event will be held at the Fraternal Order of Eagles Aerie #1213 at 1601 East Washington Avenue in Las Vegas, Nevada.

The Stand Down will focus attention on the needs of many homeless veterans in the Las Vegas valley. Approximately 400 homeless veterans are expected in attendance over the course of the event. The Stand Down will bring the community into the solution, give hope to those veterans who are still living on the streets of Las Vegas, offer them a temporary respite, and provide information and services that can help end their nightmare on the streets.

The 1601 E. Washington Avenue property (Eagles Lodge #1213, assessor #: 13926201014) will be used for the following services, all of which will be free to homeless veterans:

- Social service provider booths offering housing and rental assistance, referrals to treatment, social security assistance, family support, legal assistance, dental work (courtesy of Miles For Smiles)
- Veterans Administration booths: veteran benefits and enrollment, medical checks (blood pressure and tuberculosis screenings), dental checks, assistance with service records
- Distribution of goods: clothes, shoes, socks, underwear, hygiene kits
- Free haircuts
- 3 meals on May 14 & 15: Breakfast (continental), Lunch (BBQ), Dinner (catered hot meal)
- Empowerment groups and support meetings such as Alcoholics Anonymous
- Closing ceremony: recognition and awards on May 16
- An agenda of the event's proposed activities is also attached.

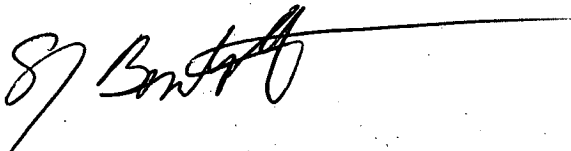

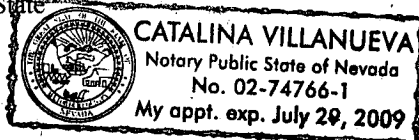
