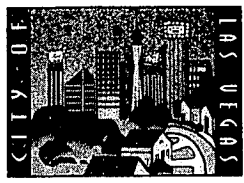

Dear Ms. Ma:

It has been determined that the proposed co-location of antennas to an existing 82.5-foot tall Wireless Communications Facility, Stealth meets the standard for approval as defined in Title 19.04.040 and 19.20.020 of the Zoning Code of the City of Las Vegas, subject to the following.

1. Conformance to the submitted site plan and elevations.
2. The wireless communications facility and its associated equipment and screening shall be properly maintained and kept free of graffiti at all times by the monopole owner. Failure to perform the required maintenance may result in fines and/or removal of the facility and its associated equipment. If abandoned, the property owner must obtain a demolition permit to remove the equipment within 30 days of abandonment. All equipment must then be removed within six months after operations at the site cease.

A Special Use Permit application will not be required prior to submittal of building permits. It should be noted that within ten (10) days after this notice is mailed, the applicant may proceed to apply for building permits, unless a member of the City Council files with the Director a written request for the Council to review the approval. A copy of this letter must be included in the permit package.

JUSTIFICATION LETTER

MetroPCS is a regional provider of wireless communications services with more than 3 million subscribers to date. We hold 23 licenses in the greater Miami, Tampa, Sarasota, Atlanta, San Francisco, Dallas, Detroit and Sacramento metropolitan areas. MetroPCS is currently building a network in Las Vegas (among other regions in the country), expecting to launch service in less than a year. When we enter a new market, our goal is to collocate on existing structures as much as possible.

In this case, MetroPCS proposes to mount six (6) panel antennas at approximately 50' above ground level (antennae centerline) on an existing 82' tall monopine owned by New AT&T Wireless (formerly Cingular Wireless). Coax cables connecting these antennas to MetroPCS's equipment cabinets will run on the exterior of the monopine, shrouded and painted the same color as the monopine bark. We are positioning the coax cables on the east side of the monopine to further minimize their visibility from Ann Road. MetroPCS's equipment cabinets will be located immediately north of AT&T's equipment shelter inside the maintenance yard of Los Prados Community Association. The proposed 12' x 16' equipment area will not be enclosed, as the Community is gated and secured. However, MetroPCS will cover the top of the cabinets with a fabric sun screen or canopy to shade the equipment from heat. Only the sun screen and a small portion of the coax cable ice bridge near the cabinets will be visible from Ann Road, as shown on the concurrently submitted photo simulation.

Once MetroPCS service is available in the greater Las Vegas area, residents will finally have the option of flat-rate plans with unlimited anytime local and domestic long distance minutes with no signed contract. Customers have many plans to choose from, the premier one priced no more than \$50.00 a month plus tax, which includes unlimited text messaging, directory assistance and the taking, sending and receiving of photos. MetroPCS is among the first wireless operators to deploy an all-digital network based on third generation infrastructure and handsets. In sum, MetroPCS allows its customers to benefit from new technology without having to count minutes and hassle with paying overages. In addition to bringing a new low, flat-rate wireless service, MetroPCS's entry into the Las Vegas market will create many technical and retail based jobs.

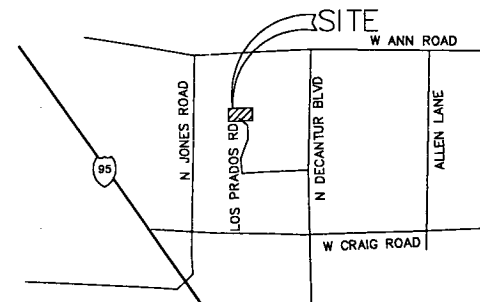

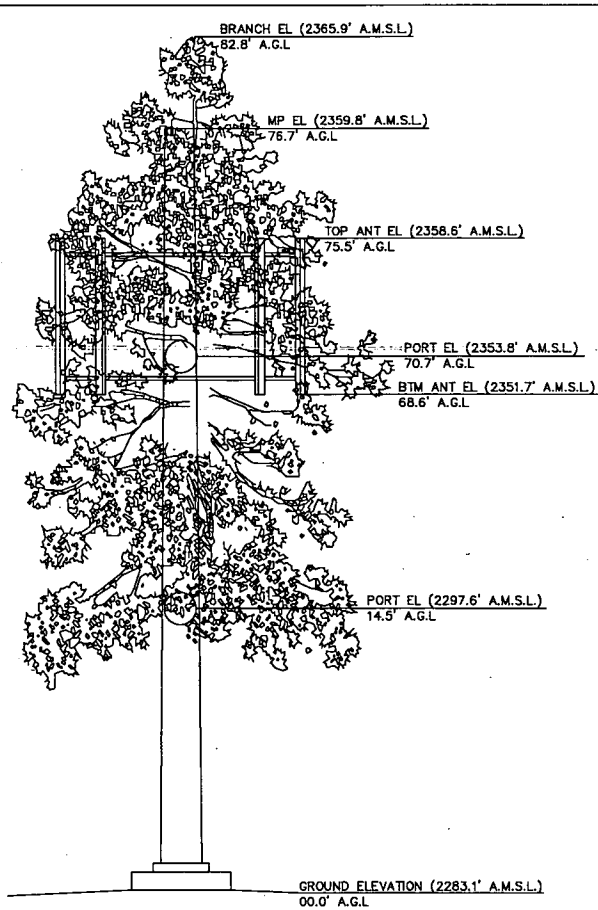

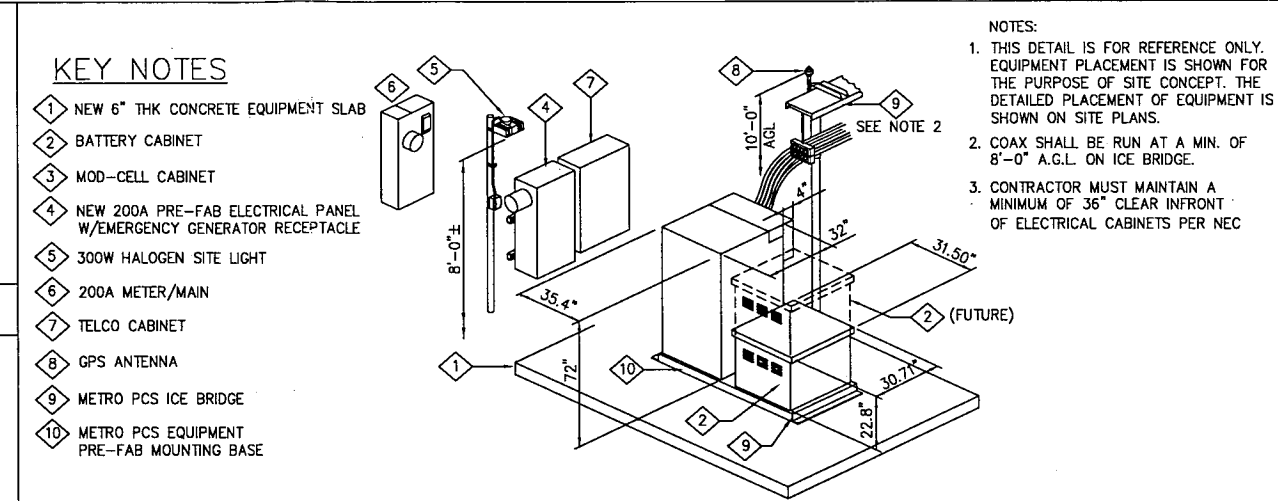

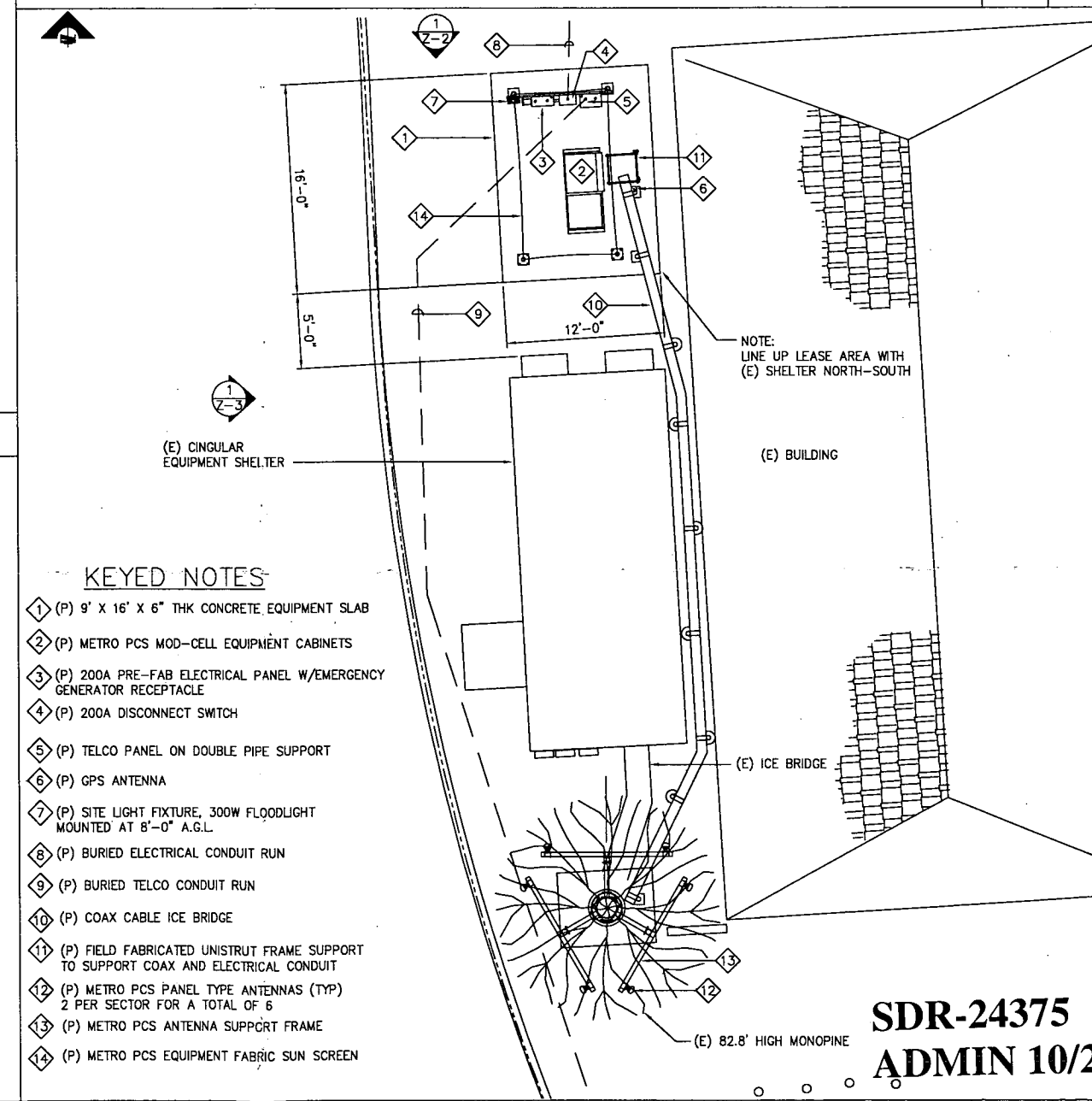
OVERALL SITE PLAN
