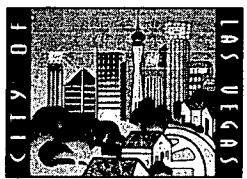

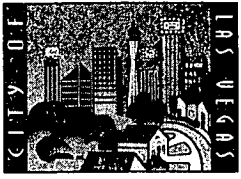

This letter is an affirmation to the planned proposal to designate the Tule Springs Ranch area as a Historic Site.

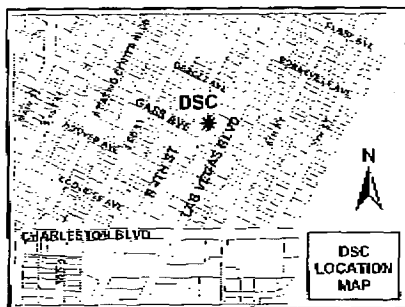
