5. **The use shall conform to the submitted plot plan.**
6. **No combustible materials shall be located within 50 feet of any structure on, or adjacent to this site.**
7. **No building or structure of any type shall be erected closer than 25 feet from any property line.**
8. **The applicant shall display a copy of this Temporary Commercial Permit during the hours of operation.**
9. **Sanitation facilities must be provided in accordance with the Clark County Health District and Republic Services of Southern Nevada.**
10. **The applicant shall provide private security officers as required by the Las Vegas Metropolitan Police Department.**
11. **Any signage for this temporary commercial use must be approved and permitted by the Planning and Development Department**
12. **All applicable City code requirements shall be satisfied.**

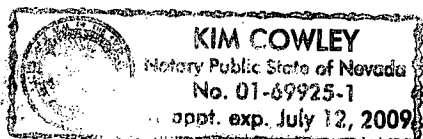

Justification Letter

This letter is a request for a NASCAR souvenir trailer to be set up at the Stratosphere Casino, Hotel & Tower. The proposed dates are March 3/8/07 to March 10/07 from 1pm - 9pm.

The hours of operation will be 24 (twenty-four) hours a day. The trailer we will be using is a white 30 foot Souvenir Trailer. The dimension of the trailer is 8 (eight) foot wide, 30 (thirty) foot long and 13 (thirteen) foot tall.

The trailer will be used to display the NASCAR Jackets, T-Shirts, and Hats. On the outside of the front of the Trailer we will have 2 (two) - 10 x 10 (ten x ten) Canopy Covers which will cover merchandise from the sun.

The construction of this 10 x 10 (ten x ten) canopy is a lightweight aluminum frame. Canopy will be attached to trailer and there will be no side panels. Also on the outside and in front of the trailer will be 2 x 8 (two x eight) foot tables to display diecast cars. The tables are standard construction. Also in front of the trailer we will have 2 (two) shirt racks. These racks are 5 (five) foot tall and are 6 (six) feet around. The racks are of a metal structure. There will be no signage used at the event.

There will be a portable bar, hot dog stand AND popcorn cart.

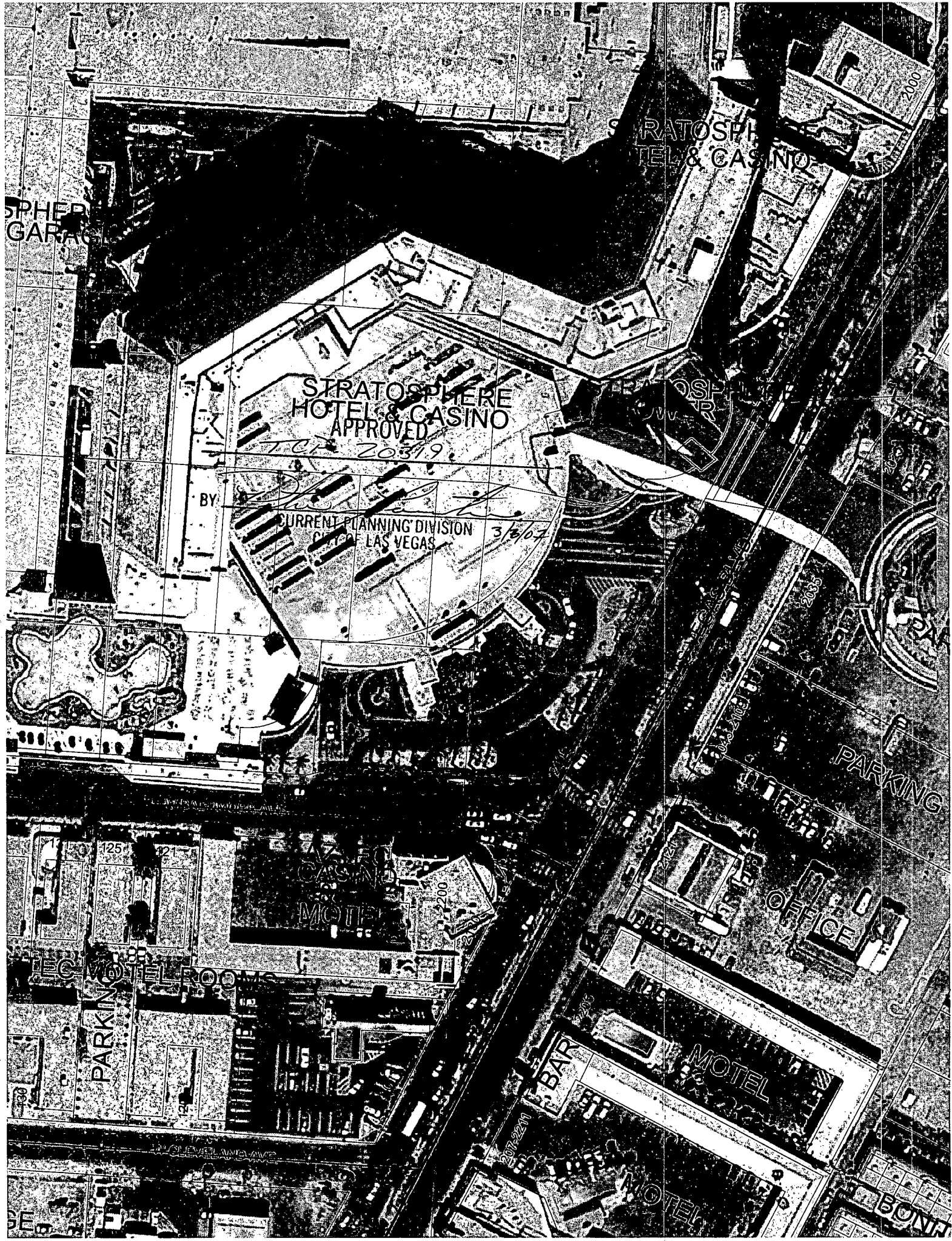
There will be a FREE Carnival game set with a NASCAR Theme.
