I reviewed the above referenced project for **Planning only**. The following comments and/or corrections must be addressed to complete the plans review.

1. Planning staff has reviewed the proposed room addition located at 316 Brighton Road. The project site is zoned as R-1 (Single Family Residential) within the Southwest Sector of the City of Las Vegas Master Plan.
2. In accordance with Title 19.08 Residential Development Standards of the City of Las Vegas Municipal Code, a minimum 15 foot rear yard setback is required. As proposed, the site plan indicates an 11 foot rear setback. Any encroachment into this setback requires a Variance. If no redesign is proposed, the Variance process can be started with submittal of a Pre-Application Conference Request to the Planning Department.
