

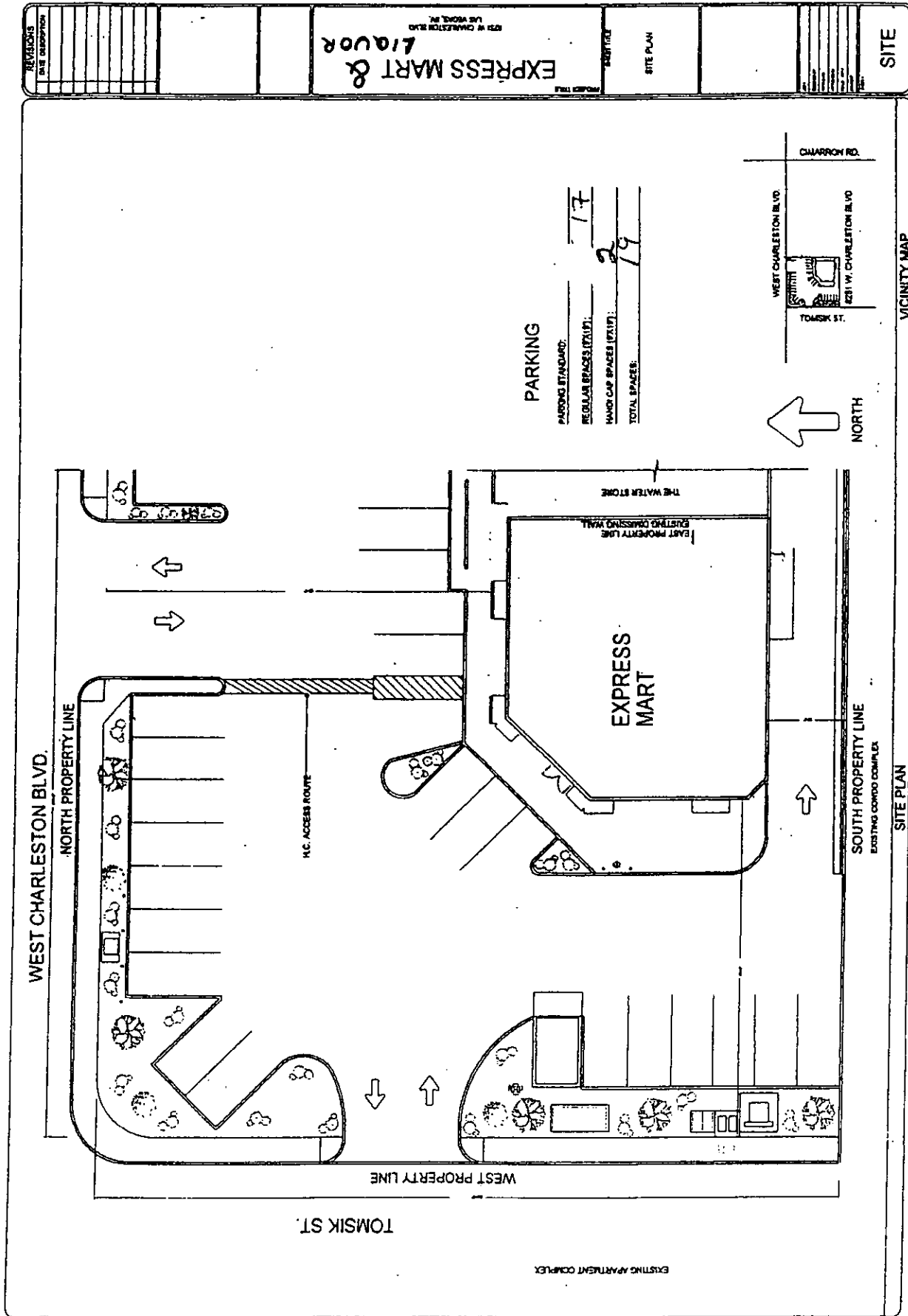

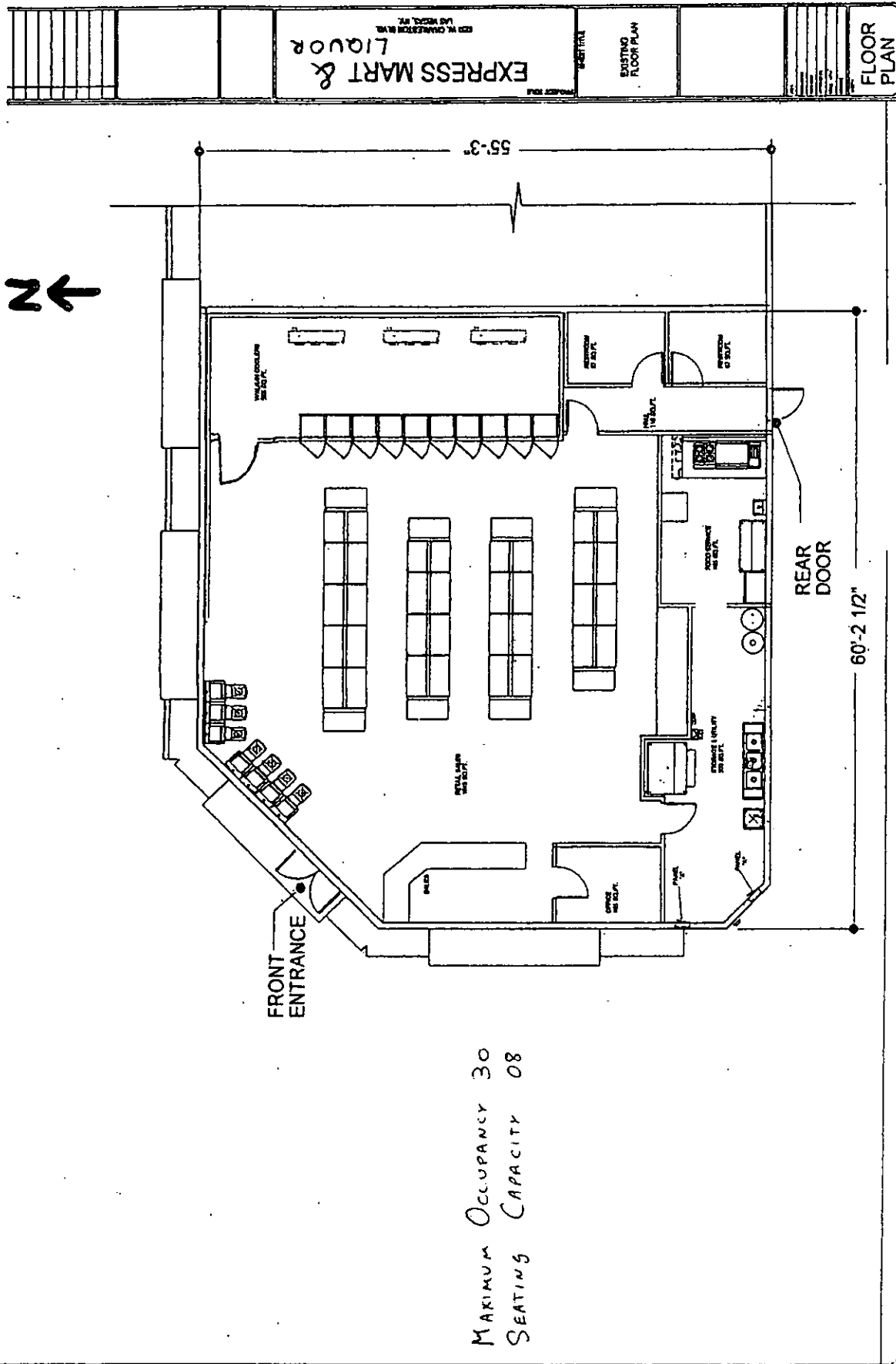
COMMENTS:
