PURPOSE/BACKGROUND:

The Planning Department is requesting funding in the amount of \$3,150.00 to hire artist Joseph Watson to design permanent sign toppers for 12 street signs and reformat existing banner images for permanent banners. This amount is based on Option 2 of the design proposal submitted by Mr. Watson (please see attached).

Temporary banners were installed on street lights in and around the historic district in 2013.

The Berkley Square Historic District is listed on the National Register of Historic Places.

If approved, staff will present draft designs to the Commission as well as the Las Vegas Ward 5 Council office for review.

FINDINGS:

The Historic Preservation Commission has \$116,239.00 available funding in the HPC Centennial Operating Fund. This project is allowable under the Public Outreach and Historical Interpretation budget items.

This estimate includes tasks to perform under contract. The estimated pricing is solely for design work and not for printing, fabrication or installation.

Items:

(Option 1) Needed: (1) Street sign design and the silhouette design of the topper.

Encompasses: Designing (1) topper image for use on the street signs. This will be a single image that will be reproduced 24 times for the purpose of applying to the double sided street signs. The custom image will be re-purposed elements from the existing banner art that I created. This newly created standard image will also include the wording "Berkley Square Historic District," along with the phrases "The First African-American Built Subdivision". This option includes color mock-ups and color variations as well as the final production art.

Estimated cost: \$950.00

(Option 2) Needed: (5) Street sign designs which includes (1) common topper design for the interior street signs and (4) unique topper designs for the entry streets signs. Also, the silhouette design of the topper.

Encompasses: Designing four unique designs for use on the entry street signs. These signs will represent a brief history of the neighborhood by re-use of the images from the banners. These images will be re-formatted into new street sign dimensions and I will create extra imagery if needed. This newly created images will also include the wording "Berkley Square Historic District," along with the phrases "The First African-American Built Subdivision". This option includes color mock-ups and color variations as well as the final production art.

Estimated cost: \$2600.00

(Option3) Needed: (12) Unique street sign designs and silhouette design of the topper. Each image will be reproduced twice as a two sided street sign topper.

Encompasses: Designing twelve unique designs for use on the street sign toppers. These signs will be generated from the re-use of existing banner art. Each of the sign toppers in this particular option will reflect a different aspect of the Berkley Square neighborhood. These newly created images will also include the wording "Berkley Square Historic District," along with the phrases "The First African-American Built Subdivision". This option includes color mock-ups and color variations as well as the final production art.

Estimated cost: \$4500.00



Needed: Permanent Banner Art.

Encompasses: Reformatting the (10) existing banner art images into approx 3'x5'. It will involve cropping and possibly creating extra added area to the images due to the cropping and newly blank spaces within the image.

Estimated cost: \$550.00
