This firm represents Warm Springs Road CVS, L.L.C., a Nevada limited liability company, doing business as CVS/pharmacy #2990 (the "Applicant"). Enclosed for processing, please find the Applicant's request to amend the SUP Approval Letter, dated November 16, 2006, in the manner stated herein. In addition, please also find the Review of Condition Application (the "Application") and our firm check in the amount of \$1,280.00 for the Application fees.

On November 15, 2006 the Las Vegas City Council approved the Applicant's request for a Special Use Permit #14687 (the "SUP") for a retail establishment with accessory package liquor sales at the above-referenced business location (the "Location"). A copy of the Original SUP Approval Letter (the "Letter") is included in the Application attached hereto. The Applicant currently operates a retail pharmacy with package liquor sales at the Location.

The original SUP contains several conditions, one of which prohibits, among other things, the sale of individual containers of "screw cap wine." Specifically, the fourth Condition (the "Condition") provides as follows:

“The sale of individual containers of any size of beer, wine coolers or screw cap wine is prohibited. All such products shall remain in their original configurations as shipped by the manufacturer. Further, no repackaging of containers into groups smaller than the original shipping container size shall be permitted.”

The Applicant hereby respectfully requests the City of Las Vegas to remove the prohibition on the sale of wine in individual screw cap containers as set forth in the foregoing Condition.

The Condition does not expressly prohibit the sale of individual containers of wine in corked containers and, therefore, makes a distinction between the type of container seal. The rationale for making this distinction stems from the traditional notion that screw cap wine is inexpensive or “cheap” and that sales of wine with screw cap bottles cause an increase in undesirable alcohol related activity and a decrease in the safety and welfare of the community.

However, due to significant changes in the wine manufacturing industry and certain deficiencies with corked wine containers, the distinction between the type of wine with screw caps and corked containers no longer exists. Today, there is essentially no difference in the price, quality, variety or nature of screw cap wine and corked wine.

During the last decade, numerous reputable wine manufacturers have replaced corked wine containers with screw cap wine containers. The reasons for this transition in the wine industry include, without limitation, the following:

- 1) Screw cap containers have a decreased impact on the environment. During the last decade there has been an increased demand for wine and a decrease in the supply of cork. Cork itself is processed from the bark of the cork tree, which is principally found in the western Mediterranean region of Europe. Obtaining cork involves harvesting cork from cork trees. As such, screw cap containers are an “environmentally friendly” alternative to cork as they have lessened the demand for cork harvesting.
- 2) Cork has been known to adversely affect the taste of wine, thus, leading wine makers away from cork to screw cap containers.
- 3) Screw cap containers provide a superior seal, thus eliminating the estimated fifteen percent (15%) fail rate of wine contained in corked containers.¹

Examples of fine wine bottled with screw caps include Argyle Nuthouse Pinot Noir 2006 (\$47.00 per bottle), Henschke Hill of Grace Shiraz 2004 (\$529.00 per bottle), D'Arenberg Coppermine Road Cabernet Sauvignon 2004 (\$47.99 per bottle) and Alma Rosa El Jabali Vineyard Chardonnay 2007 (\$26.99 per bottle).

In sum, the distinction between corked containers and screw cap containers of wine is no longer applicable to the wine industry and there is no benefit to the public by regulating or restricting the sale of bottles of wine with screw caps. As such, the Applicant respectfully requests the City of Las Vegas to amend the Condition in the existing SUP to remove the prohibition on sales of single containers of screw cap wine.

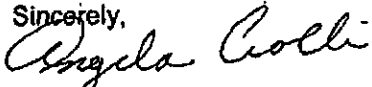
