ITEM DESCRIPTION: Consideration of HPC Centennial Legacy funding request not to exceed \$1,000.00 for bronze plaque commemorating Woodlawn Cemetery and Veteran's Memorial Circle and costs for installation in the public right-of-way at Woodlawn Cemetery, 1500 Las Vegas Boulevard North, (APN 139-26-101-003), C-V (Civic) Zone, Ward 5 (Barlow).

BACKGROUND

02/27/08 HPC approved Centennial project budget and timeline.

ANALYSIS

The city of Las Vegas is requesting approval of HPC Centennial Legacy funding request not to exceed \$1,000.00 for a bronze plaque commemorating Woodlawn Cemetery and Veteran's Memorial Circle to be located near the entrance of Woodlawn Cemetery on Las Vegas Boulevard.

Staff has received four quotes from the following companies:

Plaques and Letters: \$313.00 for a 12" x 8" plaque, shipping quoted upon order.

Franklin Bronze Plaques: \$411.00 for a 14" x 14" plaque, shipping quoted upon order.

The Bronze Plaque: \$635.00 for a 24" x 6" plaque, free shipping.

Erie Landmark: \$816.00 for an 18" x 18" plaque, \$55.00 shipping.
\$204.00 for a 9" x 9" plaque, \$23.00 shipping.

City of Las Vegas Field Operations Department
Installation: \$500.00

Staff recommends the following text:

Woodlawn Cemetery 1914

Opened in 1914 on ten acres of donated land, the cemetery was the unofficial veteran's cemetery until 1989 and is the home of Veteran's Memorial Circle.

Woodlawn Cemetery is listed on the National Register of Historic Places.

The HPC has \$20,689.38 available in operating costs for the HPC Centennial Legacy Fund.

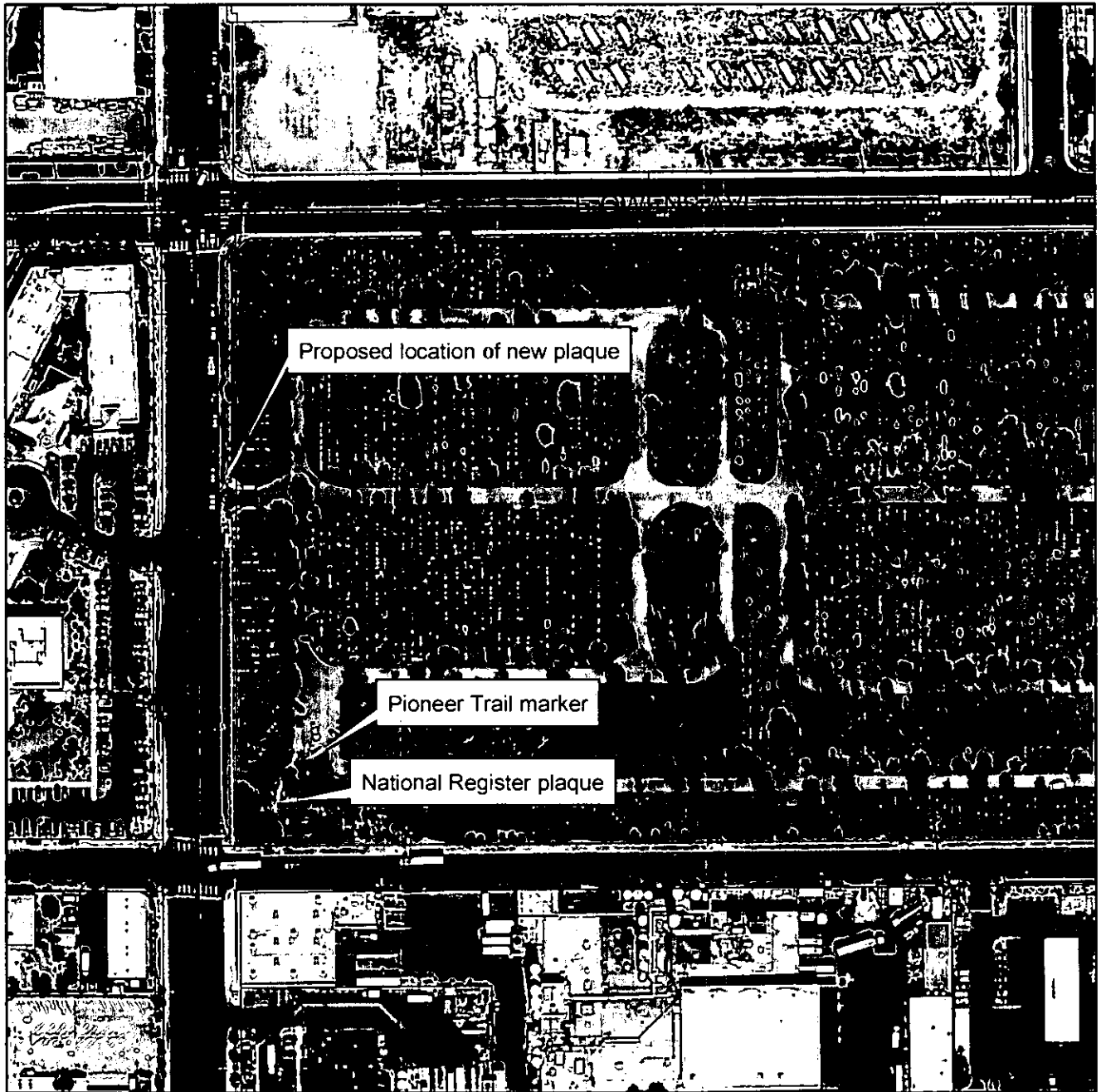
