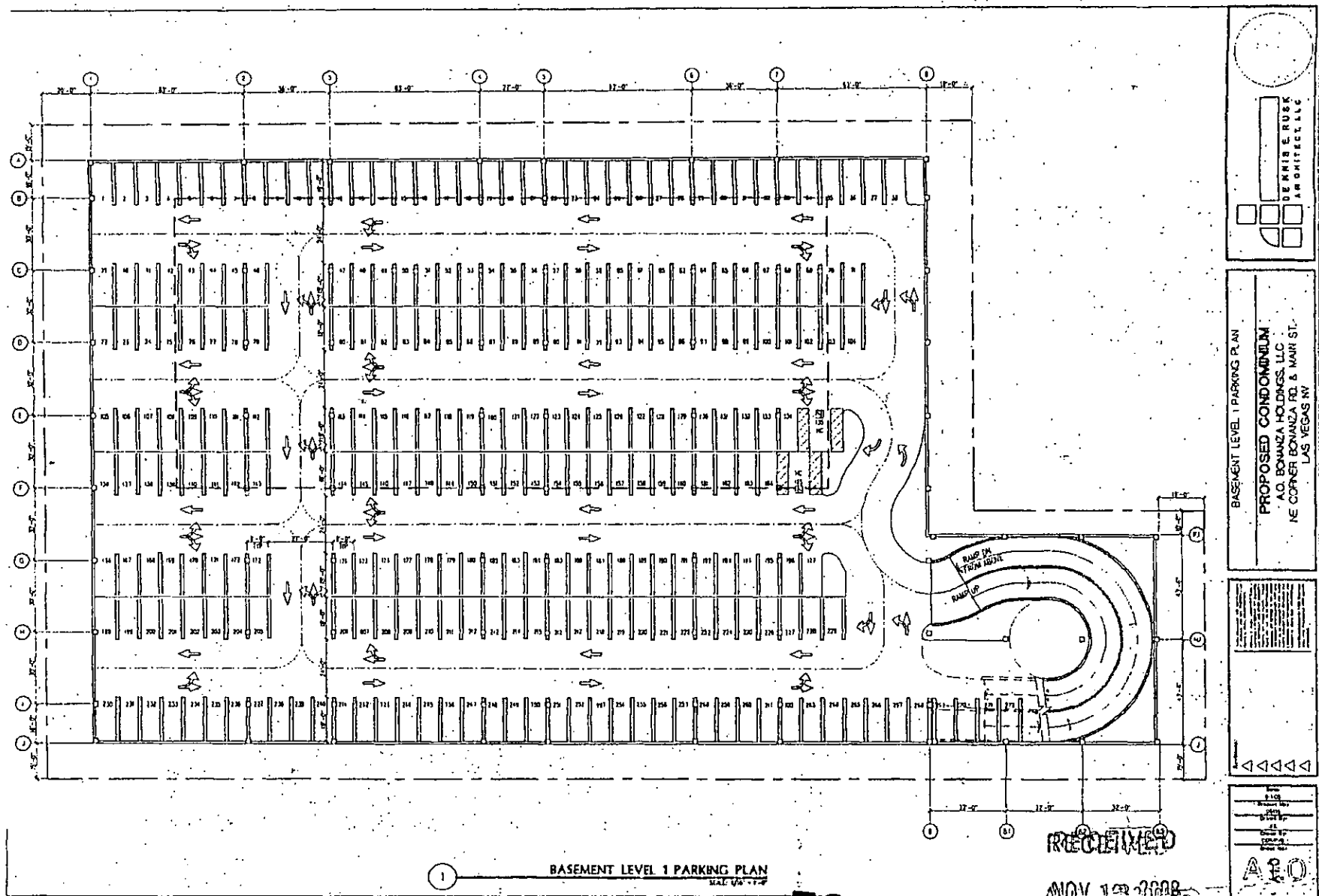


BASEMENT LEVEL 1 PARKING PLAN

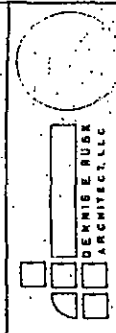
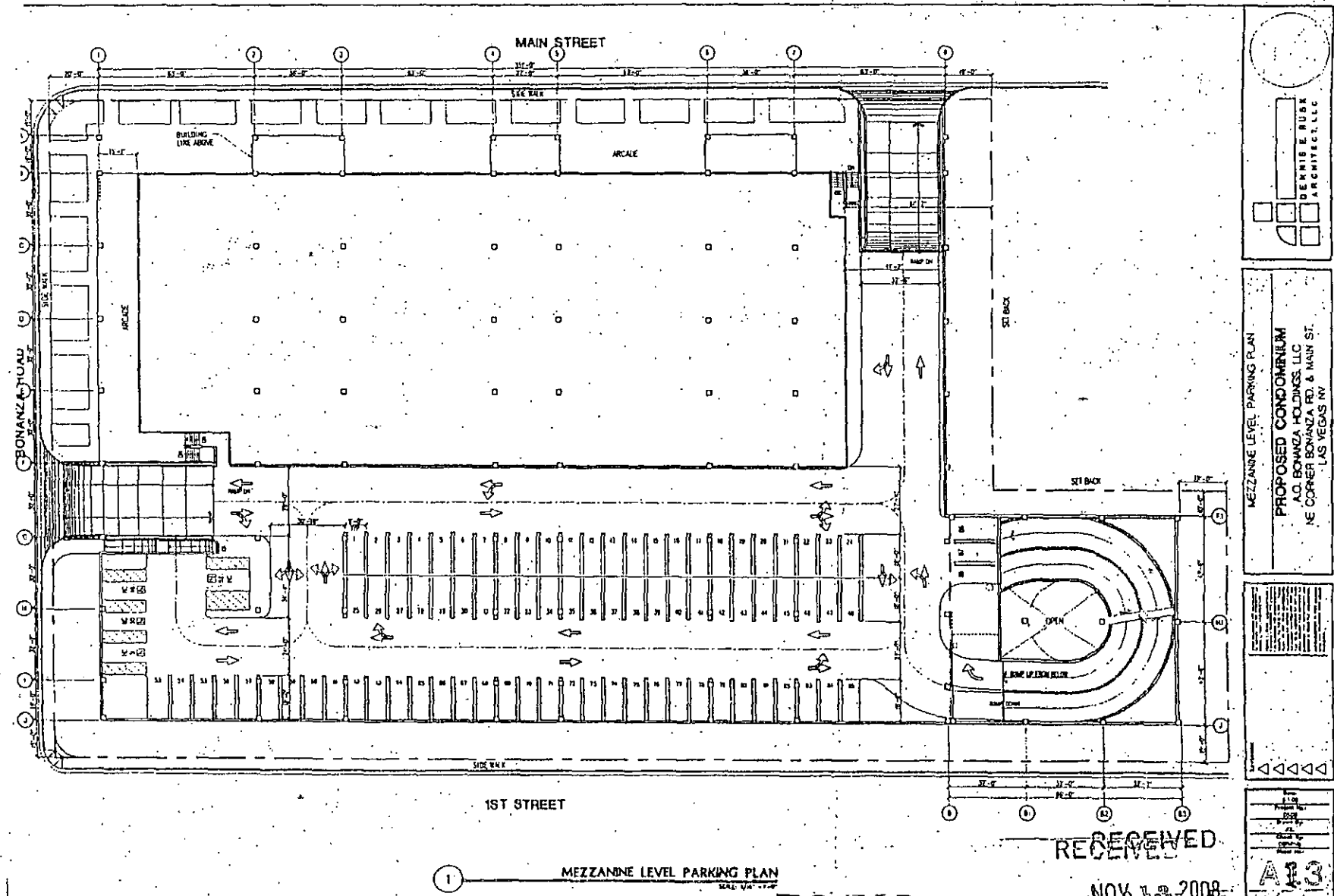
MALL FLOOR PLAN & BASEMENT LEVEL 3 PARKING PLAN

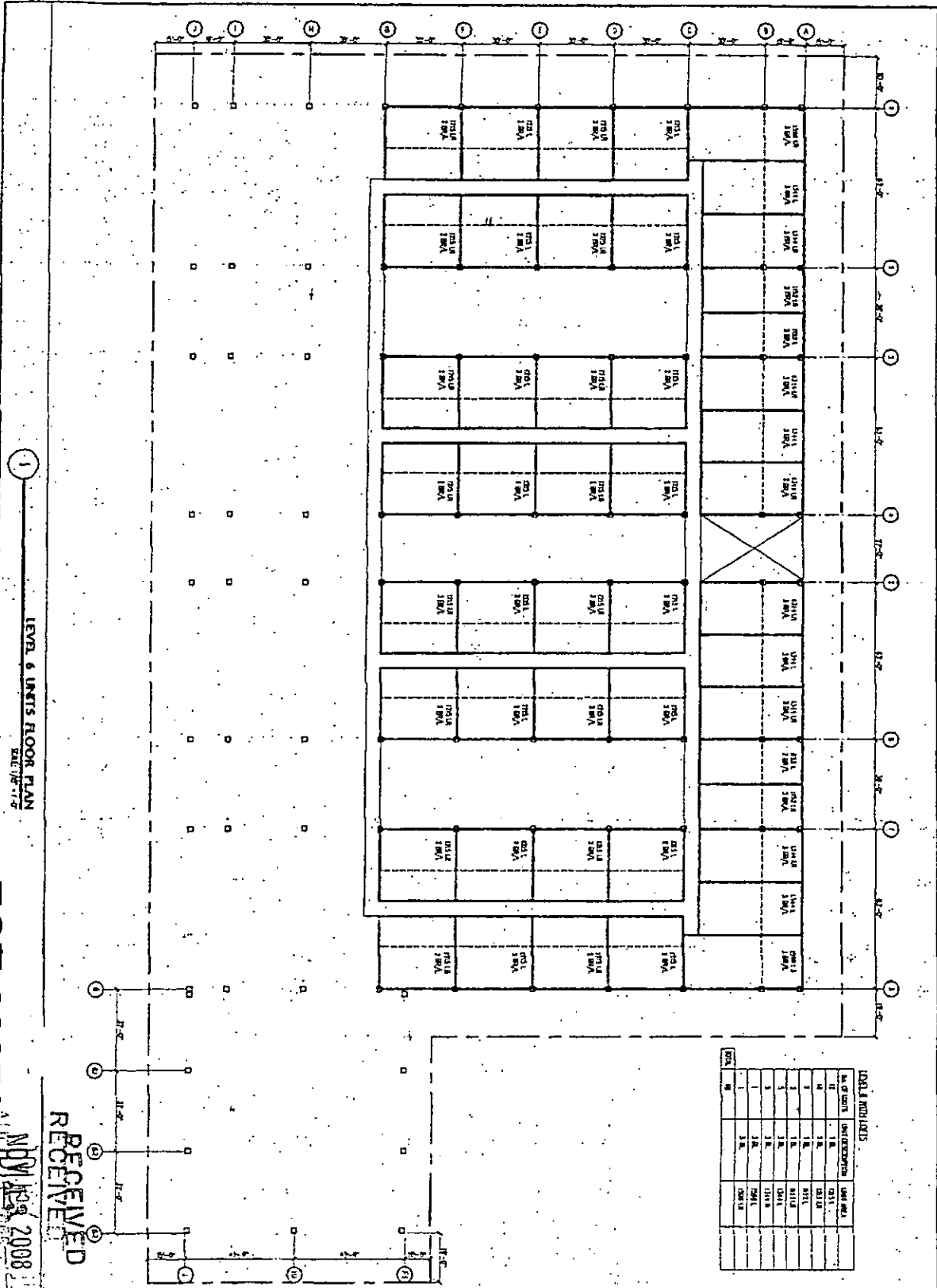
LEVEL 5 UNITS FLOOR PLAN

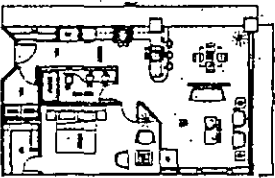

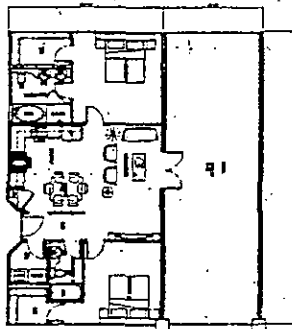
UNIT 912 (1 BR)

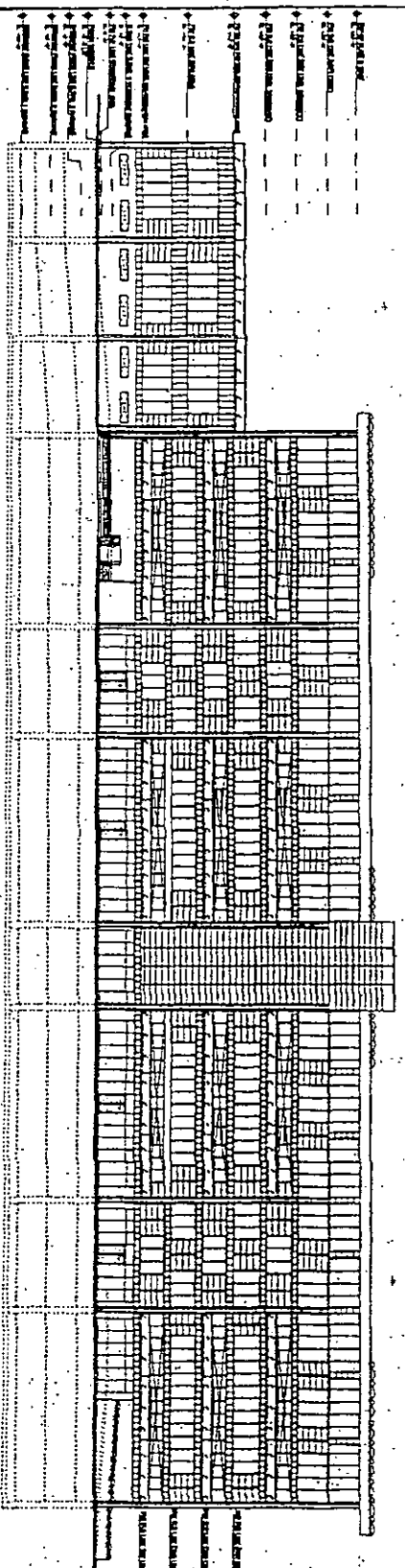

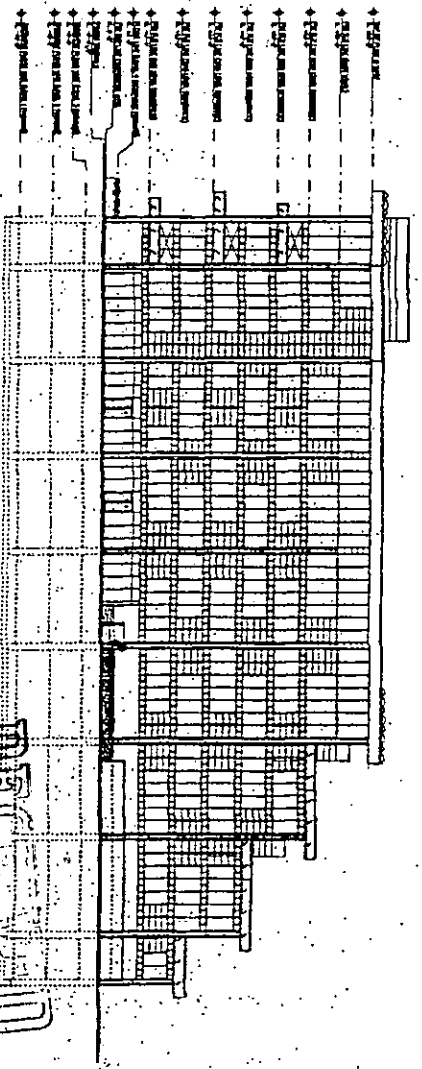

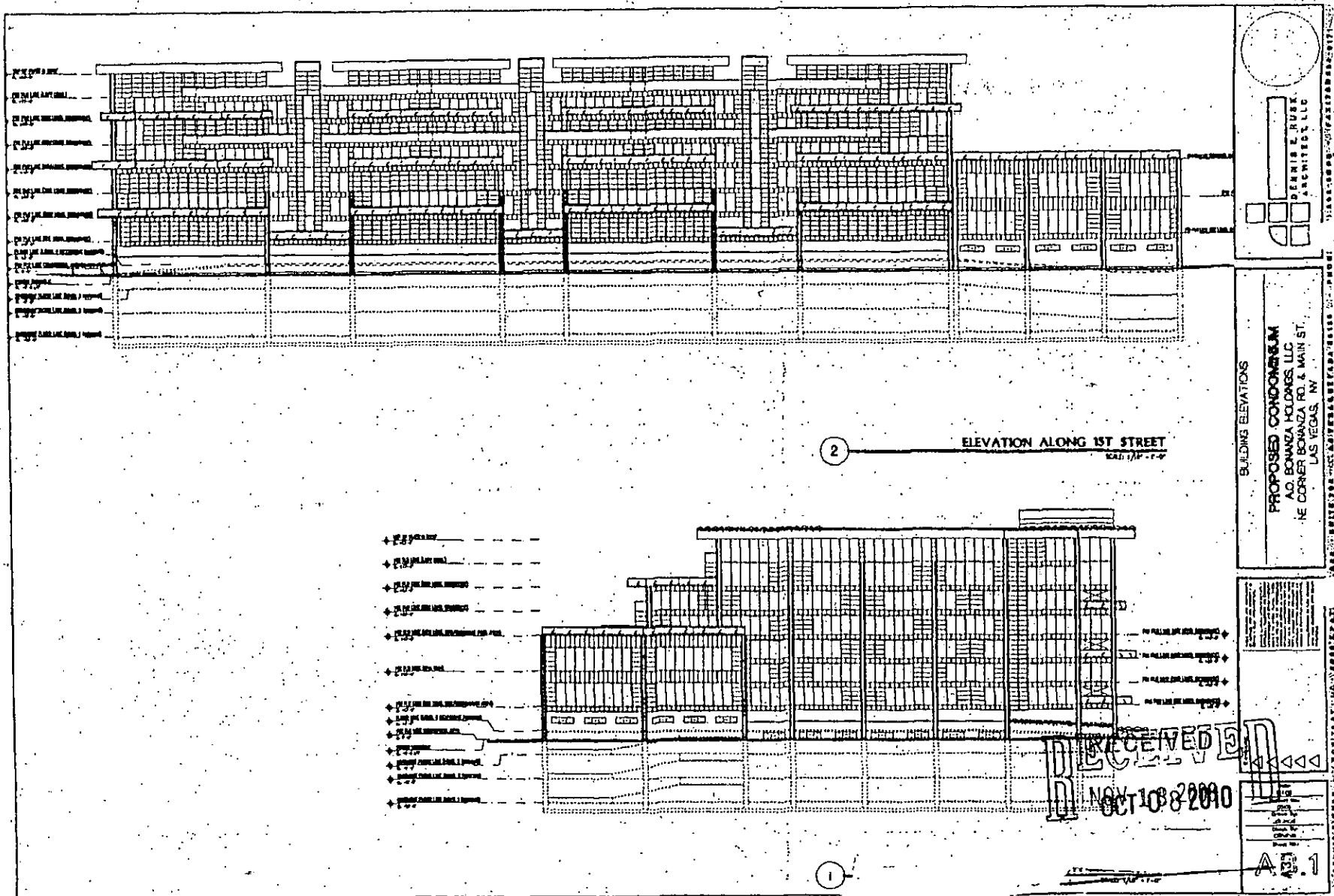


ELEVATION 1
