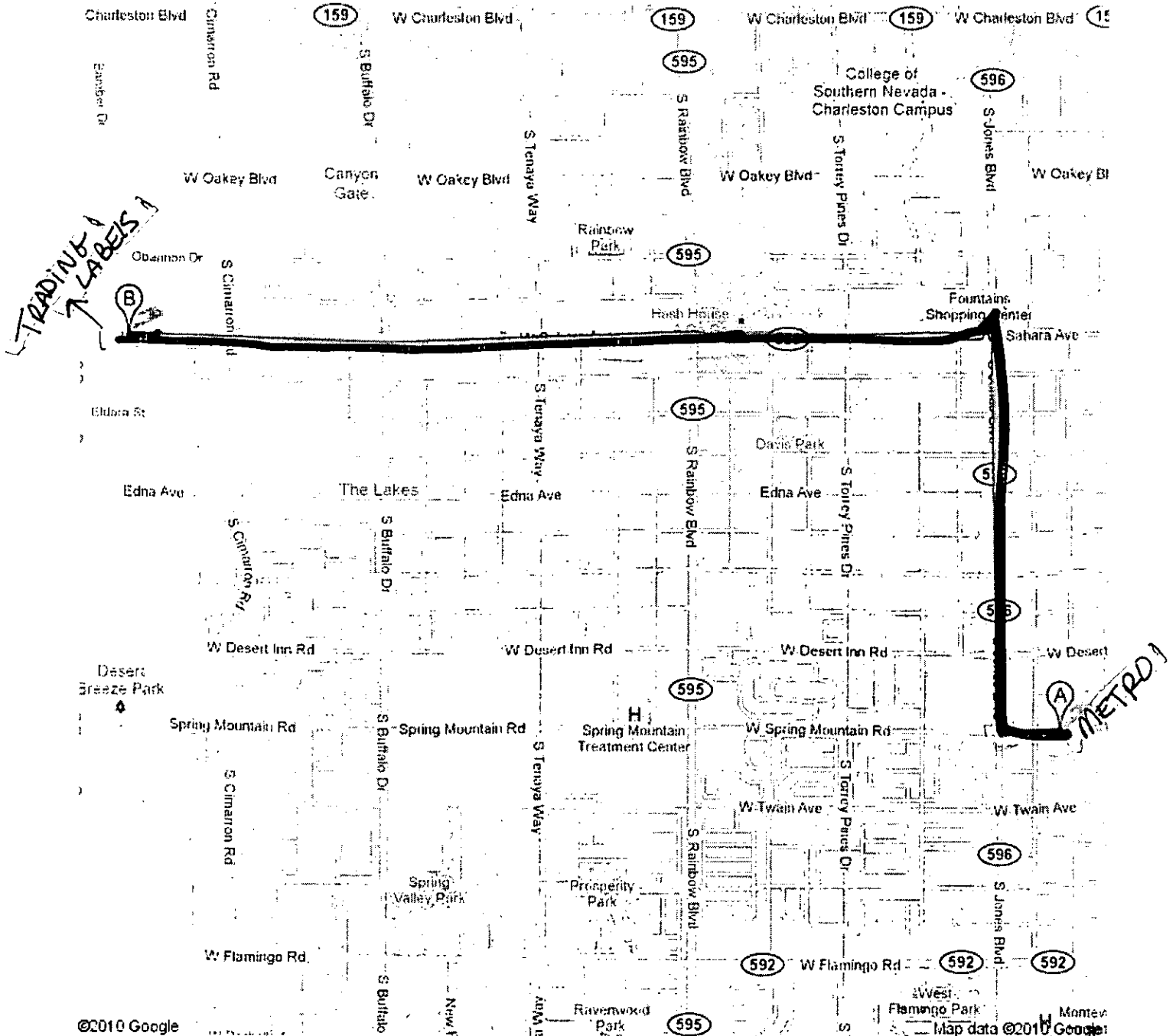

MEDICAL EMERGENCY SERVICES MAP

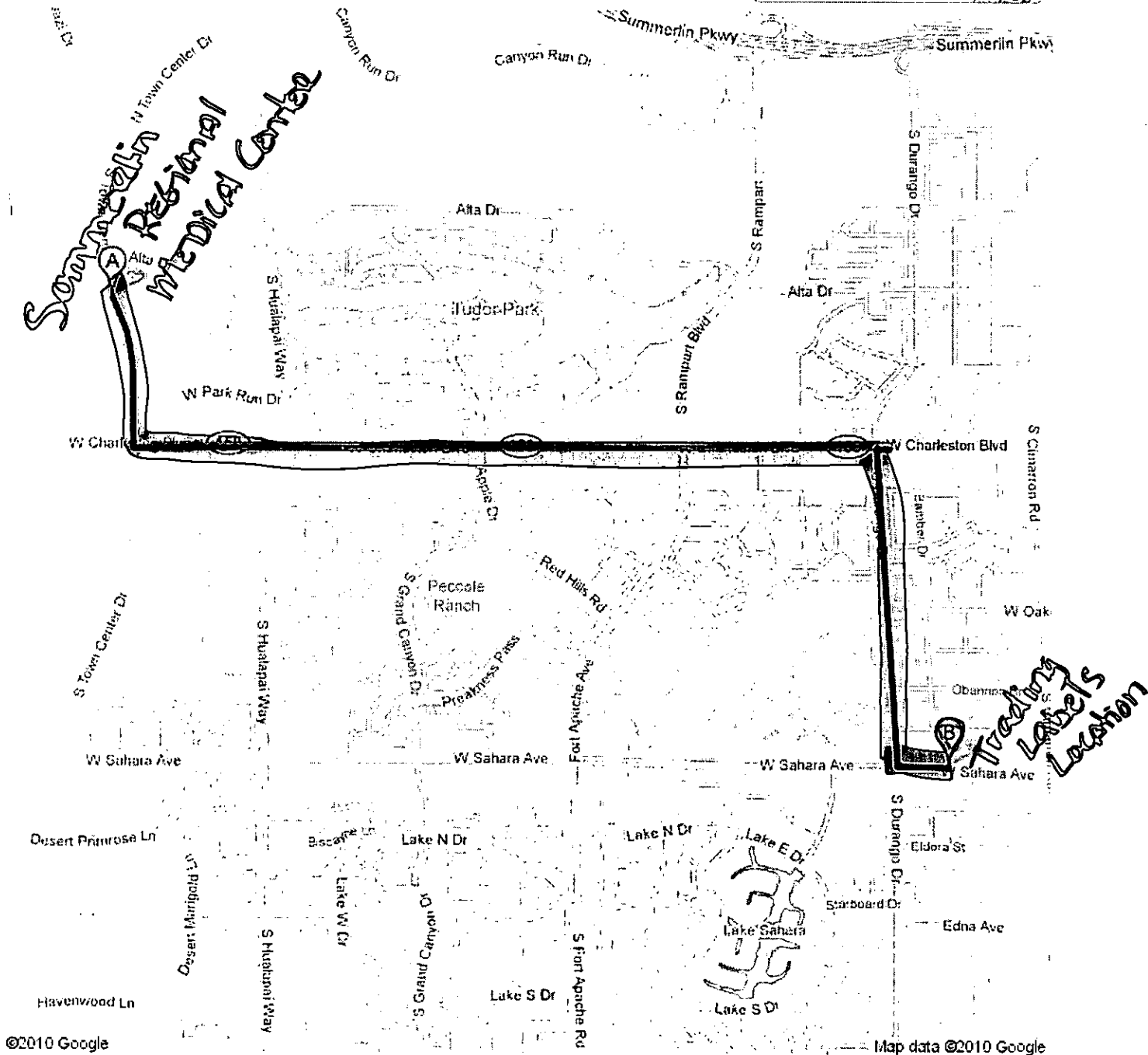

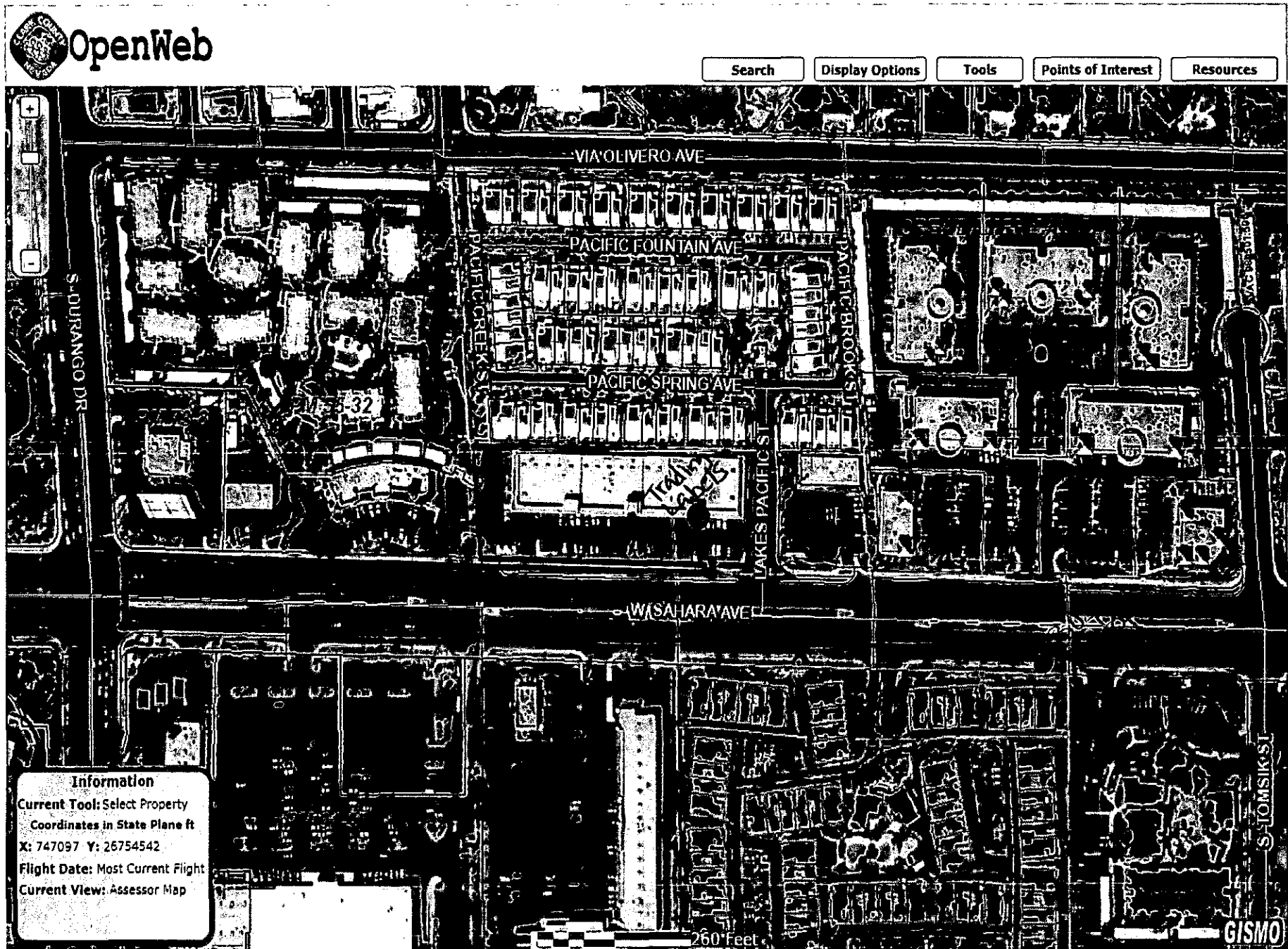
