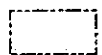

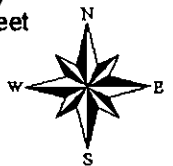

to subject location



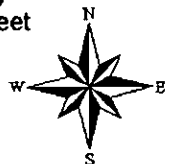

 Possible primary route from Fire Station 15 to subject location



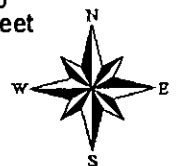

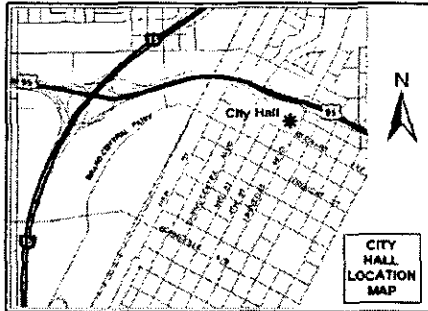

Dear City of Las Vegas:

Future Smiles is a new school-based oral health program that focuses on preventive oral health care to help address the staggering oral health needs of Nevada's most vulnerable children. Our services target uninsured/underserved, low-income, at-risk children (who would not otherwise see a dental professional) while the children are in school removing barriers that limit access to dental providers. In 2009-2010 we began our first school-based site at Cynthia Cunningham Elementary and through funding from United Way we will be expanding the program to Reynaldo Martinez Elementary and Clark High School.

While we are school-based and intend to see eligible children from Clark High School our doors are also open to any Clark County child who meets are criteria of need (uninsured/underserved) and low-income. At Clark High School we intend to operate the clinic with 2 dental hygienists and one administrative person for a total of 20-30 hours a week. The program operates with grant dollars and donations therefore if funding is limited the hours will be reduced.

Future Smiles' 2010-2011 goals include: (1) providing 1,200 children with oral health education and screenings, (2) 2,400 dental sealants, (3) 1,150 fluoride varnish/topical applications, and (4) 500 dental cleanings (prophylaxis). Our program works diligently to be a dental home for children, and to provide ongoing care. About 60% of Future Smiles' children in our 2009-10 school year returned for services at least once. Future Smiles is very proud of this percentage especially given the high transiency rate of our target population.

Furthermore, Future Smiles is pursuing a blend of funding opportunities at the programmatic level. These funding sources include grants from foundations and associations, donations from dental associations, coalitions, funding through small fundraisers and funding from Medicaid. Medicaid covers approximately 18-25% of the children we serve. Our goal is to receive funding from multiple sources and types of organizations, helping to ensure the program's sustainability.

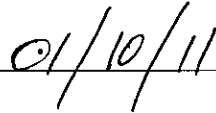

Our services target uninsured/underserved, low-income, at-risk children (who would not otherwise see a dental professional) while the children are in school removing barriers that limit access to dental providers. In 2009-2010 we began our first school-based site at Cynthia Cunningham Elementary and through funding from United Way we will be expanding the program to Reynaldo Martinez Elementary and Clark High School. While we are school-based and intend to see eligible children from Clark High School our doors are also open to any Clark County child who meets the criteria of need (uninsured/underserved) and low-income. At Clark High School we intend to operate the clinic with 2 dental hygienists and one administrative person for a total of 20-30 hours a week. The program operates with grant dollars and donations therefore if funding is limited the hours will be reduced. The operation will be located within an existing modular structure located on the school grounds. No site changes are proposed as part of the request.

**MEMORANDUM OF UNDERSTANDING
BETWEEN
FUTURE SMILES

ED W. CLARK HIGH SCHOOL**

This Memorandum of Understanding (hereafter referred to as "MOU") is made and entered into this _____ day of _____, 201____, by and between the City of Las Vegas, a municipal corporation of the State of Nevada (hereafter referred to as "City"), the Clark County School District, a political subdivision of the State of Nevada (hereafter referred to as "District") and Future Smiles, a domestic non-profit organization (hereafter referred to as Future Smiles). The City, District and Future Smiles may be individually referred to as "Party" or collectively referred to herein as the "Parties."

RECITALS

WHEREAS, the District is the owner of that real property and improvements located at 4291 Pennwood Avenue, Las Vegas, Nevada, 89102, APN# 162-07-701-001, more commonly known as Ed W. Clark High School, (hereafter referred to as "Premises"), (see Exhibit "A" attached hereto and made a part of); and

WHEREAS, the City is the owner of a modular facility (hereafter referred to as "Modular") that was placed on "Premises" pursuant to a MOU dated May 8, 2007 by and between the City and the District for operation of the Clark Community School Program in order to provide community services; and

WHEREAS, it has been determined by the City that the Clark Community School Program is no longer in operation; and

WHEREAS, the City has requested to utilize the Modular for the operation of a non-profit dental health service program operated by Future Smiles in order to provide preventive pediatric dental health care services.

NOW, THEREFORE, and in consideration of the mutual terms, conditions, and covenants set forth below, the Parties agree to the following:

1. **Purpose.** This MOU is being created for the purposes of granting the City and Future Smiles permission and authority to enter upon the Premises, and sets forth the respective obligations of the Parties in regards to maintenance and operation of the Modular.
2. **Authorization.** The City and Future Smiles are hereby authorized to enter upon the Premises and maintain thereon the Modular that is to be utilized for preventive pediatric health care services. District will also permit the City and Future Smiles access to District property, as needed, in order to repair the Modular or conduct improvements on or in the Modular.
3. **Term.** This MOU and the authorization provided herein shall be for a period of five (5) years (hereinafter referred to as "Initial Term"), and shall commence after approval by the governing bodies of

the City and District. The official commencement date shall be the date of the latest signing by an authorized representative of the governing bodies of the City and District hereto.

This MOU has the option of renewing for two (2) additional periods of five (5) years upon approval of the governing bodies of the City and District. If upon termination of this MOU, the City will remove the Modular from the Premises, and return the Premises to its original condition, reasonable wear and tear expected.

4. **Termination.** The City or District may terminate this MOU without cause with written notice. Such termination shall become effective sixty (60) calendar days after written notice is served by the terminating Party on the other Party pursuant to Section 11 Notices.

5. **Use.** The Parties desires that Future Smiles develop a preventive pediatric dental health care program for the oral health of children. An example of these services shall include but not be limited to:

- a. Oral hygiene education
- b. Child prophylaxis
- c. Sealants
- d. Fluoride varnish
- e. Children with oral health needs will be referred to community dental clinics that have agreed to partner with Future Smiles

The City and Future Smiles agree not to assign this MOU, sublet the Modular, use or permit the Modular to be used for any purpose other than that described in this MOU, except with the prior written consent and approval of the District. Any such assignment or delegation made without the required consent shall be void, and result in the termination of this MOU.

The City and Future Smiles agree not to allow any liens, mortgages or encumbrances to be placed against the Modular or the Premises during the term of the MOU without the written consent and approval of the District, whose consent shall not be unreasonably withheld.

6. **Maintenance and Repairs.** Future Smiles shall maintain the Modular and every part thereof in a clean, neat, and orderly condition, free of objectionable noise, odors, or nuisance and will in all respects and at all times fully comply with health, safety, and police regulations including all laws, regulations statutes or codes concerning the use, storage, or maintenance of hazardous material in the Modular or on the Premises. Future Smiles shall fully fund the operation of the Modular and be responsible for maintenance and custodial care. The City will be responsible for the all expenses associated with major repairs to the modular building due to wear and tear.

7. **Utilities.** Future Smiles shall fully and promptly pay all water, gas, heat, power, and other public utilities of every kind associated with the Modular. The District shall have no responsibility of any kind for payment of any such utilities. Payment of utilities will be coordinated with the District's Facilities' Division's Energy Conservation Department.

8. **Compliance with Federal, State and Local Laws.** Future Smiles shall obtain and maintain as current any and all federal, state, and local permits and licenses, including required professional licenses, required to operate the Modular as a dental office as described in this MOU. Future Smiles further agrees to abide by all applicable federal, state, and local codes regulations, statues, ordinances, and laws, now in force or which hereafter may be in force with respect to the Modular. Future Smiles also agrees to comply with all District standards.

9. **Insurance.** -Future Smiles shall be responsible for providing and maintaining the following insurance coverage's in force for the life of this MOU. The insurance company(ies) must have an A. M. Best rating of A or better and be licensed to write such insurance in the State of Nevada. Future Smiles shall provide to the District and City prior to commencement of this agreement, certificate(s) of insurance verifying required coverage. The insurance carrier shall give the District and City a thirty (30) calendar day written advance notice of any termination, expiration, or any and all changes in the coverage. Deductibles and self-insurance retentions shall be declared in the certificate(s) of insurance. All deductibles/retentions are the sole responsibility of Future Smiles.

Certificate(s) shall evidence the following coverage:

- A. Commercial General Liability Insurance, including contractual liability in accordance with the indemnification requirements in this agreement, and including bodily injury, personal injury, and property damage, with the limits of at least \$3,000,000 per occurrence. The general liability insurance shall include coverage for molestation, sexual abuse and corporal punishment, and shall name the Clark County School District and the City of Las Vegas as additional insured.
- B. Professional Liability in an amount no less than \$1,000,000 covering the professional liability of the individual dentists and their staffs in performance of this contract.
- C. Statutory Workers' Compensation and Employers Liability in an amount no less than \$1 million, including a waiver of subrogation in favor of District and City.
- D. Evidence of Property insurance in an amount sufficient to cover loss of real and personal property belonging to Future Smiles, including a waiver of subrogation in favor of District and City.

The insurance may be provided under primary policies or by a combination of primary and excess policies.

10. **Indemnity.** Future Smiles, on behalf of itself and its participating dentists and their staff agrees to protect, defend, indemnify, save and hold harmless the District and the City, their governing board, its agents, officers, and employees and assume all costs, expenses, and liabilities of any nature to which these parties may be subjected as a result of any claim, demand, action, or cause of action arising out of the activities involving this MOU.

This MOU is being written and is approved at no risk to District. District shall not be liable for any loss, injury, death, or damage to persons or property which at any time may be suffered or sustained by any parties to this contract, or by any person who may at any time be using or occupying or visiting the Modular, or be in, on or about the Modular, whether the loss, injury, death or damage shall be caused by or in any way result from or arise out of any act, omission or negligence of Future Smiles or of any occupant, visitor, or use of any portion of the Modular. Future Smiles shall protect, defend, indemnify and hold District harmless against any and all claims, liability, loss or damage on account of any such loss, injury, death or damage arising from or related to operations of Future Smiles and/or the Modular during the term of the Agreement.

District makes no warranty as to the suitability or safety of the site for the uses intended herein, and Future Smiles assumes all liability and responsibility for their use of said premises, and accepts premises "as is". Future Smiles hereby agrees to protect, defend all claims, indemnify and hold the District harmless from and against any and all liability (including attorney's fees and costs) which District may incur by reason of use of the facilities by or conduct of operations by Future Smiles or its agents, including injury arising by reason of a dangerous and defective condition of the improvements hereon.

11. **Notices.** All legal notices required pursuant to this MOU shall be in writing. Any notice required to be given under the terms of this MOU shall be deemed to have been given when, (i) received by the Party to whom it is directed by hand delivery or personal service, (ii) sent by U.S. mail via certified mail-return receipt requested at the following addresses:

12. **Alterations, Additions, and Improvements.** At any time during the term of this MOU, Future Smiles, subject to the prior written approval of the District and City and at the sole expense of Future Smiles, may make alterations, additions, and/or improvements in and to the Modular only. Any such alterations, additions and/or improvements shall be performed in a workmanlike manner, in accordance with all applicable governmental regulations and requirements, and shall not weaken or impair the structural strength or lessen the value of the modular building.

13. **Modification and/or Amendments.** No amendments, changes and/or modifications of this MOU shall be valid unless in writing and signed by all Parties. If any provision of this MOU is held by a court of competent jurisdiction to be invalid, void or unenforceable for whatever reason, the remaining provisions not so declared shall, nevertheless, continue in full force and effect, without being impaired in any manner whatsoever.

14. **Counterparts; Electronic Delivery.** This MOU may be executed in counterparts, all such counterparts will constitute the same MOU and the signature of any Party to any counterpart will be deemed a signature to, and may be appended to, any other counterpart. Executed copies hereof may be delivered by facsimile or e-mail and upon receipt will be deemed originals and binding upon the Parties hereto, regardless of whether originals are delivered thereafter.

15. **General Conditions.** The laws of the State of Nevada will govern as to the interpretation, validity and effect of this MOU. This MOU is intended only to benefit the Parties hereto and does not create any rights, benefits or causes of action for any other person, entity or member of the general public.

The Parties are associated with each other only for the purposes and to the extent set forth in this MOU, and in respect to performance of services pursuant to this MOU, the Parties are and shall be a separate and distinct from each other. Nothing contained in this MOU shall be deemed or construed to create a partnership or joint venture, to create relationships of an employer-employee or principal-agent or to otherwise create any liability for one agency whatsoever with respect to the indebtedness, liabilities, and obligations of the other agency or any other.

Pursuant to NRS 239.010, information or documents in connection with this MOU may be open to public inspection and copying. The Parties will have the duty to disclose unless a particular record is confidential by law or a common law balancing of interests.

Should any part of this MOU be rendered void, invalid, or unenforceable by any court of law, for any reason, such determination shall not render void, invalid, or unenforceable, under any other part of this MOU. Each Party, or responsible representative thereof, has read this MOU and understands the

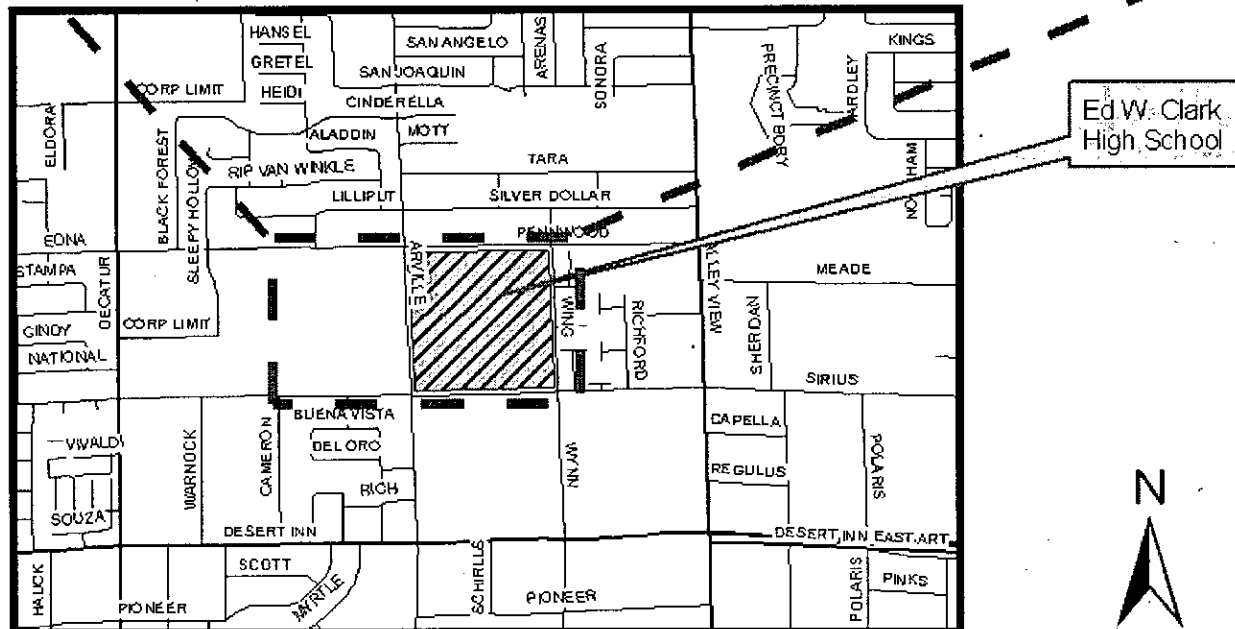
