working in her store for 2 weeks prior to opening. I feel that due to todays economy, a resale store is one that will likely succeed and prosper.

Finding an area that will allow a "Thrift Store" (Consignment Store) has been very difficult in the North West area of the Valley. Realtors are reluctant to extend a contingency clause and want their monies up front. I have found someone who will extend the clause and in fact is giving me 3 months free rent, maybe 4, and will not start the lease until the day the "Special Use Permit"/Business license is received. I have negotiated \$1.34 a square foot, which includes cams. This will be for a three year lease with a 2 year option. In my opinion, it doesn't get much better than this!

I am very excited to start this new chapter of my life.

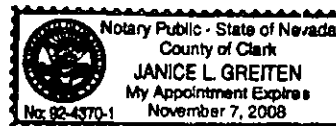

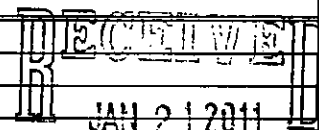
