At the regular meeting held October 18, 2006, the Las Vegas City Council approved a Special Use Permit – 13271 for retail package liquor off-sale at 8251 W. Charleston Blvd, Las Vegas, NV 89117. However, there were certain restriction added to the above mentioned special use permit, copy included.

The current owner, Brownmail, Inc., requests the city council to remove “Added Condition A” limiting the business in hours of operation. The owner plans to convert the current business from an independent operator to a 7 Eleven franchise business. One the requirements of the franchisor are the store is operational 24 hrs a day year round.

We further request that condition number six under “Planning and Development” stating “the sale of individual containers of any size of beer, wine coolers or screw cap wine” be removed as it unnecessarily put an unfair financial burden on the business. We request the City Council allow the sale of any size individual sale of beer cans and bottles including, 40 oz, 32 oz, 24 oz, 16 oz, and 12 oz cans and or bottles, as well as allow the sale of wine coolers or screw cap wine of any sizes.

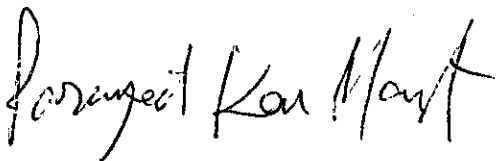
