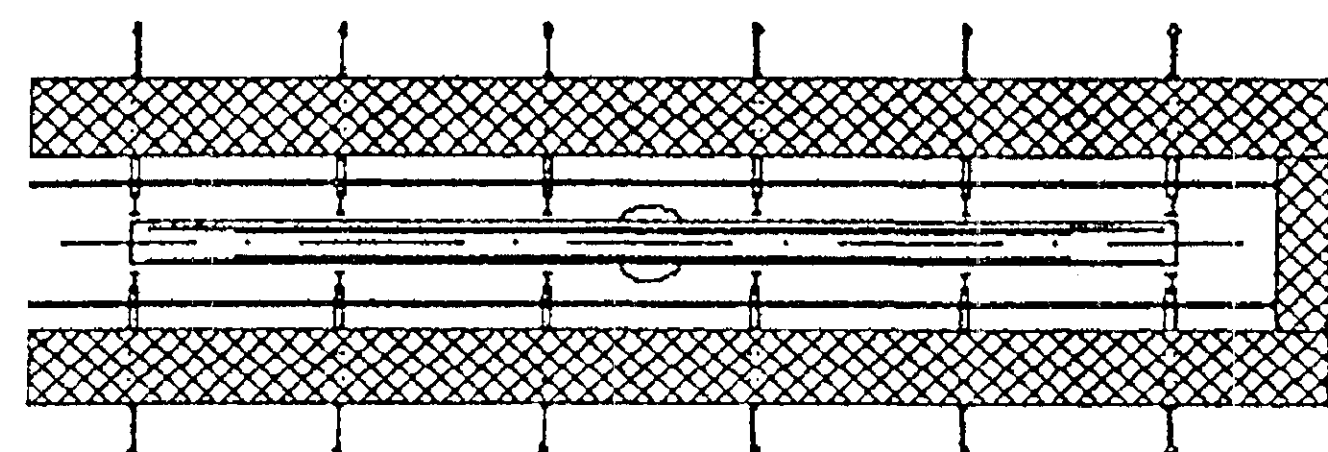
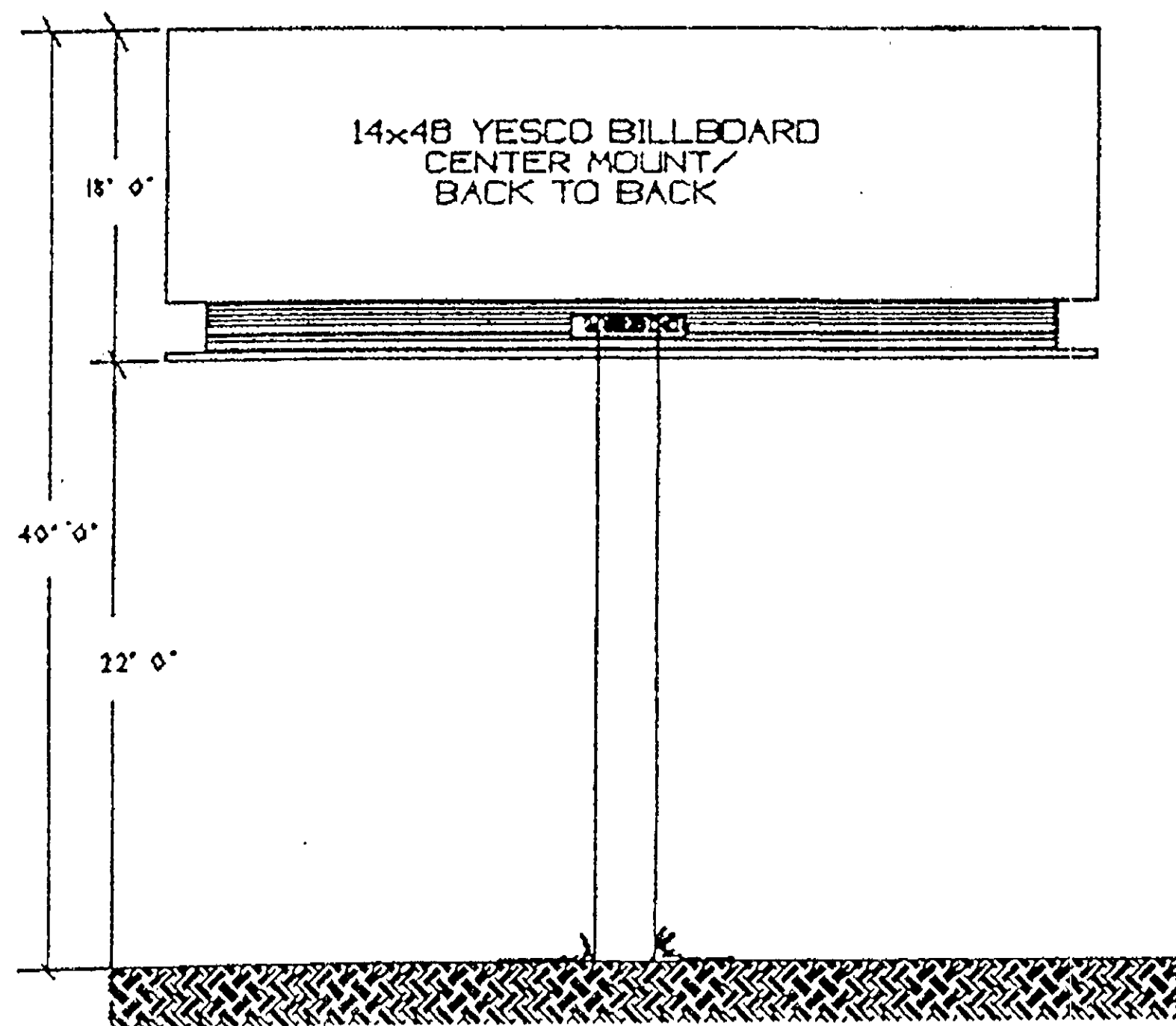

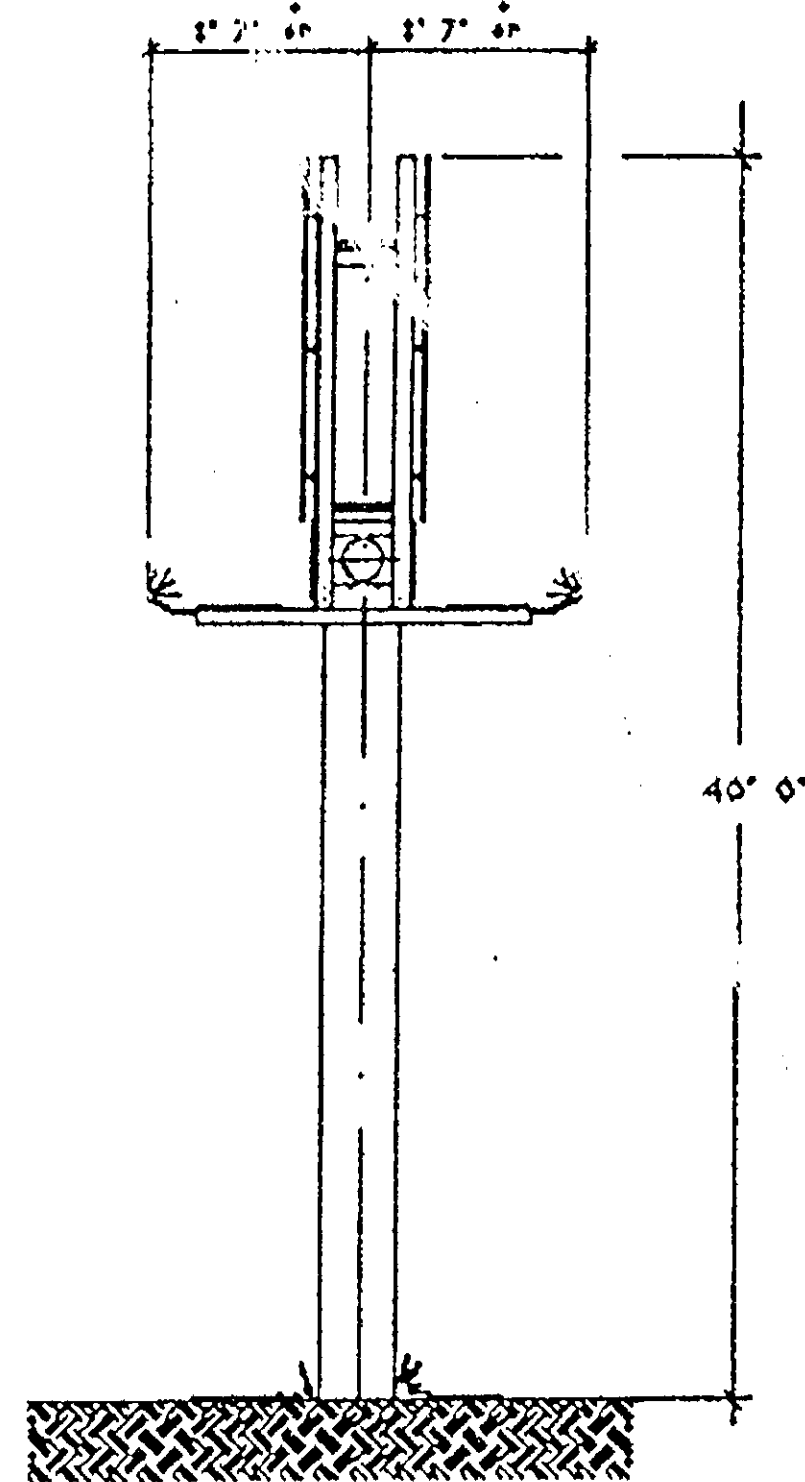


PLAN VIEW



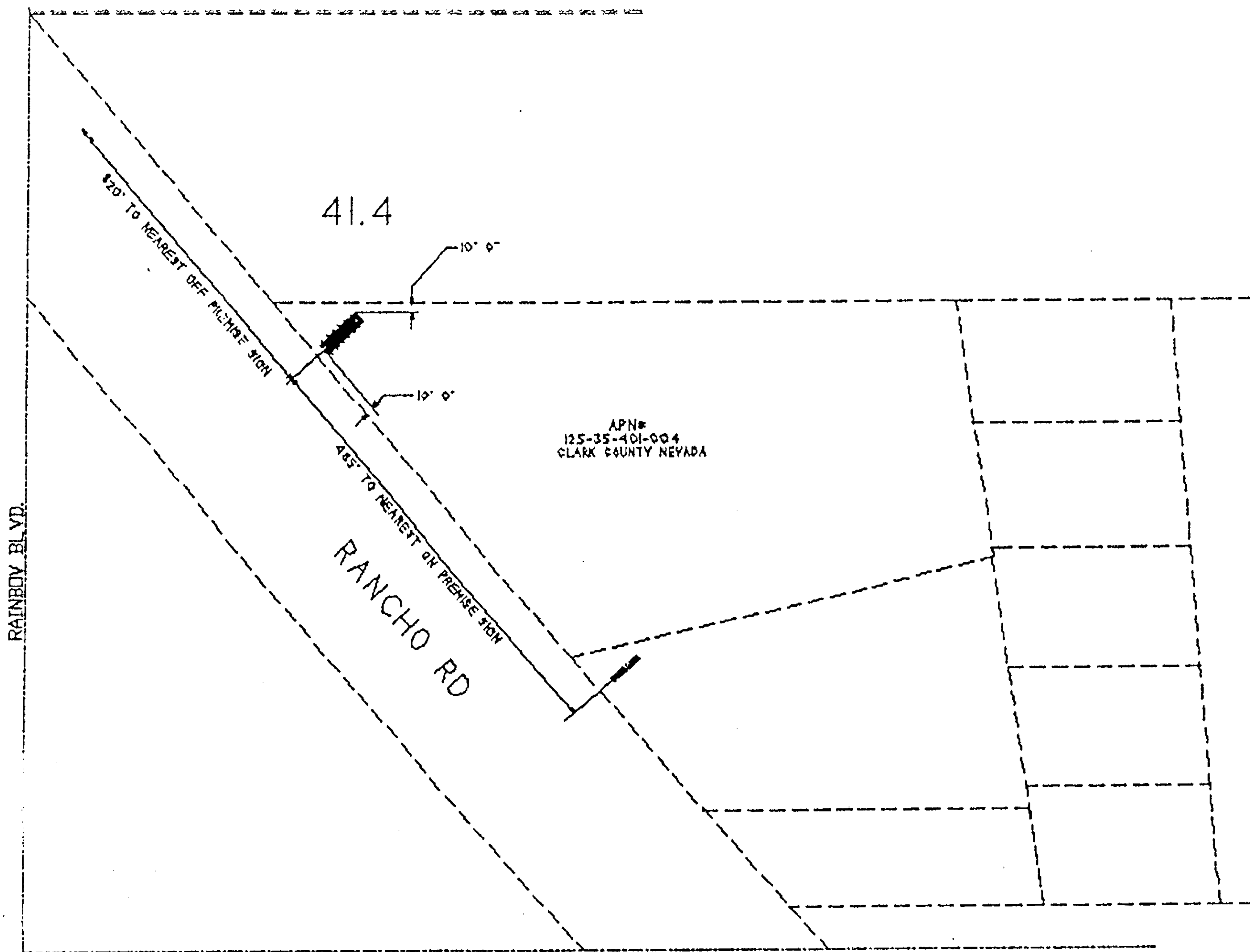
SIGN ELEVATION

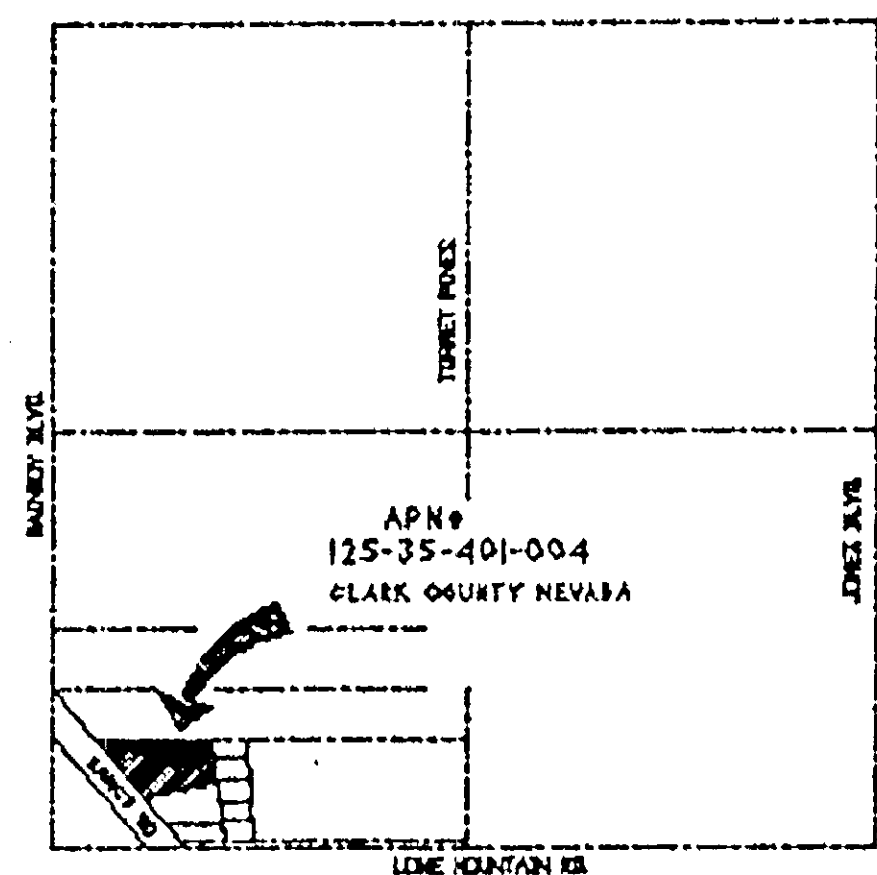
SIDE ELEVATION

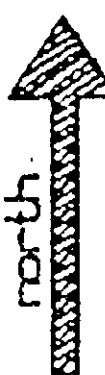
SITE PLAN

SCALE 1" = 1/4 MILE



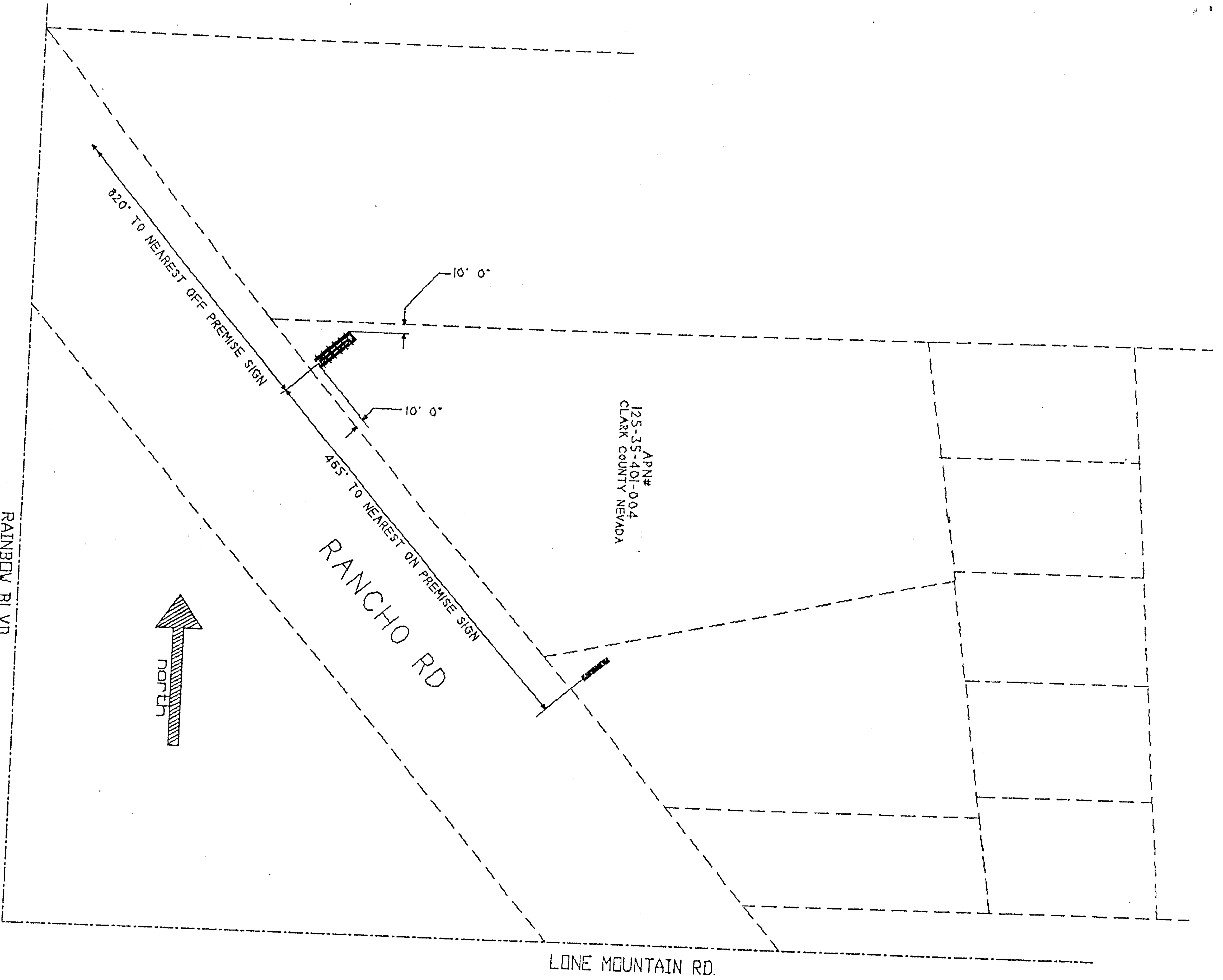
