### Meeting Notes:

1. A Variance is needed to allow an 8" side yard setback, where 3 feet is required for a 320 square-foot Accessory Structure (Title 19.08).
2. A Variance is needed to allow a screen wall/fence to exceed 8 feet in height (Title 19.12). This is the east elevation of the fence screening the accessory shipping container.
3. All Plans shall be to scale.
4. Variance (Title 19.08 from #1 above) shall include a 1-foot rear yard setback where 3 feet is required for an existing 48 SF accessory structure, or the shed can be moved to comply with Title 19, or removed completely from premises and plans.
5. Building and Safety: existing container may already be acceptably fireproofed; however, an official determination will be made at a later date.
6. C.1979 - The mobile home was placed at 4208 Carnation Lane.
7. 06/02/97 - A building permit (97011264) was issued to convert the mobile home to real property. The permit was finalized on 06/05/97.
8. In the R-MH (Mobile/Manufactured Home) zoning district, the maximum lot coverage is 50 percent.
9. No building permits were located for the two existing storage sheds.
10. As an Accessory Structure, the shipping container must be placed on a foundation and aesthetically compatible with the main dwelling unit. The trailer uses a T1 siding, while the container is metallic. Container is situated on concrete pad--satisfies Building and Safety requirement.
11. 10/18/10 - A code enforcement case was opened for vehicles parked in the front yard, commercial trailers and construction equipment stored on side yard and rear yard and a shipping container is located in the side yard, which does not meet setback requirements. The case is currently open.

## **JUSTIFICATION LETTER**

Project: STORAGE SHED VARIANCE

Location: 4208 Carnation Lane  
Las Vegas, Nv.

Applicant: Mr. Eric Flo

### **Description:**

This application is submitted to allow 2 existing storage units to remain on the existing property located at 4208 Carnation Lane, in a R-MH zone. This application specifically addresses one of the said storage units that being the Conex Unit. The existing Storage unit A meets the 3 ft. setback requirements and should not require any variance. I would like to point out that the small Storage Shed currently located in the northwest corner of the property (and is only 5'-9" high) will be removed by the owner.

Due to the increased crime in the immediate neighborhood (next door) the applicant (who was a victim of said crime) was forced to protect his property by installing the Conex storage unit. Verification of said crimes is available from Metropolitan Police records.

In accordance with City of Las Vegas Municipal Code Section 1908.040 (B) (1), accessory structures are permissible under the following conditions:

- The accessory structure must be accessory to the main use (residence).

The storage units are used to secure the work tools of the occupants of the residence and therefore are accessory to the main use.

- The accessory structure must be less than 35 ft. in height.

The storage units do not exceed 9 ft. in height and therefore meet the requirement.

- The sum of the floor areas of the accessory structures may not exceed 50% of the floor area of the principle structure.

The total area of all 3 storage units equal 628 s.f. which is less than 50% of the floor area of the principle structure which is 720 s.f.

- Accessory structures may only be constructed in the side and rear yards, not in front yards.

All three of the existing storage units are located in either the side or rear yards and not in the front yard area.

This property owner has attempted to both protect his property and maintain the aesthetics of the neighborhood by screening the storage unit from view from the street and adjacent property with a solid wood fence. The existing wood fence is currently 9 ft. high which screens the Conex unit from the street. The applicant would be willing to reduce the height of said fence to 8 ft. This would leave the upper 8" of the Conex unit exposed to view from the street. The applicant would also be willing to paint the Conex unit to match the color of the existing residence even though it can only be seen from his own property. In addition to this, if required, the applicant would also be willing to move the existing Conex unit an additional 2 ft. away from the north property line.

The practice of having accessory structures directly adjacent to property lines is more the rule rather than the exception to the rule in this particular neighborhood. At this parcel alone there exists a habitable structure located directly adjacent to his south property line and a storage structure located directly adjacent to his west property line. This owner also gave permission to the parcel to his immediate north to encroach into the rear setback with the main residence.

~~We hereby respectfully request a variance to allow the existing Conex storage unit to remain in its present location (or move 2 ft. to the south). We would also ask that a variance be granted for the existing 9 ft. high screen fence. Again, if this is not possible, the applicant would be willing to reduce the screen fence to 8 ft. high.~~

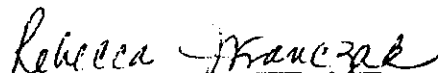

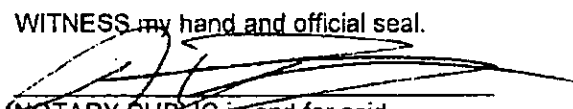

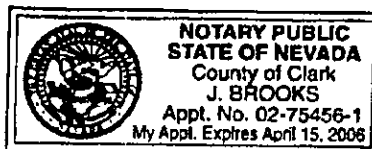
