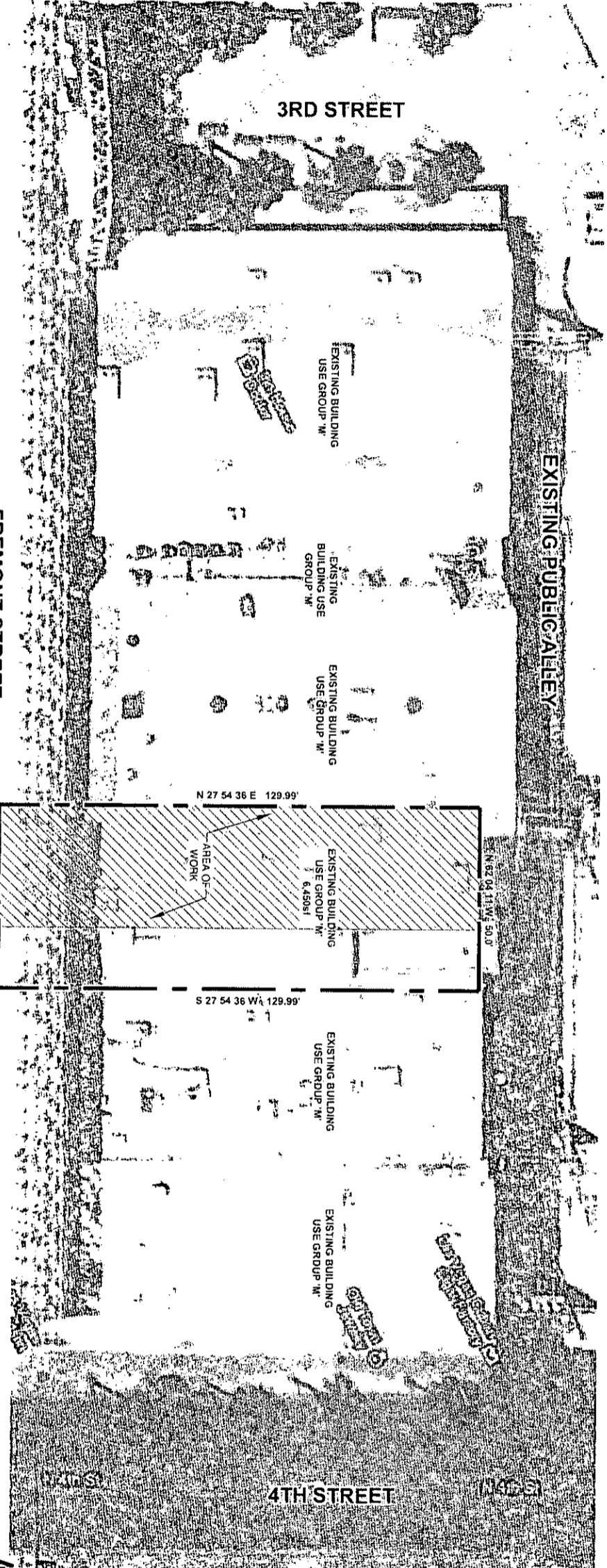


1 VICINITY MAP

Meeting Notes:

1. SUP-36558: The City Council approved a Special Use Permit for a BEER/WINE/COOLER OFF-SALE use within an existing 5,166 square-foot Retail establishment at 316 Fremont Street on 01/20/2010. PC and staff recommended approval.
2. Business license C15-00379 issued for C-Store 8/29/89; L10-92378 pending.
3. SUP-36558 not fully exercised; Planning approved business license review on 01/21/10.
4. SUP not exercised as the license was not issued, (Extension of Time not requested) hence the entitlement for OFF-SALE was lost due to issue regarding Business Licensing's definition of Convenience Store. Inventory d/n reflect Convenience Store, but more of a Gift Shop.
5. There are no outstanding land use issues regarding this request. All use separation and distance requirements, or minimum SUP requirements appear to be in compliance.
6. A "Convenience Store" is limited to no less than 1,200 SF and no greater than 5,000 SF dedicated retail area exclusive of office or stock area. Floor plans show 4,413 SF.
7. Per Title 6.50.020: Convenience Store means a retail establishment other than a drug store, which:

-Offers for sale prepackaged food products, household items and other goods commonly associated with this products and items, provided that not more than thirty percent of its physical retail inventory on the establishment premises is devoted to alcoholic beverages;

-Contains not less than 1,200 square-feet nor more than 5,000 square-feet of floor space devoted to retail sales display, exclusive of warehouse and office areas; and

-Displays alcoholic beverages for sale no closer than 10 feet from any public entrance to the establishment.
