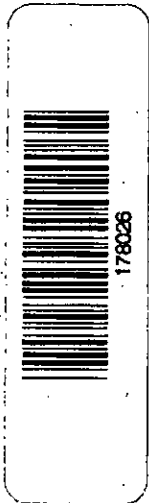

**\*\* STAFF REPORT \*\***

**PROJECT DESCRIPTION**

This is the first Required Review of Special Use Permit (SUP-27870) that allowed a 4,344 square-foot Supper Club with a sixty-foot distance separation from a Child Care Facility where four-hundred feet is required at 8991 West Sahara Avenue. The (SUP-27870) complies with all Title 19 requirements as conditioned by City Council. Therefore, staff recommends approval. If this application is denied, the Supper Club use would cease to exist.

**ISSUES**

- A Waiver to allow a 60-foot distance separation from a Child Care Facility, where 400 feet is required.
- A companion Special Use Permit (SUP-28192) for a proposed Night Club was approved at the 08/06/08 City Council, but was never exercised and expired on 08/06/09.

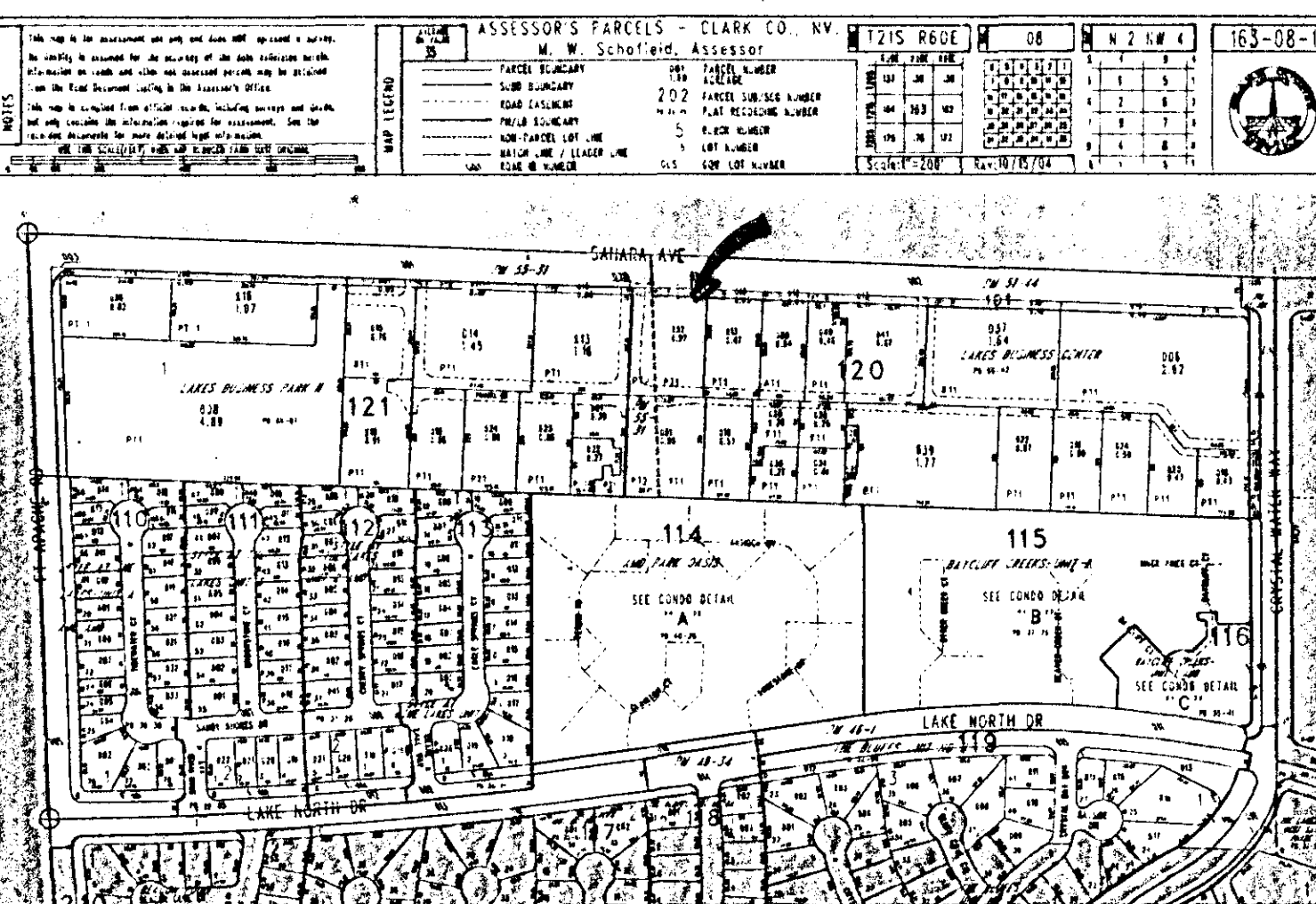

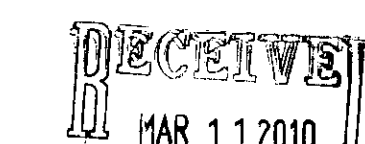
