In connection with the above referenced Special Use Permit application, we are writing to express our objection to the package liquor off-sale use at the applicant's location. While we support business development and all progressive efforts downtown, we feel that the proliferation of package liquor sales is detrimental to this area.

The acceptable function of a package liquor operation near the Fremont Street Experience and the Fremont East Entertainment District would be a retail store where a tourist could purchase beer, wine or liquor for consumption in their hotel room or other location away from Fremont Street. There are numerous options for those tourists wanting alcohol for off-premise consumption that exist today. The problem with package liquor sales in the entertainment corridor is that most of the alcohol is purchased for immediate consumption on the street. There is no control of the alcohol consumption with off-sale that currently exists with on-sale purveyors. We prefer that alcoholic beverage sales for immediate consumption continue to be provided to downtown visitors in the controlled environment provided by casinos.
