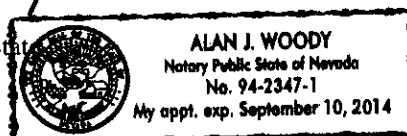

Please consider this my justification letter pertaining to the haunted attraction I desire to produce called **Zombie Precinct:Screamont East**. It is to take place in the fenced in parking lot on the southwest corner of Fremont and 7th Streets within the Fremont East Entertainment District. The lot belongs to the El Cortez which has given written permission to utilize the lot for the event. The official address is 645 Fremont Street, Las Vegas, Nevada 89101.

The days of operation will be from October 14 through November 2, 2011. Setup will commence early October, 2011. Hours of operation will be from 6pm to 2am.

The success of other haunted attractions has prompted the Entertainment District to implement the same there. The board for the District feel that the event will further assist in bringing more business and positive exposure, particularly during the Halloween season, to them and the existing entertainment and dining venues already in operation.

The layout of the haunt was designed to fit within the footprint of the lot. The design of the haunt is keeping in tune with the current thematic devices being mainly 3D combined with strategic lighting, etc. yet still maintaining the scare and entertainment factor. There will be no reference to or implementation of any derogatory music or culture.

The target demographic is 18 to 45. There will be no one admitted in under the age of 18. We will have ample security to maintain complete safety for the cast and patron. Our cast will be sufficiently trained in haunt operations to be able to handle a number of situations as well.

In conclusion, **Zombie Precinct:Screamont East** is a seasonal attraction that will enhance the already developing Fremont East in a positive way, diversifying the scope of events that already take place there.

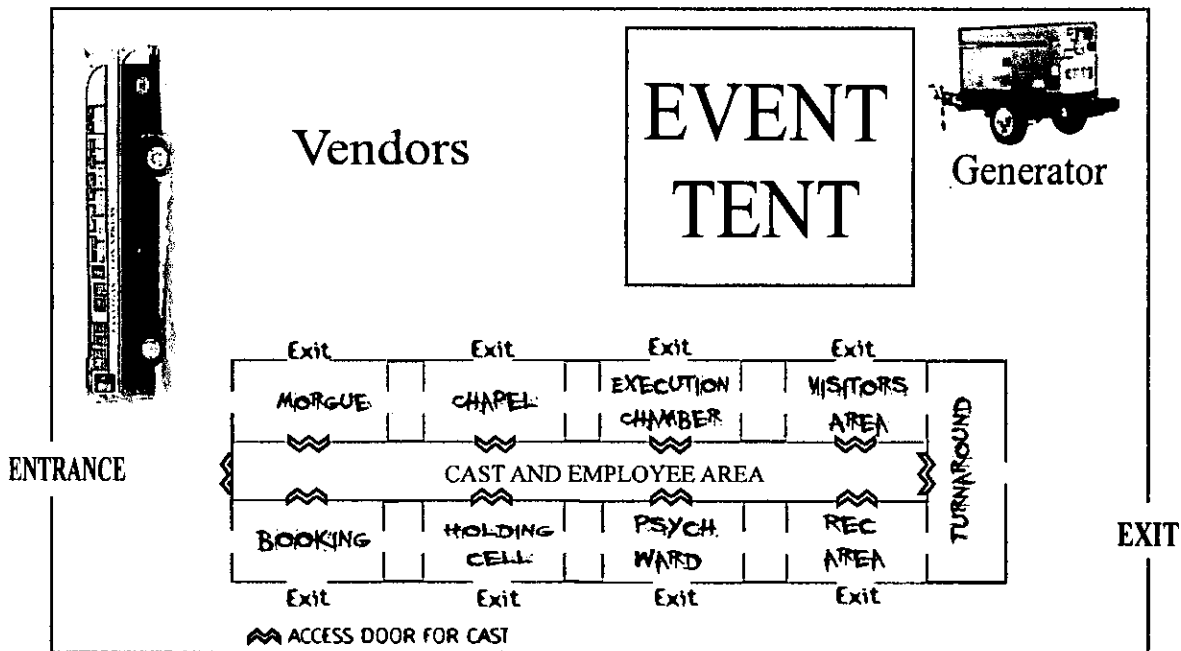
